Questions Relating to Clauses in the Goods Contract;

Clause 7.8 – it is unclear as to why it would take such a level of time to inspect and we would request this be reduced from 30 days to 7 days.

The NMRN is a charitable organisation and does not have dedicated resources available for goods inwards and inspection. Therefore the 30 days is the maximum time we would expect for any inspection to be undertaken in.

Clause 7.9 – We request this clause be amended to remedy for specific performance or contractual damages and an obligation to mitigate losses as well as demonstrate rather than a blanket provision.

This is a general contractual statement and is related to Clause 7.10. The NMRN are using public money on this purchase and therefore must have the ability to ensure that remedies are available to them for non-delivery.



Clause 7.10(a) – We request the remedy - liquidated delay damages be deleted.

The NMRN are using public money on this purchase and therefore must have the ability to ensure that remedies are available to them for non-delivery. This is request is not agreed.

Clause 7.10 – We would request the clause be extended to cover instances where the customer fails to provide an opportunity to deliver (i.e. staff not available etc).

This is covered in clause 7.11 whereby the NMRN will ensure access to the Supplier, to deliver the goods, considering the secure nature of the location concerned.

Clause 8.5 – remove reference to statutory rights.

Request not agreed; The NMRN are using public money on this purchase and therefore must have the ability to ensure that remedies are available to them for non-delivery.

Clause 11.1 – We request that this clause be amended to apply to direct losses only, with indirect or consequential loss excluded

Agreed for this requirement

Clause 11.2 - Can NRMN advise the limit of insurances required?

We will require the Supplier to have Insurance as follows;

Employer's (Compulsory) Liability Insurance = £5,00,000

Public Liability Insurance = £5,000,000

Professional Indemnity Insurance = £0 (Not Applicable)

Product Liability Insurance = £5,000,000

Clause 11.7a.1 – Request this be limited to our insurances

Clause 11.7a.2 – Request this be amended to the value of the Goods paid and received at the time of the breach.

Clause 11.7a.3 – Request this be limited to our insurances

Clause 11.7a.4 – unclear as to how this could apply. If the goods are lost / damaged in transit the customer will not have paid. All other losses to be covered by the customer. Please advise?

Clause11.7b - Request this be limited to 150% of cost and charges received within previous 12 months prior the breach or 150% of the costs and charges received in any 12 months and the limit of our insurances as required.
