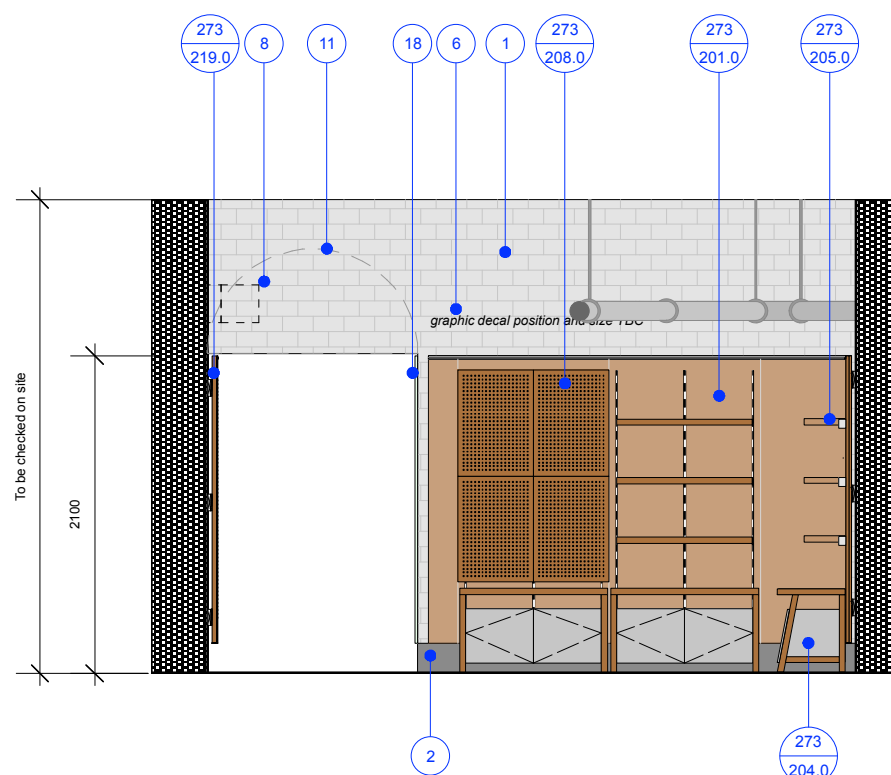
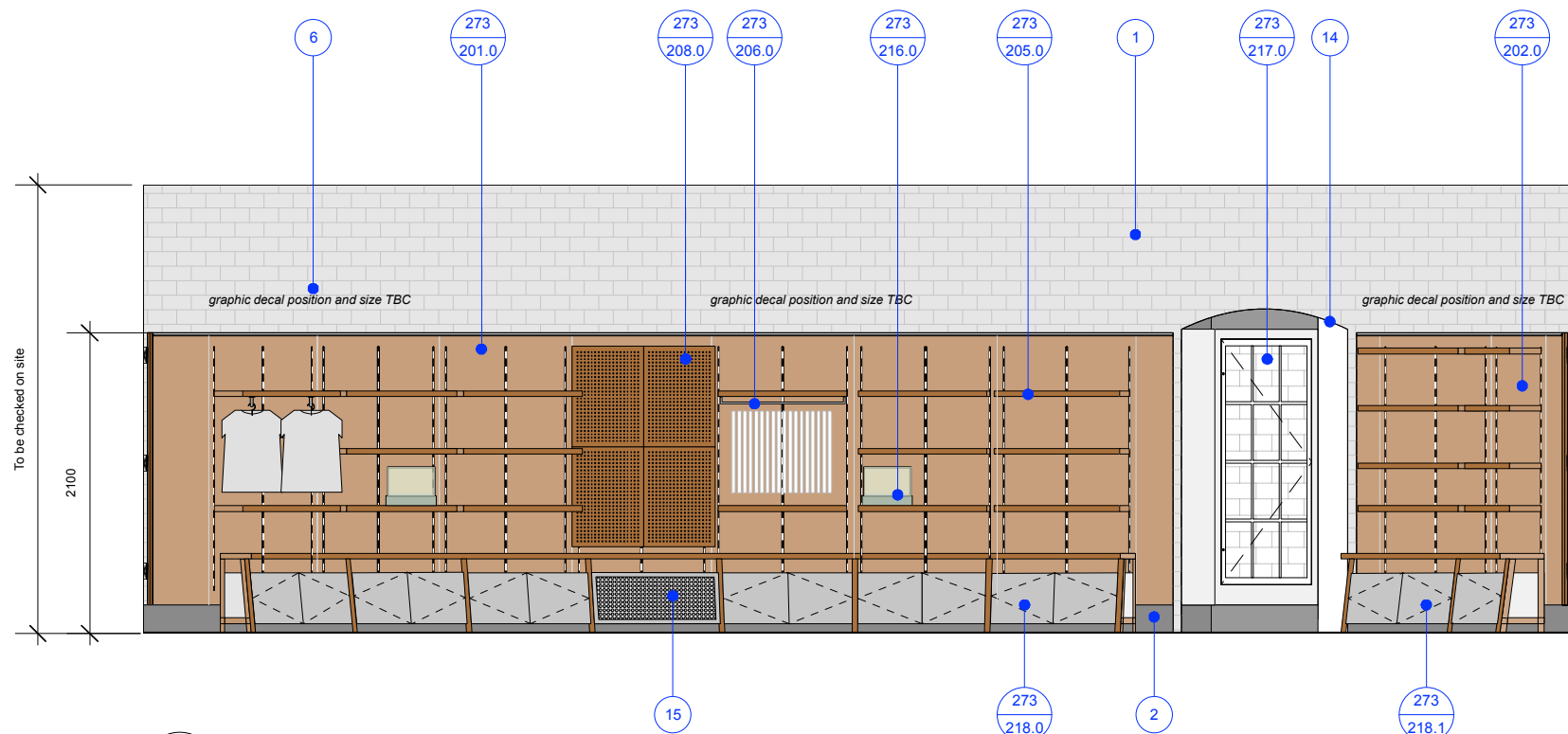


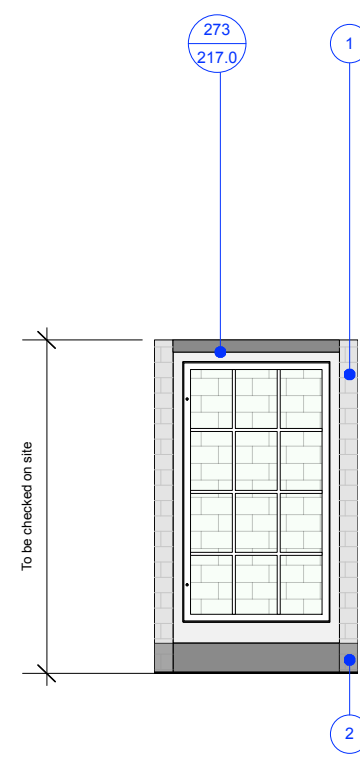
Elevation G

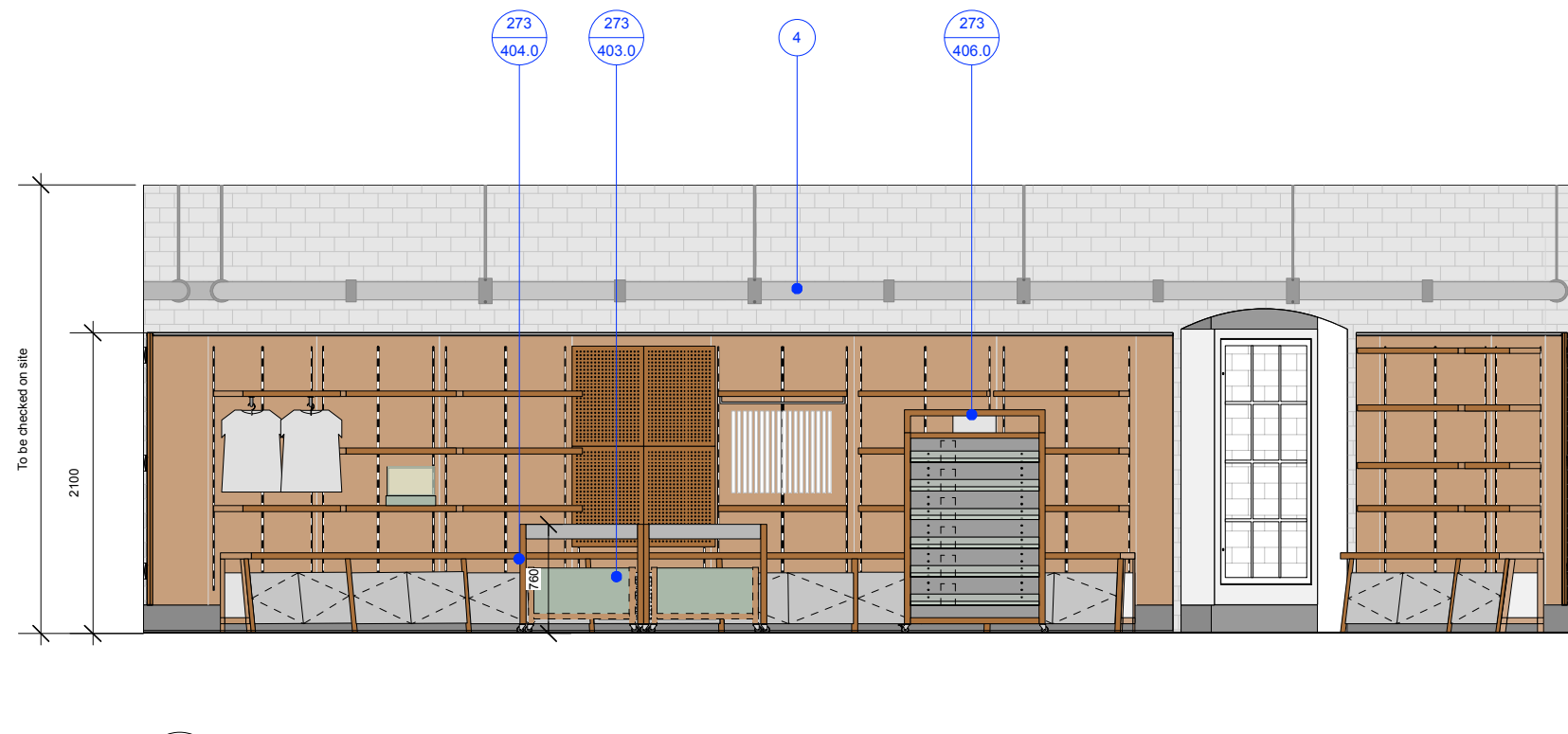
Elevation H

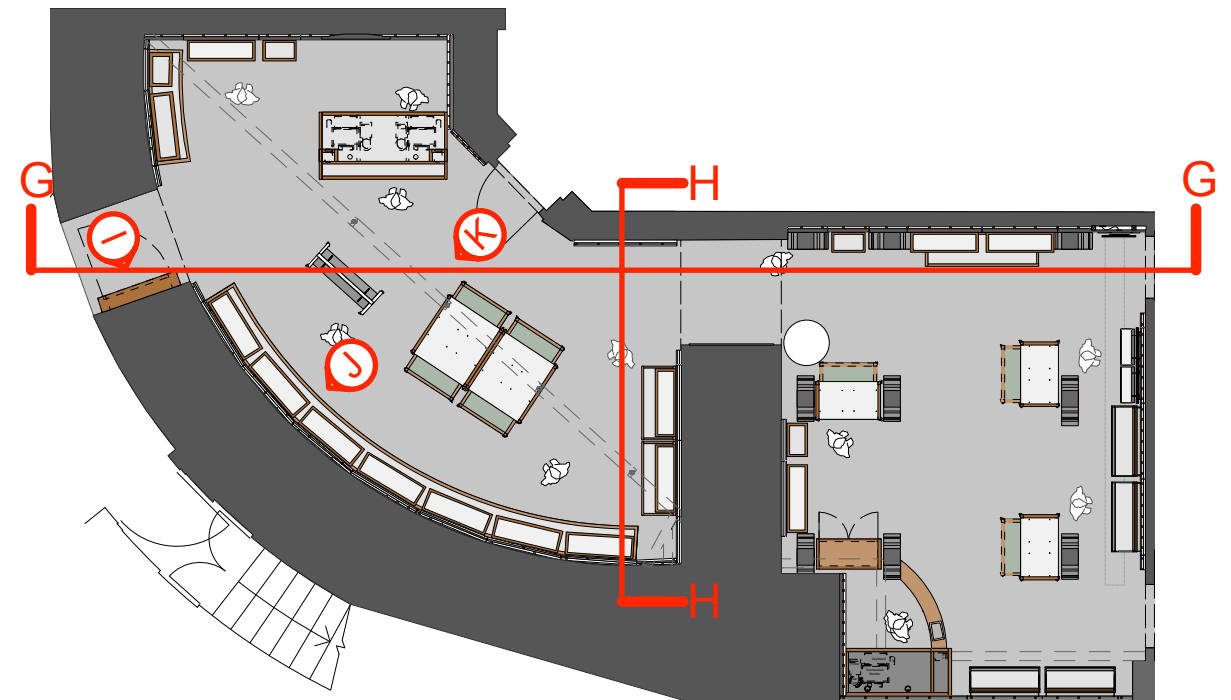
Elevation J

- GENERAL NOTES:**
- Area to be surveyed and all dimensions checked prior to any installation.
- Listed Building.** Great care must be taken while checking existing fixing points and establishing new ones during strip-out.
- Contractor to visit site to establish and mark out fixing positions prior to fit out.
- Once stripped out, contractor to liaise with design consultant, planning consultant and client for a visit with **Listed Buildings**, who will inspect and agree on fixings prior to any installation.
- All fixings in accordance with detail drawings and 273/203.0 Method Statement**
- Area will have new finishes in situ such as floor, decorations, lighting and power. All to be protected during fit out period.
- Make good any decorations marked during fit out.
- Refer to small power and AV drawing to establish extent of works including final positioning of sockets, panic alarms, LCD screens etc.
- Lighting to be specified and focussed after installation by others.
- Make good any decorations marked during fit out.
- Retain light fittings not indicated here.
- Retain existing original overhead pipe work.
- Retain existing original duct work.
- Retain existing beams/columns/doors/frames
- General signage by others and to be advised.
- For loose equipment quantities refer to individual detail drawings. DO NOT take quantities from this drawing.**
- 1/** All existing walls and doors and door frames rubbed down and prepared for decoration to match existing grey paint colour, TBC. Minimum 2 x coats matt emulsion to walls and eggshell finish to walls, doors and door frames. Contractor to visit site and establish paint colour and finish, and to provide samples of all finishes stated for approval prior to manufacture.
- 2/** Existing skirtings rubbed down and prepared for decoration to match existing black paint colour, TBC. Minimum 2 x coats matt emulsion to walls and eggshell finish. Shown indicatively as 200mm high, with unitary siting above. Contractor to survey on site and inform design consultant and client if this is to be amended. Contractor to visit site and establish paint colour and finish, and to provide samples of all finishes stated for approval prior to manufacture.
- 3/** Existing fixtures in room 66 to be retained, to be surveyed on site to make sure proposed fixtures fit around.
- 4/** Existing pipework retained. Contractor to survey on site and liaise with design consultant and lighting supplier to ensure fit out does not interfere with this or any other existing ceiling structure. Where already painted, to be rubbed down and prepared for decoration to match existing grey paint colour, TBC. Minimum 2 x coats matt emulsion to columns and eggshell finish.
- 5/** Feature pendant lights, see **273/004.0 RCP and lighting** for spec and position
- 6/** Graphic text decal by contractor. Artwork by others. Allow a provisional sum for project
- 7/** Radiator position shown indicatively on wall. See **273/003.0 Small power and flooring** for spec and position
- 8/** Existing ceiling beams and AC boxing out shown indicatively. Contractor to survey on site and ensure fit out does not interfere with existing structure. Where already painted, to be rubbed down and prepared for decoration to match existing grey paint colour, TBC. See **point 4 for finish.**
- 9/** Map graphic wall, supplied by client, fixed to wall, see **See 273/302.2** for wall size and position
- 10/** New FE hanging sign, existing signage position shown indicatively. Power in galvanised conduit cables. See **273/004.0 RCP and lighting**
- 11/** Arch and tunnel soffit shown indicatively. Contractor to investigate behind existing FE hanging sign and establish whether or not arch can be fully opened up
- 12/** Existing door retained. Not for public access
- 13/** Wall mounted light to be supplied by Iguzzini, fixed to existing structure. Contracture to ensure minimal fixing detail. See **273/004.0 RCP and lighting**
- 14/** Arch shown indicatively. Survey to be carried out on site
- 15/** Radiator in wall bay low storage unit shown indicatively. See **273/218.1 Room 68 curved Wall base unit - 2** for detail and **273/003.0 Small power and flooring** for position
- 16/** Magnetic panel fixed to wall. Constructed in ply with magnetic laminate wrap
- 17/** Existing columns and bases rubbed down and prepared for decoration to match existing grey and black paint colours, TBC. Minimum 2 x coats matt emulsion to columns and eggshell finish. Contractor to visit site and establish paint colour and finish, and to provide samples of all finishes stated for approval prior to manufacture.
- 18/** Mirror to wall. Glass mirror, polished edges and safety backing. Bonded or mechanically fixed. Contractor to advise. To sit above skirting line. Pre-drilled holes to take wall mounted light fitting. Set in 100mm from edges of wall.
