CONTRACT FOR: Building Capacity to coordinate, implement and measure results of a multi-functional Adolescent Reproductive Health programme in Ghana

With reference to the contractual letter dated 7 January 2014 whereby your firm was engaged to undertake delivery of the services described at Section 3 of the Contractual letter, as most recently amended by the letter of 30 November 2015, I confirm that the UK Government wishes to make the following further amendments to the letter of 7 January 2014:-

Section 1

Paragraph 3, Contract Period

DELETE 31 March 2017 ("the End Date") and REPLACE with 30 September 2017 ("the End Date")

Paragraph 4, Financial Limit

DELETE £11,287,161 ("the Financial Limit") and REPLACE with £12,287,161 ("the Financial Limit"). The revised Financial Limit of £12,287,161 includes £390,376 for the Operational Research component of the Programme.

Section 4 – Key Personnel

Section 5 – Schedule of Prices

REPLACE existing Schedule of Prices for the main Programme and INSERT revised Schedule of Prices submitted to the Contract Officer on 08 July 2016. The Schedule of Prices for the Operational Research component of the Programme remains unchanged.

- 1. This amendment relates to (a) updating of Key Personnel; (b) an increase in the Financial Limit; and (c) a time extension of six months.
- 2. This amendment will facilitate the extension of the Ghana Adolescent Reproductive Health Programme
