**CONTRACT FOR: Violence Against Woman and Girls Research and Innovation Fund: VAWG in Conflict and Humanitarian Emergencies**

With reference to the contract dated 28<sup>th</sup> April 2014, as most recently amended by the letter dated 15<sup>th</sup> August 2018, both Parties have in principle agreed to the following variations to the Contract:

**Section 1, Form of Contract**

Paragraph 3, Commencement and Duration of the Services

DELETE: The Supplier shall start the Services on 1<sup>st</sup> May 2014 (the "Start Date") and shall complete them by 30<sup>th</sup> April 2019 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

INSERT: The Supplier shall start the Services on 1<sup>st</sup> May 2014 (the "Start Date") and shall complete them by 9<sup>th</sup> December 2019 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

Paragraph 4, Financial Limit

DELETE: Payments under this Contract shall not, in any circumstances, exceed **£5,109,824.00** inclusive of any government tax, if applicable (the "Financial Limit").

INSERT: Payments under this Contract shall not, in any circumstances, exceed **£5,171,897.00** inclusive of any government tax, if applicable (the "Financial Limit").
