Section 1 - FORM OF CONTRACT

CONTRACT FOR : East Africa Strategic Research and Evidence Fund

Manager Contract

THIS CONTRACT is made

BETWEEN: The Secretary of State for International Development at the Department for

International Development, Abercrombie House, Eaglesham Road, East

Kilbride, G75 8EA ("DFID");

AND : Pricewaterhousecoopers Limited

("Supplier")

whose principal place of business, or, where the Supplier is a company, whose registered office is situated at PwC Tower, Waiyaki Way/Chiromo

Road, Westlands, Nairobi, Kenya

(together the "Parties").

WHEREAS:

- **A.** DFID requires the Supplier to provide the services as defined in Section 3 (the "Services") to DFID (the "Recipient"); and
- **B.** the Supplier has agreed to provide the Services on the terms and conditions set out in this Contract.

IT IS HEREBY AGREED as follows:

1. Documents

This Contract shall be comprised of the following documents:

This Contract constitutes the entire agreement between the Parties in respect of the Suppliers obligations and supersedes all previous communications between the Parties, other than as expressly provided for in Section 3 and/or Section 4.

2. Contract Signature

If the Original Form of Contract is not returned to the Contract Officer (as identified in Section 4) duly completed (including the applicable Purchase Order Number at the top of Section 1), and signed and dated on behalf of the Supplier within **15 working days** of the date of





signature on behalf of DFID, DFID will be entitled, at its sole discretion, to declare this Contract void.

No payment will be made to the Supplier under this Contract until a copy of the Form of Contract, signed on behalf of the Supplier, is returned to the Contract Officer.

3. Commencement and Duration of the Services

The Supplier shall start the Services on 25th February 2015 (the "Start Date") and shall complete them by 31th March 2020 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

4. Financial Limit

Payments under this Contract shall not, in any circumstances, exceed £9,533,174 exclusive of any government tax if applicable (the "Financial Limit"), of which £883,174 (inclusive of local Kenyan taxes) is in respect of management fees payable under the terms of the contract as detailed in Section 5. The balance, £8,650,000 is funds available for grants and on demand procurement of External Local Peer Review Panel.

5. Time of the Essence

Time shall be of the essence as regards the performance by the Supplier of its obligations under this Contract.
