Secretary of State for Education, Department for Education whose Head Office is located at Sanctuary Buildings, Great Smith Street, London, SW1P 3BT (the "Customer"), and

Allied Publicity Services (Manchester) Limited whose registered office is situated at Chetham House, Bird Hall Lane, Cheadle Heath, SK3 0KP (the "Supplier")

RECITALS:

- A. The Customer and the Supplier entered into a Call-Off Agreement under Order Number STA-0154 (the "Call-Off Contract") for the provision of National Curriculum Assessment (NCA) Test Materials Print Production and Collation services for the 2018 NCA Test Cycle, on 14 August 2017
- B. The Customer and Supplier have agreed to vary the terms of the Call-Off Contract as set out in this Variation agreement
- C. In accordance with clause 22 and of Call-Off Contract Schedule 12, in line with the procedure set out in sub-clause 22.1 (Variation Procedure) of the Call-Off Contract, the parties have agreed the changes described at paragraph 1. (below).

VARIATION

- 1. The Call-Off Contract is varied as follows and shall take effect on the date signed by both parties:

- 1.1 ***The original term of the Call-Off Contract expires on 31 July 2018. Section B, 1.2 of the Call-Off Contract contained provision to extend the term until 31 July 2019. Hereby the Customer confirms that the full term of the extension period is required and therefore the effective end date for the Call-Off Contract be changed to 31 July 2019.***

- 1.2 The Statements of Requirements within the original Call-Off Contract and altered by subsequent change controls are as follows:

3. This Call-Off Contract, including any previous Variations, shall remain effective and unaltered except as amended by this Variation.
