Proposal Overview:

Following client request, Century propose to Supply, Install & Commission a conventional fire alarm as per the design drawing provided from HSSP Architects. 7406-04-012.

Specification:

This specification covers the Supply, Install & Commission of the following:

1x Conventional Fire Panel

2x MCP

6x Sounders

6x Visual Indicators

The electrical installation will be carried out in accordance with the current edition of the IEE Regulations in standard Fire-Resistant cable in accordance with BS6387, surface run or concealed within the building structure where practical / run / enclosed within red / white PVC mini trunking.

Fire resistant cable complying with BS7629 shall be used for the final circuit supplying the Low Voltage mains supply to the Fire Alarm System.



All works will be installed, commissioned and certified to BAFE standards.



Commissioning

Commissioning includes for smoke/heat testing of each detector, full audibility test for all Bells/Sounders, address setting of detectors / manual call points / interface units etc and the general recommendations as set out in Clause 39, Section 5, BS5839 Pt 1 2013.

Acceptance

On acceptance of the Fire Alarm System Century will provide the End User / Client with an Acceptance Certificate in accordance with BS5839, Pt.1, 2013 (42.2c).

The Acceptance Certificate will verify that:

- All installation work appears to be satisfactory
- That the system can give a fire alarm signal
- That any facility for remote transmission of faults and alarms to an alarm receiving centre operates correctly
- That the correct system documentation has been provided
- That sufficient representatives of the End User / Client have been properly instructed in the operation of the system
- That the nominated responsible person has been advised of their responsibilities and how these might be discharged
- That all relevant tests, defined in the purchase specification, have been witnessed

Manuals and Drawings

Operating instructions will be handed over after completion of the commissioning. A drawing detailing equipment location will be prepared subject to receipt from yourselves of a reproducible plan or drawing showing the building outline and all internal full height partitions in electronic format (AutoCAD or PDF).








Relative Notes:

- During the commissioning and warranty periods, work areas should be made safe and classified non – hazardous.
