Rationale of project:	Scaling up the training for dental nurses in Dental Recur-Brief Negotiated Interview for prevention of dental caries in children
Overview, Brief descriptor:	<p>The Dental Recur-Brief Negotiated Interview, DR-BNI is an evidence-based therapeutic conversation between trained dental nurse and parent/caregiver to support adoption of dentally healthy behaviours.</p> <p>The documentation for the nurse training to deliver this intervention has been supported by HEENW to-date and has financed the development of training manuals from research to Train the Trainers model using face-to-face delivery. This next stage is to prepare the material for uploading for national e-learning delivery.</p> <p>This next stage will fund Work-Package 2 (WP2): Develop detailed descriptions and vignettes of sugar-related and toothbrushing behaviours in children who have developed</p>

	childhood dental caries and those at high caries risk using published evidence, national and international guidance. Review and add narration to dentally-related slides – DR-BNI Facilitators and DR-BNI Train the Trainers. Review dental components and amend training manuals for learning platform delivery.
<b>Project outcome / impact:</b>	Development and refinement of the dental components of DR-BNI training to be uploaded to national e-learning platform/When all components have been completed DR-BNI will be available for national e-learning with the aim of reducing dental caries in children.
<b>Evaluation of Project:</b>	This is development of an e-learning project for delivery of DR-BNI and can be evaluated when uploaded and available for training.
<b>Sustainability:</b>	The e-learning programme for DR-BNI will be designed to allow updating of dental and health psychology components to future updated national guidance in the prevention of dental caries to provide a sustainable e-learning programme.
