This FRAMEWORK AGREEMENT (the Agreement) dated 1 March 2023 is made

AND: DAI Global UK Ltd

(the "Supplier")

together the "Parties")

WHEREAS:

- A. FCDO may require the Supplier to supply the services outlined in Section 3 hereof, as more particularly defined in the Terms of Reference of Calldown Contracts which may be placed from time to time (the "Services") pursuant to the Agreement; and
- B. The Supplier has agreed to provide the Services on the terms and conditions set out in this Agreement and the related Calldown Contract.

IT IS HEREBY AGREED as follows:

This Agreement constitutes the entire agreement between the Parties in respect of the Suppliers obligations and supercedes all previous communications between the Parties, other than as expressly provided for in Section 4.





2. Agreement Signature

If the Original Form of Contract is not returned to the Contract Officer duly completed (including the applicable ECM Number at the top of Section 1), and signed and dated on behalf of the Supplier within **15 working days** of the date of signature on behalf of FCDO, FCDO will be entitled, at its sole discretion, to declare this Agreement void.

No payment will be made to the Supplier under any Call Down Contract until this Form of Agreement and the relevant Call Down Contract, are signed on behalf of the Supplier, and returned to the Contract Officer.

3. Commencement and Duration of Agreement

The Agreement shall commence on 1 March 2023 (the "start date") and shall expire on 29 February 2024 (the "end date") unless this Agreement is terminated earlier in accordance with its Terms and Conditions.

4. Time of the Essence

Time shall be of the essence as regards performance by the Supplier of its obligations under this Agreement and each Call Down Contract in existence from time to time.

5. Use of Agreement
