### (cc) How the contract works

(i) If the Buyer decides to buy Deliverables under the Contract it must state its requirements using the Award Form. If allowed by the Regulations, the Buyer can:

make changes to the Award Form;

create new Schedules:

exclude optional template Schedules; and

use Special Terms in the Award Form to add or change terms.

(ii) The Contract:

is between the Supplier and the Buyer; and

includes Core Terms, Schedules and any other changes or items in the completed Award Form.

- (iii) The Supplier acknowledges it has all the information required to perform its obligations under the Contract before entering into it. When information is provided by the Buyer no warranty of its accuracy is given to the Supplier.
- (iv) The Supplier acknowledges that, subject to the Allowable Assumptions set out in Annex 2 of Schedule 3 (Charges) (if any), it has satisfied itself of all details relating to:

the Buyer's requirements for the Deliverables;

the Buyer's operating processes and working methods; and the ownership and fitness for purpose of the Buyer Assets,

and it has it has advised the Buyer in writing of:

each aspect, if any, of the Buyer's requirements for the Deliverables, operating processes and working methods that is not suitable for the provision of the Services;

the actions needed to remedy each such unsuitable aspect; and

a timetable for and, to the extent that such costs are to be payable to the Supplier, the costs of those actions,

and such actions, timetable and costs are fully reflected in this Contract.

- (v) The Supplier won't be excused from any obligation, or be entitled to additional Costs or Charges because it failed to either:
  - verify the accuracy of the Due Diligence Information; and properly perform its own adequate checks.
- (vi) The Buyer will not be liable for errors, omissions or misrepresentation of any information.

(vii) The Supplier warrants and represents that all statements made and documents submitted as part of the procurement of Deliverables are and remain true and accurate.

### (dd) What needs to be delivered

### (i) All deliverables

The Supplier must provide Deliverables:

that comply with the Specification, the Tender Response and the Contract:

using reasonable skill and care;

using Good Industry Practice;

using its own policies, processes and internal quality control measures as long as they don't conflict with the Contract;

on the dates agreed; and

that comply with Law.

The Supplier must provide Deliverables with a warranty of at least 90 days from Delivery against all obvious defects or for such other period as specified in the Award Form.

Where the Award Form states that the Collaborative Working Principles will apply, the Supplier must co-operate and provide reasonable assistance to any Buyer Third Party notified to the Supplier by the Buyer from time to time and act at all times in accordance with the following principles:

proactively leading on, mitigating and contributing to the resolution of problems or issues irrespective of its contractual obligations, acting in accordance with the principle of "fix first, settle later";

being open, transparent and responsive in sharing relevant and accurate information with Buyer Third Parties;

where reasonable, adopting common working practices, terminology, standards and technology and a collaborative approach to service development and resourcing with Buyer Third Parties;

providing reasonable cooperation, support, information and assistance to Buyer Third Parties in a proactive, transparent and open way and in a spirit of trust and mutual confidence; and

identifying, implementing and capitalising on opportunities to improve deliverables and deliver better solutions and performance throughout the relationship lifecycle.

### (ii) Goods clauses

All Goods delivered must be new, or as new if recycled, unused and of recent origin.

All manufacturer warranties covering the Goods must be assignable to the Buyer on request and for free.

The Supplier transfers ownership of the Goods on Delivery or payment for those Goods, whichever is earlier.

Risk in the Goods transfers to the Buyer on Delivery of the Goods, but remains with the Supplier if the Buyer notices damage following Delivery and lets the Supplier know within 3 Working Days of Delivery.

The Supplier warrants that it has full and unrestricted ownership of the Goods at the time of transfer of ownership.

The Supplier must deliver the Goods on the date and to the specified location during the Buyer's working hours.

The Supplier must provide sufficient packaging for the Goods to reach the point of Delivery safely and undamaged.

All deliveries must have a delivery note attached that specifies the order number, type and quantity of Goods.

The Supplier must provide all tools, information and instructions the Buyer needs to make use of the Goods.

The Supplier must indemnify the Buyer against the costs of any Recall of the Goods and give notice of actual or anticipated action about the Recall of the Goods.

The Buyer can cancel any order or part order of Goods which has not been Delivered. If the Buyer gives less than 14 days' notice then it will pay the Supplier's reasonable and proven costs already incurred on the cancelled order as long as the Supplier uses all reasonable endeavours to minimise these costs.

The Supplier must at its own cost repair, replace, refund or substitute (at the Buyer's option and request) any Goods that the Buyer rejects because they don't conform with Clause (dd). If the Supplier doesn't do this it will pay the Buyer's costs including repair or re-supply by a third party.

### (iii) Services clauses

Late Delivery of the Services will be a Default of the Contract.

The Supplier must co-operate with the Buyer and third party suppliers on all aspects connected with the Delivery of the Services and ensure that Supplier Staff comply with any reasonable instructions of the Buyer or third party suppliers.

The Supplier must at its own risk and expense provide all Supplier Equipment required to Deliver the Services.

The Supplier must allocate sufficient resources and appropriate expertise to the Contract.

The Supplier must take all reasonable care to ensure performance does not disrupt the Buyer's operations, employees or other contractors.

The Supplier must ensure all Services, and anything used to Deliver the Services, are of good quality and free from defects.

The Buyer is entitled to withhold payment for partially or undelivered Services, but doing so does not stop it from using its other rights under the Contract.

### (ee) Pricing and payments

- (i) In exchange for the Deliverables, the Supplier must invoice the Buyer for the Charges in the Award Form.
- (ii) All Charges:

exclude VAT, which is payable on provision of a valid VAT invoice; and include all costs connected with the Supply of Deliverables.

- (iii) The Buyer must pay the Supplier the Charges within 30 days of receipt by the Buyer of a valid, undisputed invoice, in cleared funds using the payment method and details stated in the Award Form.
- (iv) A Supplier invoice is only valid if it:
  - includes all appropriate references including the Contract reference number and other details reasonably requested by the Buyer; and
  - includes a detailed breakdown of Delivered Deliverables and Milestone(s) (if any).
- (v) The Buyer may retain or set-off payment of any amount owed to it by the Supplier under this Contract or any other agreement between the Supplier and the Buyer if notice and reasons are provided.
- (vi) The Supplier must ensure that all Subcontractors are paid, in full, within 30 days of receipt of a valid, undisputed invoice. If this does not happen, the Buyer can publish the details of the late payment or non-payment.
- (vii) The Supplier has no right of set-off, counterclaim, discount or abatement unless they're ordered to do so by a court.
- (ff) The buyer's obligations to the supplier
  - (i) If Supplier Non-Performance arises from a Buyer Cause:
    - the Buyer cannot terminate the Contract under Clause (e)(cdxxx);
    - the Supplier is entitled to reasonable and proven additional expenses and to relief from Delay Payments, liability and Deduction under this Contract:
    - the Supplier is entitled to additional time needed to make the Delivery;
    - the Supplier cannot suspend the ongoing supply of Deliverables.
  - (ii) Clause (i) only applies if the Supplier:
    - gives notice to the Buyer of the Buyer Cause within 10 Working Days of becoming aware;
    - demonstrates that the Supplier Non-Performance only happened because of the Buyer Cause; and
    - mitigated the impact of the Buyer Cause.
- (gg) Record keeping and reporting
  - (i) The Supplier must attend Progress Meetings with the Buyer and provide Progress Reports when specified in the Award Form.
  - (ii) The Supplier must keep and maintain full and accurate records and accounts in respect of the Contract during the Contract Period and for 7 years after the End Date and in accordance with the UK GDPR or the EU GDPR as the context requires, including the records and accounts which the Buyer has a right to Audit.
  - (iii) Where the Award Form states that the Financial Transparency Objectives apply, the Supplier must co-operate with the Buyer to achieve the Financial Transparency Objectives and, to this end, will provide a Financial Report to the Buyer:

on or before the Start Date: at the end of each Contract Year; and within 6 Months of the end of the Contract Period,

and the Supplier must meet with the Buyer if requested within 10 Working Days of the Buyer receiving a Financial Report.

(iv) If the Supplier becomes aware of an event that has occurred or is likely to occur in the future which will have a material effect on the:

Supplier's currently incurred or forecast future Costs; and forecast Charges for the remainder of the Contract,

then the Supplier must notify the Buyer in writing as soon as practicable setting out the actual or anticipated effect of the event.

- The Supplier must allow any Auditor access to their premises and the (v) Buyer will use reasonable endeavours to ensure that any Auditor: complies with the Supplier's operating procedures; and
  - does not unreasonably disrupt the Supplier or its provision of the Deliverables.
- (vi) During an Audit, the Supplier must provide information to the Auditor and reasonable co-operation at their request including access to:
  - all information within the permitted scope of the Audit;
  - any Sites, equipment and the Supplier's ICT system used in the performance of the Contract; and
  - the Supplier Staff.
- (vii) The Parties will bear their own costs when an Audit is undertaken unless the Audit identifies a material Default by the Supplier, in which case the Supplier will repay the Buyer's reasonable costs in connection with the Audit.
- (viii) The Supplier must comply with the Buyer's reasonable instructions following an Audit, including:
  - correcting any identified Default;
  - rectifying any error identified in a Financial Report; and
  - repaying any Charges that the Buyer has overpaid.
- (ix) If the Supplier is not providing any of the Deliverables, or is unable to provide them, it must immediately:
  - tell the Buyer and give reasons;
  - propose corrective action; and
  - provide a deadline for completing the corrective action.
- Except where an Audit is imposed on the Buyer by a regulatory body or (x) where the Buyer has reasonable grounds for believing that the Supplier has not complied with its obligations under this Contract, the Buyer may not conduct an Audit of the Supplier or of the same Key Subcontractor more than twice in any Contract Year.

### (hh) Supplier staff

(i) The Supplier Staff involved in the performance of the Contract must: be appropriately trained and qualified;

be vetted using Good Industry Practice and the Security Policy; and comply with all conduct requirements when on the Buyer's Premises.

- (ii) Where the Buyer decides one of the Supplier's Staff is not suitable to work on the Contract, the Supplier must replace them with a suitably qualified alternative.
- (iii) If requested, the Supplier must replace any person whose acts or omissions have caused the Supplier to breach Clauses (fff)(i) to (fff)(iv).
- (iv) The Supplier must provide a list of Supplier Staff needing to access the Buyer's Premises and say why access is required.
- (v) The Supplier indemnifies the Buyer against all claims brought by any person employed by the Supplier caused by an act or omission of the Supplier or any Supplier Staff.

### (ii) Supply chain

(i) Appointing Subcontractors

The Supplier must exercise due skill and care when it selects and appoints Subcontractors to ensure that the Supplier is able to:

manage Subcontractors in accordance with Good Industry Practice; comply with its obligations under this Contract; and assign, novate or transfer its rights and/or obligations under the Sub-Contract that relate exclusively to this Contract to the Buyer or a Replacement Supplier.

(ii) Mandatory provisions in Sub-Contracts

The Supplier will ensure that all Sub-Contracts in the Supplier's supply chain entered into after the Effective Date wholly or substantially for the purpose of performing or contributing to the performance of the whole or any part of this Contract contain provisions that:

allow the Supplier to terminate the Sub-Contract if the Subcontractor fails to comply with its obligations in respect of environmental, social, equality or employment Law;

require the Supplier to pay all Subcontractors in full, within 30 days of receiving a valid, undisputed invoice; and

allow the Buyer to publish the details of the late payment or non-payment if this 30-day limit is exceeded.

The Supplier will take reasonable endeavours to ensure that all Sub-Contracts in the Supplier's supply chain entered into before the Effective Date but made wholly or substantially for the purpose of performing or contributing to the performance of the whole or any part of this Contract contain provisions that:

allow the Supplier to terminate the Sub-Contract if the Subcontractor fails to comply with its obligations in respect of environmental, social, equality or employment Law;

require the Supplier to pay all Subcontractors in full, within 30 days of receiving a valid, undisputed invoice; and

allow the Buyer to publish the details of the late payment or non-payment if this 30-day limit is exceeded.

### (iii) When Sub-Contracts can be ended

At the Buyer's request, the Supplier must terminate any Sub-Contracts in any of the following events:

there is a Change of Control of a Subcontractor which isn't preapproved by the Buyer in writing; the acts or omissions of the Subcontractor have caused or materially contributed to a right of termination under Clause (oo)(iv); a Subcontractor or its Affiliates embarrasses or brings into disrepute or diminishes the public trust in the Buyer;

the Subcontractor fails to comply with its obligations in respect of environmental, social, equality or employment Law; and/or the Buyer has found grounds to exclude the Subcontractor in accordance with Regulation 57 of the Public Contracts Regulations 2015.

### (iv) Competitive terms

If the Buyer can get more favourable commercial terms for the supply at cost of any materials, goods or services used by the Supplier to provide the Deliverables and that cost is reimbursable by the Buyer, then the Buyer may require the Supplier to replace its existing commercial terms with the more favourable terms offered for the relevant items.

If the Buyer uses Clause (e)(cdxxx) then the Charges must be reduced by an agreed amount by using the Variation Procedure.

### (v) Ongoing responsibility of the Supplier

The Supplier is responsible for all acts and omissions of its Subcontractors and those employed or engaged by them as if they were its own.

### (jj) Rights and protection

(i) The Supplier warrants and represents that:

it has full capacity and authority to enter into and to perform the Contract:

the Contract is executed by its authorised representative;

it is a legally valid and existing organisation incorporated in the place it was formed;

there are no known legal or regulatory actions or investigations before any court, administrative body or arbitration tribunal pending or threatened against it or its Affiliates that might affect its ability to perform the Contract;

all necessary rights, authorisations, licences and consents (including in relation to IPRs) are in place to enable the Supplier to perform its obligations under the Contract and for the Buyer to receive the Deliverables;

it doesn't have any contractual obligations which are likely to have a material adverse effect on its ability to perform the Contract;

- it is not impacted by an Insolvency Event or a Financial Distress Event; and
- neither it nor, to the best of its knowledge the Supplier Staff, have committed a Prohibited Act prior to the Start Date or been subject to an investigation relating to a Prohibited Act.
- The warranties and representations in Clauses (cc)(vii) and (jj)(i) are (ii) repeated each time the Supplier provides Deliverables under the Contract.
- (iii) The Supplier indemnifies the Buyer against each of the following: wilful misconduct of the Supplier, Subcontractor and Supplier Staff that impacts the Contract; and

non-payment by the Supplier of any tax or National Insurance.

- (iv) All claims indemnified under this Contract must use Clause (eee).
- The Buyer can terminate the Contract for breach of any warranty or (v) indemnity where they are entitled to do so.
- (vi) If the Supplier becomes aware of a representation or warranty that becomes untrue or misleading, it must immediately notify the Buyer.
- All third party warranties and indemnities covering the Deliverables (vii) must be assigned for the Buyer's benefit by the Supplier.
- Intellectual Property Rights (IPRs) (kk)
- 1.1 The Parties agree that the terms set out in Schedule 36 (Intellectual Property Rights) shall apply to this Contract.
- 1.2 If there is an IPR Claim, the Supplier indemnifies the Buyer against all losses, damages, costs or expenses (including professional fees and fines) incurred as a result.
- 1.3 If an IPR Claim is made or anticipated the Supplier must at its own expense and the Buyer's sole option, either:
  - obtain for the Buyer the rights to continue using the relevant item without infringing any third party IPR; or
  - replace or modify the relevant item with substitutes that don't infringe IPR without adversely affecting the functionality or performance of the Deliverables.
- 1.4 If the Buyer requires that the Supplier procures a licence in accordance with Schedule 36 or to modify or replace an item pursuant to Schedule 36, but this has not avoided or resolved the IPR Claim, then the Buyer may terminate this Contract by written notice with immediate effect.
- (II) Rectifying issues
  - (i) If there is a Notifiable Default, the Supplier must notify the Buyer within 3 Working Days of the Supplier becoming aware of the Notifiable Default and the Buyer may request that the Supplier provide a Rectification Plan within 10 Working Days of the Buyer's request alongside any additional documentation that the Buyer requires.
  - (ii) When the Buyer receives a requested Rectification Plan it can either: reject the Rectification Plan or revised Rectification Plan giving reasons; or

- accept the Rectification Plan or revised Rectification Plan (without limiting its rights) in which case the Supplier must immediately start work on the actions in the Rectification Plan at its own cost.
- (iii) Where the Rectification Plan or revised Rectification Plan is rejected, the Buyer:

will give reasonable grounds for its decision; and

may request that the Supplier provides a revised Rectification Plan within 5 Working Days.

### (mm) Escalating issues

(i) If the Supplier fails to:

submit a Rectification Plan or a revised Rectification Plan within the timescales set out in Clauses (II)(i) or (II)(iii); and

adhere to the timescales set out in an accepted Rectification Plan to resolve the Notifiable Default.

or if the Buyer otherwise rejects a Rectification Plan, the Buyer can require the Supplier to attend an Escalation Meeting on not less than 5 Working Days' notice. The Buyer will determine the location, time and duration of the Escalation Meeting(s) and the Supplier must ensure that the Supplier Authorised Representative is available to attend.

- (ii) The Escalation Meeting(s) will continue until the Buyer is satisfied that the Notifiable Default has been resolved, however, where an Escalation Meeting(s) has continued for more than 5 Working Days, either Party may treat the matter as a Dispute to be handled through the Dispute Resolution Procedure.
- (iii) If the Supplier is in Default of any of its obligations under this Clause (mm), the Buyer shall be entitled to terminate this Agreement and the consequences of termination set out in Clause 14.5.1 shall apply as if the contract were terminated under Clause (e)(cdxxx).

### (nn) Step-in rights

(i) If a Step-In Trigger Event occurs, the Buyer may give notice to the Supplier that it will be taking action in accordance with this Clause (i) and setting out:

whether it will be taking action itself or with the assistance of a third party;

what Required Action the Buyer will take during the Step-In Process;

when the Required Action will begin and how long it will continue for;

whether the Buyer will require access to the Sites; and

what impact the Buyer anticipates that the Required Action will have on the Supplier's obligations to provide the Deliverables.

(ii) For as long as the Required Action is taking place:

the Supplier will not have to provide the Deliverables that are the subject of the Required Action;

no Deductions will be applicable in respect of Charges relating to the Deliverables that are the subject of the Required Action; and

the Buyer will pay the Charges to the Supplier after subtracting any applicable Deductions and the Buyer's costs of taking the Required Action.

- (iii) The Buyer will give notice to the Supplier before it ceases to exercise its rights under the Step-In Process and within 20 Working Days of this notice the Supplier will develop a draft Step-Out Plan for the Buyer to approve.
- (iv) If the Buyer does not approve the draft Step-Out Plan, the Buyer will give reasons and the Supplier will revise the draft Step-Out Plan and re-submit it for approval.
- (v) The Supplier shall bear its own costs in connection with any step-in by the Buyer under this Clause13, provided that the Buyer shall reimburse the Supplier's reasonable additional expenses incurred directly as a result of any step-in action taken by the Buyer under:

limbs (f) or (g) of the definition of a Step-In Trigger Event; or

limbs (h) and (i) of the definition of a Step-in Trigger Event (insofar as the primary cause of the Buyer serving a notice under Clause 13.1 is identified as not being the result of the Supplier's Default).

### (oo) Ending the contract

- (i) The Contract takes effect on the Start Date and ends on the End Date or earlier if terminated under this Clause (oo) or if required by Law.
- (ii) The Buyer can extend the Contract for the Extension Period by giving the Supplier written notice before the Contract expires as described in the Award Form.
- (iii) Ending the contract without a reason

The Buyer has the right to terminate the Contract at any time without reason or (unless the Award Form states something different) liability by giving the Supplier not less than 90 days' notice (unless a different notice period is set out in the Award Form) and if it's terminated Clauses (e)(cdxxx) to (e)(cdxxx) applies.

(iv) When the Buyer can end the Contract

If any of the following events happen, the Buyer has the right to immediately terminate the Contract by issuing a Termination Notice to the Supplier:

there's a Supplier Insolvency Event;

the Supplier fails to notify the Buyer in writing of any Occasion of Tax Non-Compliance

there's a Notifiable Default that is not corrected in line with an accepted Rectification Plan;

the Buyer rejects a Rectification Plan or the Supplier does not provide it within 10 days of the request;

there's any material Default of the Contract;

a Default that occurs and then continues to occur on one or more occasions within 6 Months following the Buyer serving a warning notice on the Supplier that it may terminate for persistent breach of the Contract:

there's any material Default of any Joint Controller Agreement relating to the Contract;

there's a Default of Clauses (cc)(vii), (kk), (mm), (ss), (tt), (fff), (kkk), Schedule 19 (Cyber Essentials) (where applicable) or Schedule 36 (Intellectual Property Rights) relating to the Contract;

the performance of the Supplier causes a Critical Service Level Failure to occur:

there's a consistent repeated failure to meet the Service Levels in Schedule 10 (Service Levels):

there's a Change of Control of the Supplier which isn't pre-approved by the Buyer in writing;

the Buyer discovers that the Supplier was in one of the situations in 57 (1) or 57(2) of the Regulations at the time the Contract was awarded; the Supplier or its Affiliates embarrass or bring the Buyer into disrepute or diminish the public trust in them; or

the Supplier fails to comply with its legal obligations in the fields of environmental, social, equality or employment Law when providing the Deliverables.

The Buyer also has the right to terminate the Contract in accordance with Clauses (jj)(v) and (yy)(iii), Paragraph 4.1 of Schedule 37 (Corporate Resolution Planning) (where applicable) and Paragraph 7 of Schedule 24 (Financial Difficulties) (where applicable).

If any of the events in 73 (1) (a) or (b) of the Regulations happen, the Buyer has the right to immediately terminate the Contract and Clauses (e)(cdxxx) to (e)(cdxxx) applies.

### (v) What happens if the contract ends

Where the Buyer terminates the Contract under Clauses (e)(cdxxx) and (jj)(v), Paragraph 4.1 of Schedule 37 (Corporate Resolution Planning) (where applicable) or Paragraph 7 of Schedule 24 (Financial Difficulties) (where applicable). all of the following apply:

The Supplier is responsible for the Buyer's reasonable costs of procuring Replacement Deliverables for the rest of the Contract Period. The Buyer's payment obligations under the terminated Contract stop immediately.

Accumulated rights of the Parties are not affected.

The Supplier must promptly delete or return the Government Data except where required to retain copies by Law.

The Supplier must promptly return any of the Buyer's property provided under the terminated Contract.

The Supplier must, at no cost to the Buyer, co-operate fully in the handover and re-procurement (including to a Replacement Supplier). The Supplier must repay to the Buyer all the Charges that it has been paid in advance for Deliverables that it has not provided as at the date of termination or expiry.

The following Clauses survive the termination of the Contract: (e)(cdxxx), (gg), (hh)(ii), (kk), (pp), (ss), (tt), (uu), (vv), (ww), (nnn), (ooo), Schedule 36 (Intellectual Property Rights) and any Clauses and Schedules which are expressly or by implication intended to continue.

If either Party terminates the Contract under Clause (yy)(iii):

each party must cover its own Losses; and Clauses (e)(cdxxx) to (e)(cdxxx) applies.

(vi) When the Supplier can end the contract

The Supplier can issue a Reminder Notice if the Buyer does not pay an undisputed invoice on time. The Supplier can terminate the Contract if the Buyer fails to pay an undisputed invoiced sum due and worth over 10% of the total Contract Value within 30 days of the date of the Reminder Notice.

The Supplier also has the right to terminate the Contract in accordance with Clauses (yy)(iii) and (bbb)(v).

Where the Buyer terminates the Contract under Clause 14.3 or the Supplier terminates the Contract under Clause (e)(cdxxx) or (bbb)(v):

the Buyer must promptly pay all outstanding Charges incurred to the Supplier;

the Buyer must pay the Supplier reasonable committed and unavoidable Losses as long as the Supplier provides a fully itemised and costed schedule with evidence – the maximum value of this payment is limited to the total sum payable to the Supplier if the Contract had not been terminated; and Clauses (e)(cdxxx) to (e)(cdxxx) apply.

(vii) Partially ending and suspending the contract

Where the Buyer has the right to terminate the Contract it can terminate or suspend (for any period), all or part of it. If the Buyer suspends the Contract it can provide the Deliverables itself or buy them from a third party.

The Buyer can only partially terminate or suspend the Contract if the remaining parts of the Contract can still be used to effectively deliver the intended purpose.

The Parties must agree any necessary Variation required by this Clause (oo)(vii) using the Variation Procedure, but the Supplier may not either:

reject the Variation; or

increase the Charges, except where the right to partial termination is under Clause (oo)(iii).

The Buyer can still use other rights available, or subsequently available to it if it acts on its rights under this Clause (vii).

- (pp) How much you can be held responsible for
  - (i) Each Party's total aggregate liability in each Contract Year under the Contract (whether in tort, contract or otherwise) is no more than the greater of £5 million or 150% of the Estimated Yearly Charges unless specified otherwise in the Award Form.
  - (ii) Neither Party is liable to the other for:

any indirect Losses; and

Loss of profits, turnover, savings, business opportunities or damage to goodwill (in each case whether direct or indirect).

(iii) In spite of Clause (pp)(i), neither Party limits or excludes any of the following:

its liability for death or personal injury caused by its negligence, or that of its employees, agents or Subcontractors;

its liability for bribery or fraud or fraudulent misrepresentation by it or its employees; and

any liability that cannot be excluded or limited by Law.

- In spite of Clause (pp)(i), the Supplier does not limit or exclude its (iv) liability for any indemnity given under Clauses (hh)(v), (jj)(iii), (qq)(iii) or Schedule 7 (Staff Transfer) of the Contract.
- (v) In spite of Clause (pp)(i), but subject to Clauses (ii) and (iii), the Supplier's total aggregate liability in each Contract Year under Clause (e)(cdxxx) is no more than the Data Protection Liability Cap.
- (vi) Each Party must use all reasonable endeavours to mitigate any Loss or damage which it suffers under or in connection with the Contract, including any indemnities.
- When calculating the Supplier's liability under Clause (pp)(i) the (vii) following items will not be taken into consideration:

Deductions; and

any items specified in Clause (pp)(iv).

(viii) If more than one Supplier is party to the Contract, each Supplier Party is fully responsible for both their own liabilities and the liabilities of the other Suppliers.

#### (qq) Obeying the law

- The Supplier shall comply with the provisions of Schedule 26 (i) (Sustainability).
- (ii) The Supplier shall comply with the provisions of: the Official Secrets Acts 1911 to 1989; and

section 182 of the Finance Act 1989.

- The Supplier indemnifies the Buyer against any costs resulting from (iii) any Default by the Supplier relating to any applicable Law.
- (iv) The Supplier must appoint a Compliance Officer who must be responsible for ensuring that the Supplier complies with Law, Clause (qq)(i) and Clauses (fff) to (kkk).

#### (rr) Insurance

The Supplier must, at its own cost, obtain and maintain the Required Insurances in Schedule 22 (Insurance Requirements).

#### (ss) Data protection

- The Supplier must process Personal Data and ensure that Supplier (i) Staff process Personal Data only in accordance with Schedule 20 (Processing Data).
- (ii) The Supplier must not remove any ownership or security notices in or relating to the Government Data.
- The Supplier must make accessible back-ups of all Government Data, (iii) stored in an agreed off-site location and send the Buyer copies every 6 Months.

- (iv) The Supplier must ensure that any Supplier system holding any Government Data, including back-up data, is a secure system that complies with the Security Policy and any applicable Security Management Plan.
- (v) If at any time the Supplier suspects or has reason to believe that the Government Data is corrupted, lost or sufficiently degraded, then the Supplier must immediately notify the Buyer and suggest remedial action.
- (vi) If the Government Data is corrupted, lost or sufficiently degraded so as to be unusable the Buyer may either or both:

tell the Supplier to restore or get restored Government Data as soon as practical but no later than 5 Working Days from the date that the Buyer receives notice, or the Supplier finds out about the issue, whichever is earlier; and

restore the Government Data itself or using a third party.

- (vii) The Supplier must pay each Party's reasonable costs of complying with Clause (ss)(vi) unless the Buyer is entirely at fault.
- (viii) The Supplier:

must provide the Buyer with all Government Data in an agreed open format within 10 Working Days of a written request;

must have documented processes to guarantee prompt availability of Government Data if the Supplier stops trading;

must securely destroy all Storage Media that has held Government Data at the end of life of that media using Good Industry Practice;

securely erase all Government Data and any copies it holds when asked to do so by the Buyer unless required by Law to retain it; and

indemnifies the Buyer against any and all Losses incurred if the Supplier breaches Clause (ss) or any Data Protection Legislation.

- (tt) What you must keep confidential
  - (i) Each Party must:

keep all Confidential Information it receives confidential and secure;

not disclose, use or exploit the Disclosing Party's Confidential Information without the Disclosing Party's prior written consent, except for the purposes anticipated under the Contract; and

immediately notify the Disclosing Party if it suspects unauthorised access, copying, use or disclosure of the Confidential Information.

(ii) In spite of Clause (tt)(i), a Party may disclose Confidential Information which it receives from the Disclosing Party in any of the following instances:

where disclosure is required by applicable Law, a regulatory body or a court with the relevant jurisdiction if the Recipient Party notifies the Disclosing Party of the full circumstances, the affected Confidential Information and extent of the disclosure:

if the Recipient Party already had the information without obligation of confidentiality before it was disclosed by the Disclosing Party;

if the information was given to it by a third party without obligation of confidentiality;

if the information was in the public domain at the time of the disclosure;

if the information was independently developed without access to the Disclosing Party's Confidential Information;

on a confidential basis, to its auditors or for the purpose of regulatory requirements;

on a confidential basis, to its professional advisers on a need-to-know basis; and

to the Serious Fraud Office where the Recipient Party has reasonable grounds to believe that the Disclosing Party is involved in activity that may be a criminal offence under the Bribery Act 2010.

- (iii) The Supplier may disclose Confidential Information on a confidential basis to Supplier Staff on a need-to-know basis to allow the Supplier to meet its obligations under the Contract. The Supplier Staff must enter into a direct confidentiality agreement with the Buyer at its request.
- (iv) The Buyer may disclose Confidential Information in any of the following cases:

on a confidential basis to the employees, agents, consultants and contractors of the Buyer;

on a confidential basis to any other Central Government Body, any successor body to a Central Government Body or any company that the Buyer transfers or proposes to transfer all or any part of its business to:

if the Buyer (acting reasonably) considers disclosure necessary or appropriate to carry out its public functions;

where requested by Parliament; and

under Clauses (ee)(vi) and (uu).

- (v) For the purposes of Clauses (tt)(ii) to (tt)(iv) references to disclosure on a confidential basis means disclosure under a confidentiality agreement or arrangement including terms as strict as those required in Clause (tt).
- (vi) Transparency Information and any Information which is exempt from disclosure by Clause (uu) is not Confidential Information.
- (vii) The Supplier must not make any press announcement or publicise the Contracts or any part of them in any way, without the prior written consent of the Buyer and must use all reasonable endeavours to ensure that Supplier Staff do not either.
- (uu) When you can share information
  - (i) The Supplier must tell the Buyer within 48 hours if it receives a Request For Information.
  - (ii) In accordance with a reasonable timetable and in any event within 5 Working Days of a request from the Buyer, the Supplier must give the Buyer full co-operation and information needed so the Buyer can: publish the Transparency Information:

comply with any Freedom of Information Act (FOIA) request; and comply with any Environmental Information Regulations (EIR) request.

(iii) To the extent that it is allowed and practical to do so, the Buyer will use reasonable endeavours to notify the Supplier of a FOIA request and may talk to the Supplier to help it decide whether to publish information under Clause (i). However, the extent, content and format of the disclosure is the Buyer's decision in its absolute discretion.

### (vv) Invalid parts of the contract

- (i) If any part of the Contract is prohibited by Law or judged by a court to be unlawful, void or unenforceable, it must be read as if it was removed from the Contract as much as required and rendered ineffective as far as possible without affecting the rest of the Contract, whether it's valid or enforceable.
- (ii) If any removal under Clause (i) is so fundamental that it prevents the purpose of the Contract from being achieved or it materially changes the balance of risk and rewards between the Parties, either Party may give notice to the other Party requiring the Parties to commence good faith negotiations to rectify these issues and to amend the Contract accordingly so that, as amended, it is valid and enforceable, preserves the balance of risks and rewards in this Contract and, to the extent that it is reasonably possible, achieves the Parties' original commercial intention.
- (iii) If the Parties cannot agree on what amendments are required within 5 Working Days, the matter will be dealt with via commercial negotiation as set out in Clause **Error! Reference source not found.** and, if there is no resolution within 30 Working Days of the matter being referred, the Contract will terminate automatically and immediately with costs lying where they fall.

### (ww) No other terms apply

The provisions incorporated into the Contract are the entire agreement between the Parties. The Contract replaces all previous statements, or agreements whether written or oral. No other provisions apply.

(xx) Other people's rights in the Contract

No third parties may use the Contracts (Rights of Third Parties) Act (CRTPA) to enforce any term of the Contract unless stated (referring to CRTPA) in the Contract. This does not affect third party rights and remedies that exist independently from CRTPA.

- (yy) Circumstances beyond your control
  - (i) Any Party affected by a Force Majeure Event is excused from performing its obligations under the Contract while the inability to perform continues, if it both:
    - provides a Force Majeure Notice to the other Party; and uses all reasonable measures practical to reduce the impact of the Force Majeure Event.
  - (ii) Any failure or delay by the Supplier to perform its obligations under this Contract that is due to a failure or delay by an agent, Subcontractor or

supplier will only be considered a Force Majeure Event if that third party is itself prevented from complying with an obligation to the Supplier due to a Force Majeure Event.

(iii) Either party can partially or fully terminate the Contract if the provision of the Deliverables is materially affected by a Force Majeure Event which lasts for 90 days continuously.

### (zz) Relationships created by the contract

The Contract does not create a partnership, joint venture or employment relationship. The Supplier must represent themselves accordingly and ensure others do so.

### (aaa) Giving up contract rights

A partial or full waiver or relaxation of the terms of the Contract is only valid if it is stated to be a waiver in writing to the other Party.

### (bbb) Transferring responsibilities

- (i) The Supplier cannot assign, novate or in any other way dispose of the Contract or any part of it without the Buyer's written consent.
- (ii) Subject to Schedule 27 (Key Subcontractors), the Supplier cannot subcontract the Contract or any part of it without the Buyer's prior written consent. The Supplier shall provide the Buyer with information about the Subcontractor as it reasonably requests. The decision of the Buyer to consent or not will not be unreasonably withheld or delayed. If the Buyer does not communicate a decision to the Supplier within 10 Working Days of the request for consent then its consent will be deemed to have been given. The Buyer may reasonably withhold its consent to the appointment of a Subcontractor if it considers that:

the appointment of a proposed Subcontractor may prejudice the provision of the Deliverables or may be contrary to its interests;

the proposed Subcontractor is unreliable and/or has not provided reliable goods and or reasonable services to its other customers; and/or

the proposed Subcontractor employs unfit persons

- (iii) The Buyer can assign, novate or transfer its Contract or any part of it to any Crown Body, public or private sector body which performs the functions of the Buyer.
- (iv) When the Buyer uses its rights under Clause (bbb)(iii) the Supplier must enter into a novation agreement in the form that the Buyer specifies.
- (v) The Supplier can terminate the Contract novated under Clause (bbb)(iii) to a private sector body that is experiencing an Insolvency Event.
- (vi) The Supplier remains responsible for all acts and omissions of the Supplier Staff as if they were its own.
- (vii) If at any time the Buyer asks the Supplier for details about Subcontractors, the Supplier must provide details of Subcontractors at all levels of the supply chain including:

their name;

the scope of their appointment; the duration of their appointment; and a copy of the Sub-Contract.

### (ccc) Changing the contract

- (i) Either Party can request a Variation to the Contract which is only effective if agreed in writing, including where it is set out in the Variation Form, and signed by both Parties.
- (ii) The Supplier must provide an Impact Assessment either: with the Variation Form, where the Supplier requests the Variation; and within the time limits included in a Variation Form requested by the Buyer.
- (iii) If the Variation to the Contract cannot be agreed or resolved by the Parties, the Buyer can either:
   agree that the Contract continues without the Variation; and refer the Dispute to be resolved using Clause (nnn) (Resolving Disputes).
- (iv) The Buyer is not required to accept a Variation request made by the Supplier.
- (v) The Supplier may only reject a Variation requested by the Buyer if the Supplier:
  - reasonably believes that the Variation would materially and adversely affect the risks to the health and safety of any person or that it would result in the Deliverables being provided in a way that infringes any Law; or
  - demonstrates to the Buyer's reasonable satisfaction that the Variation is technically impossible to implement and that neither the Tender nor the Specification state that the Supplier has the required technical capacity or flexibility to implement the Variation.
- (vi) If there is a General Change in Law, the Supplier must bear the risk of the change and is not entitled to ask for an increase to the Charges.
- (vii) If there is a Specific Change in Law or one is likely to happen during the Contract Period the Supplier must give the Buyer notice of the likely effects of the changes as soon as reasonably practical. They must also say if they think any Variation is needed either to the Deliverables, the Charges or the Contract and provide evidence:
  - that the Supplier has kept costs as low as possible, including in Subcontractor costs; and
  - of how it has affected the Supplier's costs.
- (viii) Any change in the Charges or relief from the Supplier's obligations because of a Specific Change in Law must be implemented using Clauses (ccc)(i) to (ccc)(iv).
- (ddd) How to communicate about the contract
  - (i) All notices under the Contract must be in writing and are considered effective on the Working Day of delivery as long as they're delivered

- before 5:00pm on a Working Day. Otherwise the notice is effective on the next Working Day. An email is effective at 9am on the first Working Day after sending unless an error message is received.
- (ii) Notices to the Buyer must be sent to the Buyer Authorised Representative's address or email address in the Award Form.
- (iii) This Clause does not apply to the service of legal proceedings or any documents in any legal action, arbitration or dispute resolution.

### (eee) Dealing with claims

- (i) If a Beneficiary is notified of a Claim then it must notify the Indemnifier as soon as reasonably practical and no later than 10 Working Days.
- (ii) At the Indemnifier's cost the Beneficiary must both:allow the Indemnifier to conduct all negotiations and proceedings to do with a Claim; and
  - give the Indemnifier reasonable assistance with the claim if requested.
- (iii) The Beneficiary must not make admissions about the Claim without the prior written consent of the Indemnifier which cannot be unreasonably withheld or delayed.
- (iv) The Indemnifier must consider and defend the Claim diligently using competent legal advisors and in a way that doesn't damage the Beneficiary's reputation.
- (v) The Indemnifier must not settle or compromise any Claim without the Beneficiary's prior written consent which it must not unreasonably withhold or delay.
- (vi) Each Beneficiary must use all reasonable endeavours to minimise and mitigate any losses that it suffers because of the Claim.
- (vii) If the Indemnifier pays the Beneficiary money under an indemnity and the Beneficiary later recovers money which is directly related to the Claim, the Beneficiary must immediately repay the Indemnifier the lesser of either:
  - the sum recovered minus any legitimate amount spent by the Beneficiary when recovering this money; and

the amount the Indemnifier paid the Beneficiary for the Claim.

- (fff) Preventing fraud, bribery and corruption
  - (i) The Supplier must not during the Contract Period:
     commit a Prohibited Act or any other criminal offence in the Regulations 57(1) and 57(2);
    - do or allow anything which would cause the Buyer, including any of their employees, consultants, contractors, Subcontractors or agents to breach any of the Relevant Requirements or incur any liability under them.
  - (ii) The Supplier must during the Contract Period:
    - create, maintain and enforce adequate policies and procedures to ensure it complies with the Relevant Requirements to prevent a Prohibited Act and require its Subcontractors to do the same;

keep full records to show it has complied with its obligations under this Clause (fff) and give copies to the Buyer on request; and

if required by the Buyer, within 20 Working Days of the Start Date of the Contract, and then annually, certify in writing to the Buyer, that they have complied with this Clause (fff), including compliance of Supplier Staff, and provide reasonable supporting evidence of this on request, including its policies and procedures.

(iii) The Supplier must immediately notify the Buyer if it becomes aware of any breach of Clauses (fff)(i) or has any reason to think that it, or any of the Supplier Staff, have either:

been investigated or prosecuted for an alleged Prohibited Act;

been debarred, suspended, proposed for suspension or debarment, or are otherwise ineligible to take part in procurement programmes or contracts because of a Prohibited Act by any government department or agency;

received a request or demand for any undue financial or other advantage of any kind related to the Contract; and

suspected that any person or Party directly or indirectly related to the Contract has committed or attempted to commit a Prohibited Act.

- (iv) If the Supplier notifies the Buyer as required by Clause (fff)(iii), the Supplier must respond promptly to their further enquiries, co-operate with any investigation and allow the Audit of any books, records and relevant documentation.
- (v) If the Supplier is in Default under Clause (fff)(i) the Buyer may: require the Supplier to remove any Supplier Staff from providing the Deliverables if their acts or omissions have caused the Default; and immediately terminate this agreement.
- (vi) In any notice the Supplier gives under Clause (fff)(iv) it must specify the:

Prohibited Act:

identity of the Party who it thinks has committed the Prohibited Act; and action it has decided to take.

### (ggg) Equality, diversity and human rights

- (i) The Supplier must follow all applicable equality Law when they perform their obligations under the Contract, including:
  - protections against discrimination on the grounds of race, sex, gender reassignment, religion or belief, disability, sexual orientation, pregnancy, maternity, age or otherwise; and
  - any other requirements and instructions which the Buyer reasonably imposes related to equality Law.
- (ii) The Supplier must use all reasonable endeavours, and inform the Buyer of the steps taken, to prevent anything that is considered to be unlawful discrimination by any court or tribunal, or the Equality and Human Rights Commission (or any successor organisation) when working on the Contract.

### (hhh) Health and safety

- (i) The Supplier must perform its obligations meeting the requirements of: all applicable Law regarding health and safety; and the Buyer's current health and safety policy while at the Buyer's Premises, as provided to the Supplier.
- (ii) The Supplier must as soon as possible notify the other of any health and safety incidents or material hazards they're aware of at the Buyer Premises that relate to the performance of the Contract.

### (iii) Environment

- (i) When working on Site the Supplier must perform its obligations under the Buyer's current Environmental Policy, which the Buyer must provide.
- (ii) The Supplier must ensure that Supplier Staff are aware of the Buyer's Environmental Policy.

### (jjj) Tax

- (i) The Supplier must not breach any tax or social security obligations and must enter into a binding agreement to pay any late contributions due, including where applicable, any interest or any fines. The Buyer cannot terminate the Contract where the Supplier has not paid a minor tax or social security contribution.
- (ii) Where the Charges payable under the Contract are or are likely to exceed £5 million at any point during the relevant Contract Period, and an Occasion of Tax Non-Compliance occurs, the Supplier must notify the Buyer of it within 5 Working Days including:
  - the steps that the Supplier is taking to address the Occasion of Tax Non-Compliance and any mitigating factors that it considers relevant; and
  - other information relating to the Occasion of Tax Non-Compliance that the Buyer may reasonably need.
- (iii) Where the Supplier or any Supplier Staff are liable to be taxed or to pay National Insurance contributions in the UK relating to payment received under the Contract, the Supplier must both:
  - comply with the Income Tax (Earnings and Pensions) Act 2003 and all other statutes and regulations relating to income tax, the Social Security Contributions and Benefits Act 1992 (including IR35) and National Insurance contributions; and
  - indemnify the Buyer against any Income Tax, National Insurance and social security contributions and any other liability, deduction, contribution, assessment or claim arising from or made during or after the Contract Period in connection with the provision of the Deliverables by the Supplier or any of the Supplier Staff.
- (iv) If any of the Supplier Staff are Workers who receive payment relating to the Deliverables, then the Supplier must ensure that its contract with the Worker contains the following requirements:
  - the Buyer may, at any time during the Contract Period, request that the Worker provides information which demonstrates they comply with Clause (e)(cdxxx), or why those requirements do not apply, the Buyer

can specify the information the Worker must provide and the deadline for responding;

the Worker's contract may be terminated at the Buyer's request if the Worker fails to provide the information requested by the Buyer within the time specified by the Buyer;

the Worker's contract may be terminated at the Buyer's request if the Worker provides information which the Buyer considers isn't good enough to demonstrate how it complies with Clause (e)(cdxxx) or confirms that the Worker is not complying with those requirements; and

the Buyer may supply any information they receive from the Worker to HMRC for revenue collection and management.

### (kkk) Conflict of interest

- (i) The Supplier must take action to ensure that neither the Supplier nor the Supplier Staff are placed in the position of an actual, potential or perceived Conflict of Interest.
- (ii) The Supplier must promptly notify and provide details to the Buyer if an actual, potential or perceived Conflict of Interest happens or is expected to happen.
- (iii) The Buyer will consider whether there are any appropriate measures that can be put in place to remedy an actual, perceived or potential Conflict of Interest. If, in the reasonable opinion of the Buyer, such measures do not or will not resolve an actual or potential Conflict of Interest, the Buyer may terminate its Contract immediately by giving notice in writing to the Supplier where there is or may be an actual or potential Conflict of Interest.

### (III) Reporting a breach of the contract

(i) As soon as it is aware of it the Supplier and Supplier Staff must report to the Buyer any actual or suspected breach of:

Law;

Clause (qq)(i); and

Clauses (fff) to (kkk).

(ii) The Supplier must not retaliate against any of the Supplier Staff who in good faith reports a breach listed in Clause (III)(i) to the Buyer or a Prescribed Person.

### (mmm) Further Assurances

Each Party will, at the request and cost of the other Party, do all things which may be reasonably necessary to give effect to the meaning of this Contract.

### (nnn) Resolving disputes

- (i) If there is a Dispute, the senior representatives of the Parties who have authority to settle the Dispute will, within 28 days of a written request from the other Party, meet in good faith to resolve the Dispute by commercial negotiation.
- (ii) If the Parties cannot resolve the Dispute via commercial negotiation, they can attempt to settle it by mediation using the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure current at the

time of the Dispute. If the Parties cannot agree on a mediator, the mediator will be nominated by CEDR. If either Party does not wish to use, or continue to use mediation, or mediation does not resolve the Dispute, the Dispute must be resolved using Clauses (nnn)(iii) to (nnn)(v).

(iii) Unless the Buyer refers the Dispute to arbitration using Clause (nnn)(iv), the Parties irrevocably agree that the courts of England and Wales have the exclusive jurisdiction to:

determine the Dispute;

grant interim remedies; and

grant any other provisional or protective relief.

- (iv) The Supplier agrees that the Buyer has the exclusive right to refer any Dispute to be finally resolved by arbitration under the London Court of International Arbitration Rules current at the time of the Dispute. There will be only one arbitrator. The seat or legal place of the arbitration will be London and the proceedings will be in English.
- (v) The Buyer has the right to refer a Dispute to arbitration even if the Supplier has started or has attempted to start court proceedings under Clause (nnn)(iii), unless the Buyer has agreed to the court proceedings or participated in them. Even if court proceedings have started, the Parties must do everything necessary to ensure that the court proceedings are stayed in favour of any arbitration proceedings if they are started under Clause (nnn)(iv).
- (vi) The Supplier cannot suspend the performance of the Contract during any Dispute.

### (ooo) Which law applies

This Contract and any issues or Disputes arising out of, or connected to it, are governed by English law.

- 1. The Supplier recognises that the Buyer is subject to PPN 01/17 (Updates to transparency principles v1.1 (https://www.gov.uk/government/publications/procurement-policynote-0117-update-to-transparency-principles). The Supplier shall comply with the provisions of this Schedule in order to assist the Buyer with its compliance with its obligations under that PPN.
- 2. Without prejudice to the Supplier's reporting requirements set out in the Contract, within three (3) Months of the Start Date the Supplier shall submit to the Buyer for Approval (such Approval not to be unreasonably withheld or delayed) draft Transparency Reports consistent with the content requirements and format set out in the Annex of this Schedule.
- 3. If the Buyer rejects any proposed Transparency Report submitted by the Supplier, the Supplier shall submit a revised version of the relevant report for further Approval within five (5) days of receipt of any notice of rejection, taking account of any recommendations for revision and improvement to the report provided by the Buyer. If the Parties fail to agree on a draft Transparency Report the Buyer shall determine what should be included. Any other disagreement in connection with Transparency Reports shall be treated as a Dispute.
- 4. The Supplier shall provide accurate and up-to-date versions of each Transparency Report to the Buyer at the frequency referred to in the Annex of this Schedule.

# Schedule 20 (Processing Data)

#### 1. **Status of the Controller**

- 1. The Parties acknowledge that for the purposes of the Data Protection Legislation, the nature of the activity carried out by each of them in relation to their respective obligations under a Contract dictates the status of each party under the DPA 2018. A Party may act as:
  - 1. "Controller" in respect of the other Party who is "Processor";
  - 2. "Processor" in respect of the other Party who is "Controller";
  - 3. "Joint Controller" with the other Party;
  - 4. "Independent Controller" of the Personal Data where the other Party is also "Controller",

in respect of certain Personal Data under a Contract and shall specify in Annex 1 (Processing Personal Data) which scenario they think shall apply in each situation.

#### 2. Where one Party is Controller and the other Party its Processor

- 1. Where a Party is a Processor, the only Processing that it is authorised to do is listed in Annex 1 (Processing Personal Data) by the Controller.
- 2. The Processor shall notify the Controller immediately if it considers that any of the Controller's instructions infringe the Data Protection Legislation.
- 3. The Processor shall provide all reasonable assistance to the Controller in the preparation of any Data Protection Impact Assessment prior to commencing any Processing. Such assistance may, at the discretion of the Controller, include:
  - 1. a systematic description of the envisaged Processing and the purpose of the Processing;
  - 2. an assessment of the necessity and proportionality of the Processing in relation to the Services;
  - 3. an assessment of the risks to the rights and freedoms of Data Subjects; and
  - 4. the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
- 4. The Processor shall, in relation to any Personal Data Processed in connection with its obligations under the Contract:
  - 1. Process that Personal Data only in accordance with Annex 1 (*Processing* Personal Data), unless the Processor is required to do otherwise by Law. If it is so required the Processor shall notify the Controller before Processing the Personal Data unless prohibited by Law;
  - 2. ensure that it has in place Protective Measures, including in the case of the Supplier the measures set out in Clause 18.4 of the Core Terms, which the Controller may reasonably reject (but failure to reject shall not amount to approval by the Controller of the adequacy of the Protective Measures) having taken account of the:
    - nature of the data to be protected;

- 2. harm that might result from a Personal Data Breach;
- 3. state of technological development; and
- 4. cost of implementing any measures;

#### 3. ensure that:

- 1. the Processor Personnel do not Process Personal Data except in accordance with the Contract (and in particular Annex 1 (*Processing Personal Data*));
- it uses all reasonable endeavours to ensure the reliability and integrity of any Processor Personnel who have access to the Personal Data and ensure that they:
  - are aware of and comply with the Processor's duties under this Schedule 20, Clauses 18 (Data protection), 19 (What you must keep confidential) and 20 (When you can share information);
  - 2. are subject to appropriate confidentiality undertakings with the Processor or any Subprocessor;
  - 3. are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract; and
  - 4. have undergone adequate training in the use, care, protection and handling of Personal Data;
- 4. not transfer Personal Data outside of the UK unless the prior written consent of the Controller has been obtained and the following conditions are fulfilled:
  - 1. the transfer is in accordance with Article 45 of the UK GDPR (or section 73 of DPA 2018); or
  - 2. the Controller or the Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with UK GDPR Article 46 or section 75 of the DPA 2018) as determined by the Controller which could include relevant parties entering into the International Data Transfer Agreement (the "IDTA"), or International Data Transfer Agreement Addendum to the European Commission's SCCs (the "Addendum"), as published by the Information Commissioner's Office from time to time, as well as any additional measures determined by the Controller;
  - 3. the Data Subject has enforceable rights and effective legal remedies;
  - 4. the Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Controller in meeting its obligations); and

- 5. the Processor complies with any reasonable instructions notified to it in advance by the Controller with respect to the Processing of the Personal Data:
- 5. where the Personal Data is subject to EU GDPR, not transfer Personal Data outside of the EU unless the prior written consent of the Controller has been obtained and the following conditions are fulfilled:

  - 4. not do anything which may damage the reputation of the other Party or that Party's relationship with the relevant Data Subjects, save as required by Law.
- 11. Personal Data provided by one Party to the other Party may be used exclusively to exercise rights and obligations under the Contract as specified in Annex 1 (*Processing Personal Data*).

# Schedule 2 (Specification)

# 1. Introduction and summary of requirements

We would like a report by an individual or company with expert knowledge of quantum investment markets and a wide network in the investment community to examine the question: "What can the quantum sector, investment community, and UK Government do to support increased private investment into UK quantum companies, particularly at later rounds?" The report should examine the barriers to entry for investing in the quantum sector, explore innovative global approaches to stimulate investment into the sector, and set out key recommendations for government intervention.

For the purposes of this report, we are primarily interested in how to increase private equity investment by a wide range of investors, not debt financing (including venture capital (VCs), corporate VCs, growth funds, sovereign wealth funds, institutional investors, private equity, investment banks etc.)

We want the report to consider quantum technologies including: quantum computing, quantum communications, and quantum sensing, imaging, and timing.

This project will require expert knowledge of quantum and wider investment markets, a wide global network in the investment community and experience working closely with or investing in quantum companies.

DSIT would like you to demonstrate that you have the experience and capabilities to undertake the project. Your tender response should include a summary of each proposed team members experience and capabilities.

Contractors should propose named members of the project team and include the tasks and responsibilities of each team member. This should be clearly linked to the work programme, indicating the grade/ seniority of staff and number of days allocated to specific tasks.

Contractors should identify the individual(s) who will be responsible for managing the project.

# 2. Background to the Requirement & Methodology

It is a key goal of the UK's National Quantum Strategy to increase private investment into the UK's quantum companies to help them scale. At present, we know that there are several UK Venture Capitalists (VCs) active in the UK quantum sector and the investment market is functioning well at seed stages with both global and national investment into the sector. However, there is a substantial challenge to address in supporting larger follow-on rounds at later stages (series A onwards) to help UK companies scale up and compete globally. Beyond computing, other quantum companies are also struggling to secure investment at an earlier stage. We have limited understanding of why a broader range of investors aren't investing in quantum companies (although broader trends in deep tech investment probably apply to quantum), and what actions by government and the public and private sectors could build confidence and de-risk investment decisions.

Consequently, we are commissioning an expert with knowledge of emerging technologies investment markets and who has relationships with a wide network of investors and quantum companies to explore the question of how we can encourage more investment into the sector. This will include a focus on emerging business models, and suitable investment instruments or models.

We expect the report to be mainly qualitative drawing from interviews, surveys, discussions, and workshops with the investment community. The provider will therefore need a knowledge of quantum investment markets and a wide network in the investment community. The report should set out its evidence base and the methodology used, including all the data used and summaries of interviews.

### 3. Aims and Objectives

The project will gather evidence to help DSIT understand the challenges to investment in the emerging UK quantum technologies market and how they could be overcome. This will help to create informed policies based on research evidence to support more private investment into the UK quantum technologies sector.

The report should cover the following 3 themes and, at a minimum, explore the questions set out below. The successful individual or company would be expected to work with DSIT to agree and adjust the specific areas that the report will address as appropriate:

#### 1) Market barriers to investing into UK quantum companies

- a. What are the barriers to investing in quantum companies in the UK?
  - Which barriers are specific to quantum compared to wider deep tech?

How do the barriers or challenges vary for different areas of quantum technology; (1. computing, 2. communications, and 3. sensing, imaging, and timing)

## 2) Investment models and business models for quantum technology

- a. What investment models and investment instruments would be attractive for quantum technology investing? Now and in the future?
  - What models and instruments exist globally and have been successful in quantum or comparable sectors? (deep tech / life sciences etc.)
- b. Are there preferred fund structures and terms for investors to invest in funds which are focussed on quantum (either specifically or as part of a wider portfolio)?
- c. What quantum business models are attractive to investors? (Provide successful examples and why they are investable propositions).
- d. What factors are VCs evaluating when making investment decisions on Quantum companies? How do they undertake due diligence?
- e. What lessons can be identified from historical examples of early stage investing in nascent technology which subsequently generated very positive returns for venture investors?

### 3) Government intervention to support investment

- a. What government interventions could help to support investment into quantum companies, and more specifically larger follow-on rounds in the UK?
- b. What government interventions have other countries taken to support investment into quantum sectors (or comparable sectors), and how effective has it been and why? (focus on successful examples only).
  - What fund structures have other government established to incentivise greater institutional investment into quantum, for example by de-risking investor exposure?
  - What financing instruments have other government used to help leverage ii. private investment into quantum? (focus on successful examples only).
- c. What role could government play in helping to draw a wider range of investors into the UK quantum market? (corporate VCs, growth funds, sovereign wealth funds, institutional investors, private equity, investment banks etc.)

Things we already know, and therefore **would not want** the project to cover:

- Who is investing in quantum globally
- How the UK compares on quantum investment globally
- The size of the funding gap at each round between the UK and US or other countries

# 4. Outputs Required

The output should be a detailed written report which addresses the themes and questions set out above (section 3). The report should:

- a. Clearly present recommendations for UK Government on how to support more investment into UK quantum companies, setting out the evidence for such recommendations.
- b. Set out the reasons for low investor participation in the quantum market and any barriers to investing in the sector.
- c. Explore fund structures, investment terms, and quantum business models which could be suited to supporting investment in quantum.
- d. Be informed by engaging a large network of global investors, both within and outside of the quantum technologies sector. This should include VCs, corporate VCs, growth funds, sovereign wealth funds, institutional investors etc. and should explore the reasons why they are or aren't investing in quantum technologies.
- e. Examine investment models and government interventions being used in other countries to support investment into quantum technologies or other similar deep technologies and evaluate whether they are working effectively.
- f. Clear citation of the datasets and evidence used.
- g. The provision of high-level summaries of roundtable exercises, and interviews.
- h. An interim report that we can review and provide comments on halfway through.

#### 4. INTERPRETATION

Where a provision in this Schedule imposes any obligation on the Supplier including to comply with a requirement or provide an indemnity, undertaking or warranty, the Supplier shall procure that each of its Subcontractors shall comply with such obligation and provide such indemnity, undertaking or warranty to the Buyer, Former Supplier, Replacement Supplier or Replacement Subcontractor, as the case may be and where the Subcontractor fails to satisfy any claims under such indemnities the Supplier will be liable for satisfying any such claim as if it had provided the indemnity itself.

# 5. WHICH PARTS OF THIS SCHEDULE APPLY

Only the following parts of this Schedule shall apply to this Contract:

- 5.2 Part E (Staff Transfer on Exit)

# Part C: No Staff Transfer on the Start Date

#### 1. WHAT HAPPENS IF THERE IS A STAFF TRANSFER

- The Buyer and the Supplier agree that the commencement of the provision of the Services or of any part of the Services will not be a Relevant Transfer in relation to any employees of the Buyer and/or any Former Supplier.
- 1.2 Subject to Paragraphs 1.3, 1.4 and 1.7, if any employee of the Buyer and/or a Former Supplier claims, or it is determined in relation to any employee of the Buyer and/or a Former Supplier, that his/her contract of employment has been transferred from the Buyer and/or the Former Supplier to the Supplier and/or any Subcontractor pursuant to the Employment Regulations then:
  - 1.2.1 the Supplier shall, and shall procure that the relevant Subcontractor shall, within 5 Working Days of becoming aware of that fact, notify the Buyer in writing and, where required by the Buyer, give notice to the Former Supplier; and;
  - 1.2.2 the Buyer and/or the Former Supplier may offer (or may procure that a third party may offer) employment to such person, or take such other steps as it considered appropriate to resolve the matter, within 15 Working Days of receipt of notice from the Supplier or the Subcontractor, provided always that such steps are in compliance with applicable Law;
  - 1.2.3 if such offer of employment is accepted, the Supplier shall, or shall procure that the Subcontractor shall, immediately release the person from its employment;
  - 1.2.4 if after the period referred to in Paragraph 1.2.2 no such offer has been made, or such offer has been made but not accepted, the Supplier may within 5 Working Days give notice to terminate the employment of such person;

and subject to the Supplier's compliance with Paragraphs 1.2.1 to 1.2.4 and in accordance with all applicable employment procedures set out in applicable Law and subject also to Paragraph 1.5:

- a) the Buyer will indemnify the Supplier and/or the relevant Subcontractor against all Employee Liabilities arising out of the termination of the employment of any of the Buyer's employees referred to in Paragraph 1.2 provided that the Supplier takes, or shall procure that the Notified Subcontractor takes, all reasonable steps to minimise any such Employee Liabilities; and
- b) the Buyer will procure that the Former Supplier indemnifies the Supplier and/or any Subcontractor against all Employee Liabilities arising out of termination of the employment of the employees of the Former Supplier referred to in Paragraph 1.2 provided that the Supplier takes, or shall procure that the relevant Subcontractor takes, all reasonable steps to minimise any such Employee Liabilities.
- 1.3 If any such person as is described in Paragraph 1.2 is neither re employed by the Buyer and/or the Former Supplier as appropriate nor dismissed by the Supplier and/or any Subcontractor within the 15 Working Day period referred to in Paragraph 1.2 such person shall be treated as having transferred to the Supplier and/or the Subcontractor (as appropriate) and the Supplier

shall, or shall procure that the Subcontractor shall, comply with such obligations as may be imposed upon it under Law.

- 1.4 Where any person remains employed by the Supplier and/or any Subcontractor pursuant to Paragraph 1.3, all Employee Liabilities in relation to such employee shall remain with the Supplier and/or the Subcontractor and the Supplier shall indemnify the Buyer and any Former Supplier, and shall procure that the Subcontractor shall indemnify the Buyer and any Former Supplier, against any Employee Liabilities that either of them may incur in respect of any such employees of the Supplier and/or employees of the Subcontractor.
- 1.5 The indemnities in Paragraph 1.2 shall not apply to any claim:
  - 1.5.1 for discrimination, including on the grounds of sex, race, disability, age, gender reassignment, marriage or civil partnership, pregnancy and maternity or sexual orientation, religion or belief;
  - 1.5.2 or equal pay or compensation for less favourable treatment of part-time workers or fixed-term employees,

in relation to any alleged act or omission of the Supplier and/or Subcontractor; or

- 1.5.3 any claim that the termination of employment was unfair because the Supplier and/or any Subcontractor neglected to follow a fair dismissal procedure; and
- 1.6 The indemnities in Paragraph 1.2 shall not apply to any termination of employment occurring later than 3 Months from the Start Date.
- 1.7 If the Supplier and/or the Subcontractor does not comply with Paragraph 1.2, all Employee Liabilities in relation to such employees shall remain with the Supplier and/or the Subcontractor and the Supplier shall (i) comply with the provisions of Part D: Pensions of this Schedule, and (ii) indemnify the Buyer and any Former Supplier against any Employee Liabilities that either of them may incur in respect of any such employees of the Supplier and/or employees of the Subcontractor.

# 2. LIMITS ON THE FORMER SUPPLIER'S OBLIGATIONS

Where in this Part C the Buyer accepts an obligation to procure that a Former Supplier does or does not do something, such obligation shall be limited so that it extends only to the extent that the Buyer's contract with the Former Supplier contains a contractual right in that regard which the Buyer may enforce, or otherwise so that it requires only that the Buyer must use reasonable endeavours to procure that the Former Supplier does or does not act accordingly.

# Part E: Staff Transfer on Exit

#### 3. OBLIGATIONS BEFORE A STAFF TRANSFER

- The Supplier agrees that within 20 Working Days of the earliest of:
  - receipt of a notification from the Buyer of a Service Transfer or intended Service 3.1.1 Transfer;
  - 3.1.2 receipt of the giving of notice of early termination or any Partial Termination of the relevant Contract;
  - 3.1.3 the date which is 12 Months before the end of the Term; and
  - 3.1.4 receipt of a written request of the Buyer at any time (provided that the Buyer shall only be entitled to make one such request in any 6 Month period),

it shall provide in a suitably anonymised format so as to comply with the Data Protection Legislation, the Supplier's Provisional Supplier Staff List, together with the Staffing Information in relation to the Supplier's Provisional Supplier Staff List and it shall provide an updated Supplier's Provisional Supplier Staff List at such intervals as are reasonably requested by the Buyer.

- 3.2 At least 20 Working Days prior to the Service Transfer Date, the Supplier shall provide to the Buyer or at the direction of the Buyer to any Replacement Supplier and/or any Replacement Subcontractor
  - 3.2.1 the Supplier's Final Supplier Staff List, which shall identify the basis upon which they are Transferring Supplier Employees and
  - 3.2.2 the Staffing Information in relation to the Supplier's Final Supplier Staff List (insofar as such information has not previously been provided).
- 3.3 The Buyer shall be permitted to use and disclose information provided by the Supplier under Paragraphs 3.1 and 3.2 for the purpose of informing any prospective Replacement Supplier and/or Replacement Subcontractor.
- The Supplier warrants, for the benefit of The Buyer, any Replacement Supplier, and any Replacement Subcontractor that all information provided pursuant to Paragraphs 3.1 and 3.2 shall be true and accurate in all material respects at the time of providing the information.
- 3.5 From the date of the earliest event referred to in Paragraphs 3.1.1 3.1.2 and 3.1.3, the Supplier agrees that it shall not assign any person to the provision of the Services who is not listed on the Supplier's Provisional Supplier Staff List and shall, unless otherwise instructed by the Buyer (acting reasonably):
  - 3.5.1 not replace or re-deploy any Supplier Staff listed on the Supplier Provisional Supplier Staff List other than where any replacement is of equivalent grade, skills, experience and expertise and is employed on the same terms and conditions of employment as the person he/she replaces
  - 3.5.2 not make, promise, propose, permit or implement any material changes to the terms and conditions of (i) employment and/or (ii) pensions, retirement and death benefits (including not to make pensionable any category of earnings which were not

- previously pensionable or reduce the pension contributions payable) of the Supplier Staff (including any payments connected with the termination of employment);
- 3.5.3 not increase the proportion of working time spent on the Services (or the relevant part of the Services) by any of the Supplier Staff save for fulfilling assignments and projects previously scheduled and agreed;
- 3.5.4 not introduce any new contractual or customary practice concerning the making of any lump sum payment on the termination of employment of any employees listed on the Supplier's Provisional Supplier Staff List;
- 3.5.5 not increase or reduce the total number of employees so engaged, or deploy any other person to perform the Services (or the relevant part of the Services);
- 3.5.6 not terminate or give notice to terminate the employment or contracts of any persons on the Supplier's Provisional Supplier Staff List save by due disciplinary process;
- 3.5.7 not dissuade or discourage any employees engaged in the provision of the Services from transferring their employment to the Buyer and/or the Replacement Supplier and/or Replacement Subcontractor;
- 3.5.8 give the Buyer and/or the Replacement Supplier and/or Replacement Subcontractor reasonable access to Supplier Staff and/or their consultation representatives to inform them of the intended transfer and consult any measures envisaged by the Buyer, Replacement Supplier and/or Replacement Subcontractor in respect of persons expected to be Transferring Supplier Employees;
- 3.5.9 co-operate with the Buyer and the Replacement Supplier to ensure an effective consultation process and smooth transfer in respect of Transferring Supplier Employees in line with good employee relations and the effective continuity of the Services, and to allow for participation in any pension arrangements to be put in place to comply with New Fair Deal;
- 3.5.10 promptly notify the Buyer or, at the direction of the Buyer, any Replacement Supplier and any Replacement Subcontractor of any notice to terminate employment given by the Supplier or received from any persons listed on the Supplier's Provisional Supplier Staff List regardless of when such notice takes effect;
- 3.5.11 not for a period of 12 Months from the Service Transfer Date re-employ or reengage or entice any employees, suppliers or Subcontractors whose employment or engagement is transferred to the Buyer and/or the Replacement Supplier (unless otherwise instructed by the Buyer (acting reasonably));
- 3.5.12 not to adversely affect pension rights accrued by all and any Fair Deal Employees in the period ending on the Service Transfer Date;
- 3.5.13 fully fund any Broadly Comparable pension schemes set up by the Supplier;
- maintain such documents and information as will be reasonably required to manage the pension aspects of any onward transfer of any person engaged or employed by the Supplier or any Subcontractor in the provision of the Services on the expiry or termination of this Contract (including identification of the Fair Deal Employees);

- 3.5.15 promptly provide to the Buyer such documents and information mentioned in Paragraph Error! Reference source not found. of Part D: Pensions which the Buyer may reasonably request in advance of the expiry or termination of this Contract; and
- 3.5.16 fully co-operate (and procure that the trustees of any Broadly Comparable pension scheme shall fully co-operate) with the reasonable requests of the Supplier relating to any administrative tasks necessary to deal with the pension aspects of any onward transfer of any person engaged or employed by the Supplier or any Subcontractor in the provision of the Services on the expiry or termination of this Contract.
- 3.6 On or around each anniversary of the Start Date and up to four times during the last 12 Months of the Term, the Buyer may make written requests to the Supplier for information relating to the manner in which the Services are organised. Within 20 Working Days of receipt of a written request the Supplier shall provide such information as the Buyer may reasonably require which shall include:
  - 3.6.1 the numbers of employees engaged in providing the Services;
  - 3.6.2 the percentage of time spent by each employee engaged in providing the Services;
  - 3.6.3 the extent to which each employee qualifies for membership of any of the Fair Deal Schemes (as defined in Part D: Pensions); and
  - 3.6.4 a description of the nature of the work undertaken by each employee by location.
- 3.7 The Supplier shall provide all reasonable cooperation and assistance to the Buyer, any Replacement Supplier and/or any Replacement Subcontractor to ensure the smooth transfer of the Transferring Supplier Employees on the Service Transfer Date including providing sufficient information in advance of the Service Transfer Date to ensure that all necessary payroll arrangements can be made to enable the Transferring Supplier Employees to be paid as appropriate. Without prejudice to the generality of the foregoing, within 5 Working Days following the Service Transfer Date, the Supplier shall provide to the Buyer or, at the direction of the Buyer, to any Replacement Supplier and/or any Replacement Subcontractor (as appropriate), in respect of each person on the Supplier's Final Supplier Staff List who is a Transferring Supplier Employee:
  - 3.7.1 the most recent month's copy pay slip data;
  - 3.7.2 details of cumulative pay for tax and pension purposes;
  - 3.7.3 details of cumulative tax paid;
  - 3.7.4 tax code;
  - 3.7.5 details of any voluntary deductions from pay; and
  - 3.7.6 bank/building society account details for payroll purposes.

#### 4. STAFF TRANSFER WHEN THE CONTRACT ENDS

4.1 The Buyer and the Supplier acknowledge that subsequent to the commencement of the provision of the Services, the identity of the provider of the Services (or any part of the Services) may change (whether as a result of termination or Partial Termination of this Contract or otherwise) resulting in the Services being undertaken by a Replacement Supplier and/or a Replacement Subcontractor. Such change in the identity of the supplier of such

services may constitute a Relevant Transfer to which the Employment Regulations will apply. The Buyer and the Supplier further agree that, as a result of the operation of the Employment Regulations, where a Relevant Transfer occurs, the contracts of employment between the Supplier and the Transferring Supplier Employees (except in relation to any contract terms disapplied through operation of regulation 10(2) of the Employment Regulations) will have effect on and from the Service Transfer Date as if originally made between the Replacement Supplier and/or a Replacement Subcontractor (as the case may be) and each such Transferring Supplier Employee

- 4.2 The Supplier shall, and shall procure that each Subcontractor shall, comply with all its obligations in respect of the Transferring Supplier Employees arising under the Employment Regulations in respect of the period up to (and including) the Service Transfer Date and shall perform and discharge, and procure that each Subcontractor shall perform and discharge, all its obligations in respect of all the Transferring Supplier Employees arising in respect of the period up to (and including) the Service Transfer Date (including the payment of all remuneration, benefits, entitlements and outgoings, all wages, accrued but untaken holiday pay, bonuses, commissions, payments of PAYE, national insurance contributions and pension contributions and all such sums due as a result of any Fair Deal Employees' participation in the Schemes which in any case are attributable in whole or in part to the period ending on (and including) the Service Transfer Date) and any necessary apportionments in respect of any periodic payments shall be made between: (i) the Supplier and/or the Subcontractor (as appropriate); and (ii) the Replacement Supplier and/or Replacement Subcontractor.
- Subject to Paragraph 4.4, the Supplier shall indemnify the Buyer and/or the Replacement Supplier and/or any Replacement Subcontractor against any Employee Liabilities arising from or as a result of:
  - 4.3.1 any act or omission of the Supplier or any Subcontractor in respect of any Transferring Supplier Employee or any appropriate employee representative (as defined in the Employment Regulations) of any Transferring Supplier Employee whether occurring before, on or after the Service Transfer Date.
  - 4.3.2 the breach or non-observance by the Supplier or any Subcontractor occurring on or before the Service Transfer Date of:
    - a) any collective agreement applicable to the Transferring Supplier Employees; and/or
    - b) any other custom or practice with a trade union or staff association in respect of any Transferring Supplier Employees which the Supplier or any Subcontractor is contractually bound to honour;
  - 4.3.3 any claim by any trade union or other body or person representing any Transferring Supplier Employees arising from or connected with any failure by the Supplier or a Subcontractor to comply with any legal obligation to such trade union, body or person arising on or before the Service Transfer Date;
  - 4.3.4 any proceeding, claim or demand by HMRC or other statutory authority in respect of any financial obligation including, but not limited to, PAYE and primary and secondary national insurance contributions:
    - a) in relation to any Transferring Supplier Employee, to the extent that the proceeding, claim or demand by HMRC or other statutory authority

relates to financial obligations arising on and before the Service Transfer Date; and

- b) in relation to any employee who is not identified in the Supplier's Final Supplier Staff List, and in respect of whom it is later alleged or determined that the Employment Regulations applied so as to transfer his/her employment from the Supplier to the Buyer and/or Replacement Supplier and/or any Replacement Subcontractor, to the extent that the proceeding, claim or demand by HMRC or other statutory authority relates to financial obligations arising on or before the Service Transfer Date;
- 4.3.5 a failure of the Supplier or any Subcontractor to discharge or procure the discharge of all wages, salaries and all other benefits and all PAYE tax deductions and national insurance contributions relating to the Transferring Supplier Employees in respect of the period up to (and including) the Service Transfer Date);
- 4.3.6 any claim made by or in respect of any person employed or formerly employed by the Supplier or any Subcontractor other than a Transferring Supplier Employee identified in the Supplier's Final Supplier Staff List for whom it is alleged the Buyer and/or the Replacement Supplier and/or any Replacement Subcontractor may be liable by virtue of this Contract and/or the Employment Regulations; and
- 4.3.7 any claim made by or in respect of a Transferring Supplier Employee or any appropriate employee representative (as defined in the Employment Regulations) of any Transferring Supplier Employee relating to any act or omission of the Supplier or any Subcontractor in relation to its obligations under regulation 13 of the Employment Regulations, except to the extent that the liability arises from the failure by the Buyer and/or Replacement Supplier to comply with regulation 13(4) of the Employment Regulations.
- 4.4 The indemnity in Paragraph 4.3 shall not apply to the extent that the Employee Liabilities arise or are attributable to an act or omission of the Replacement Supplier and/or any Replacement Subcontractor whether occurring or having its origin before, on or after the Service Transfer Date, Including any Employee Liabilities
  - 4.4.1 arising out of the resignation of any Transferring Supplier Employee before the Service Transfer Date on account of substantial detrimental changes to his/her working conditions proposed by the Replacement Supplier and/or any Replacement Subcontractor to occur in the period on or after the Service Transfer Date); or
  - 4.4.2 arising from the Replacement Supplier's failure, and/or Replacement Subcontractor's failure, to comply with its obligations under the Employment Regulations.
- 4.5 Subject to Paragraphs 4.6 and 4.7, if any employee of the Supplier who is not identified in the Supplier's Final Transferring Supplier Employee List claims, or it is determined in relation to any employees of the Supplier, that his/her contract of employment has been transferred

from the Supplier to the Replacement Supplier and/or Replacement Subcontractor pursuant to the Employment Regulations then:

- 4.5.2 the Supplier may offer employment to such person, or take such other steps as it considered appropriate to resolve the matter, within 15 Working Days of receipt of notice from the Replacement Supplier and/or Replacement Subcontractor or take such other reasonable steps as it considers appropriate to deal with the matter provided always that such steps are in compliance with Law;
- 4.5.3 if such offer of employment is accepted, or if the situation has otherwise been resolved by the Supplier or a Subcontractor, the Replacement Supplier and/or Replacement Subcontractor shall immediately release the person from its employment or alleged employment;
- 4.5.4 if after the period referred to in Paragraph 4.5.2 no such offer has been made, or such offer has been made but not accepted, or the situation has not otherwise been resolved, the Replacement Supplier and/or Replacement Subcontractor may within 5 Working Days give notice to terminate the employment of such person;

and subject to the Replacement Supplier's and/or Replacement Subcontractor's compliance with Paragraphs 4.5.1 to 4.5.4 the Supplier will indemnify the Replacement Supplier and/or Replacement Subcontractor against all Employee Liabilities arising out of the termination of the employment of any of the Supplier's employees referred to in Paragraph 4.5 provided that the Replacement Supplier takes, or shall procure that the Replacement Subcontractor takes, all reasonable steps to minimise any such Employee Liabilities.

- 4.6 The indemnity in Paragraph 4.5 shall not apply to:
  - 4.6.1 any claim for:
    - discrimination, including on the grounds of sex, race, disability, age, gender reassignment, marriage or civil partnership, pregnancy and maternity or sexual orientation, religion or belief; or
    - equal pay or compensation for less favourable treatment of part-time workers or fixed-term employees,
    - arising as a result of any alleged act or omission of the Replacement Supplier and/or Replacement Subcontractor; or
  - 4.6.2 any claim that the termination of employment was unfair because the Replacement Supplier and/or Replacement Subcontractor neglected to follow a fair dismissal procedure.
- 4.7 The indemnity in Paragraph 4.5 shall not apply to any termination of employment occurring later than 6 Months from the Service Transfer Date.

  - 4.9.1 the Supplier and/or any Subcontractor; and
  - 4.9.2 the Replacement Supplier and/or the Replacement Subcontractor.
- 4.10 The Supplier shall promptly provide the Buyer and any Replacement Supplier and/or Replacement Subcontractor, in writing such information as is necessary to enable the Buyer, the Replacement Supplier and/or Replacement Subcontractor to carry out their respective duties under regulation 13 of the Employment Regulations. The Buyer shall procure that the Replacement Supplier and/or Replacement Subcontractor, shall promptly provide to the Supplier and each Subcontractor in writing such information as is necessary to enable the Supplier and each Subcontractor to carry out their respective duties under regulation 13 of the Employment Regulations.
- 4.11 Subject to Paragraph 4.9, the Buyer shall procure that the Replacement Supplier indemnifies the Supplier on its own behalf and on behalf of any Replacement Subcontractor and its Subcontractors against any Employee Liabilities arising from or as a result of:

  - take or procure the taking of all reasonable risk management and risk control measures in relation to Deliverables as it would be reasonable to expect of a prudent contractor acting in accordance with Good Industry Practice, including the investigation and reports of relevant claims to insurers:
  - promptly notify the insurers in writing of any relevant material fact under 3.1.2 any Insurances of which the Supplier is or becomes aware; and
  - hold all policies in respect of the Insurances and cause any insurance 3.1.3 broker effecting the Insurances to hold any insurance slips and other evidence of placing cover representing any of the Insurances to which it is a party.

# 4. What happens if you aren't insured

4.1 The Supplier shall not take any action or fail to take any action or (insofar as is reasonably within its power) permit anything to occur in relation to it which

4.2 Where the Supplier has failed to purchase or maintain any of the Insurances in full force and effect, the Buyer may elect (but shall not be obliged) following written notice to the Supplier to purchase the relevant Insurances and recover the reasonable premium and other reasonable costs incurred in connection therewith as a debt due from the Supplier.

# 5. Evidence of insurance you must provide

The Supplier shall upon the Start Date and within 15 Working Days after the renewal of each of the Insurances, provide evidence, in a form satisfactory to the Buyer, that the Insurances are in force and effect and meet in full the requirements of this Schedule.

# 6. Making sure you are insured to the required amount

The Supplier shall ensure that any Insurances which are stated to have a minimum limit "in the aggregate" are maintained at all times for the minimum limit of indemnity specified in this Contract and if any claims are made which do not relate to this Contract then the Supplier shall notify the Buyer and provide details of its proposed solution for maintaining the minimum limit of indemnity.

#### 7. Cancelled Insurance

- The Supplier shall notify the Buyer in writing at least five (5) Working Days prior to the cancellation, suspension, termination or non-renewal of any of the Insurances.
- 7.2 The Supplier shall ensure that nothing is done which would entitle the relevant insurer to cancel, rescind or suspend any insurance or cover, or to treat any insurance, cover or claim as voided in whole or part. The Supplier shall use all reasonable endeavours to notify the Buyer (subject to third party confidentiality obligations) as soon as practicable when it becomes aware of any relevant fact, circumstance or matter which has caused, or is reasonably likely to provide grounds to, the relevant insurer to give notice to cancel, rescind, suspend or void any insurance, or any cover or claim under any insurance in whole or in part.

#### 8. Insurance claims

- The Supplier shall promptly notify to insurers any matter arising from, or in relation to, the Deliverables, or the Contract for which it may be entitled to claim under any of the Insurances. In the event that the Buyer receives a claim relating to or arising out of the Contract or the Deliverables, the Supplier shall co-operate with the Buyer and assist it in dealing with such claims including without limitation providing information and documentation in a timely manner.
- 8.2 Except where the Buyer is the claimant party, the Supplier shall give the Buyer notice within twenty (20) Working Days after any insurance claim in excess of £50,000.00 relating to or arising out of the provision of the Deliverables or this Contract on any of the Insurances or which, but for the application of the

  - 3.4.1 requested to do so by the Buyer or the Buyer Approves such removal or replacement (not to be unreasonably withheld or delayed);
  - 3.4.2 the person concerned resigns, retires or dies or is on maternity or long-term sick leave; or
  - 3.4.3 the person's employment or contractual arrangement with the Supplier or Subcontractor is terminated for material breach of contract by the employee.
- 3.5 The Supplier shall:
  - 3.5.1 notify the Buyer promptly of the absence of any Key Staff (other than for short-term sickness or holidays of two (2) weeks or less, in which case the Supplier shall ensure appropriate temporary cover for that Key Role);
  - 3.5.2 ensure that any Key Role is not vacant for any longer than ten (10) Working Days;
  - 3.5.3 give as much notice as is reasonably practicable of its intention to remove or replace any member of Key Staff and, except in the cases of death, unexpected ill health or a material breach of the Key Staff's employment contract, this will mean at least three (3) Months' notice;
  - 3.5.4 ensure that all arrangements for planned changes in Key Staff provide adequate periods during which incoming and outgoing staff work together to transfer responsibilities and ensure that such change does not have an adverse impact on the provision of the Deliverables; and
