

# **Invitation to Tender**

# **Summary**

Concept and design (phase 1) and delivery (phase 2) of a mobile 'democracy' exhibition for WFD, including digital and printed content to promote the exhibition.

## **Overview**

Westminster Foundation for Democracy ("WFD") is the UK public body dedicated to supporting democracy around the world. Operating internationally, WFD works with parliaments, political parties, and civil society groups as well as on elections to help make political systems fairer, more inclusive, and more accountable.

We are a problem-solving, practitioner-led organisation that offers:

- Specialist analysis, research, and advice to inform policy makers on a range of democratic governance issues;
- High quality and impactful programmes that directly support the full spectrum of institutions in political systems to develop inclusive political processes, more accountable political systems, protection of rights and freedoms, and more pluralistic societies; and
- International elections observation on behalf of the UK.

## Aim of this Invitation to Tender

WFD is issuing this Invitation to Tender ("ITT") to a range of potential suppliers of goods and/or services and would welcome a **bid** from your organisation.

We are looking for an organisation/supplier to deliver the outlined project to the highest standard, and utilising the most creative approach, whilst considering time and budget restrictions and ensuring that that the project is delivered on time.

## **Bid submission**

All bids should be submitted by <u>9am UK time on Monday 23 January 2023</u> in writing, must comply with the requirements of this ITT, and must include the information requested in the Bid Requirements below.

## **Detailed Specification**

## **Objective**

It is clearer than ever that human dignity and social progress are closely linked to democratic freedoms. But democracy is not easy or inevitable.

We live in a period of increased risk to democratic freedoms around the world. Westminster Foundation for Democracy (WFD) is the UK public body dedicated to strengthening democracy around the world.

WFD's Communications and External Affairs team aims to showcase the importance, value and impact of our work in an accessible way. We also want to raise awareness of WFD more broadly and position the organisation as a global thought leader, influential voice and a trusted regional partner.

We aim to communicate the relevance of the work that WFD does to strengthen democracy and tackle global issues that impact everyone. These issues include responding to climate change, reducing pollution, improving the inclusion of LGBTQ+ people and people with disabilities and creating more opportunities for women and girls. We position WFD as a problem solver – working in countries and territories throughout the world on long term projects and programmes. We want to show that we are an international organisation with good local knowledge – most of the people who work for WFD are from the places where we are delivering projects and programmes.

WFD launched a <u>3-year strategy</u> in October 2022 and we would like to develop an inspirational travelling / mobile exhibition as a way of engaging with UK parliamentarians, WFD funders and partners, as well as the wider public. The exhibition could launch in the Houses of Parliament but should be suitable for a range of locations / venues around the UK and in the countries where we work.

The exhibition should help make the case for our work. The following themes and topics could be included in the exhibition:

- The state of democracy in the world
- The benefits of democracy
- WFD's work and its impact
- The work and impact of WFD's partners

All content developed as part of this project needs to be accessible, easy to understand and there needs to be the option of translating it into multiple languages. WFD may seek partners for the



exhibition, so the concept should illustrate opportunities for partner or sponsor visibility in the exhibition.

We would like the exhibition to have a unique concept and look and feel that can also be used as part of a social media campaign and works like a thread throughout all communications around the exhibition.

#### Scope of work

#### **CONCEPT AND DESIGN WORK:**

This invitation to tender covers two phases: concept and design (phase 1) and delivery (phase 2). We would like to invite you to put forward an outline proposal to develop the following:

#### Phase 1: Deliverables (concept and design)

- A concept for a WFD 'democracy' exhibition that can easily travel to different places in the UK and overseas. The content needs to be flexible, and it may, at times, be displayed in a corridor or small room. It may be put outside or displayed on a stand in a large open exhibition centre. One of the venues might need the exhibition to be dismantled within 6 hours.
- 2. The concept should include a digital concept/strategy for the exhibition to be used online (on our website, in digital newsletters, on social media).
- 3. A printed element (flyer, postcard, or poster).
- 4. A title for the exhibition that can be used as a hashtag.
- 5. The exhibition concept should contain all copy elements for the exhibition and for all suggested digital applications.
- 6. Specifications for illustrations and/or photography that need to be commissioned as part of phase 2.
- 7. A detailed quote for print and production costs for the suggested exhibition concept, refining the indicative cost estimate given as part of the bid, including a high-level delivery plan and lead times for the production process as part of phase 2. Please note, supply of printing services is not included as part of the contract for phase 1 or phase 2.
- 8. The project needs to be based on WFD's brand guidelines, but it should have its own identity/treatment aligned with these. The design might need to incorporate one or more sponsor logos.

#### Phase 2: Deliverables (delivery of exhibition)

Based on the design and concept delivered in phase 1 and subject to availability of funding, WFD may decide to go ahead with phase 2 of the project. In that case, the selected supplier will be asked to deliver the remainder of the project – including:

- 1. Design of content / delivery of proposal as set out in phase 1
- 2. Project management of the commission and production of illustrations and/or photography and other content, including a detailed work plan and liaising with contributors.
- 3. A communication plan for the exhibition



#### **Timeline**

To support the development of the exhibition design we will provide 10 to 20 key messages that we want the exhibition to communicate, 6 case studies that show the themes we work on and content that communicates why there's an urgent need to strengthen democracy around the world. These will be provided by early February 2023 and the design and concept for the exhibition would then need to be developed between then and 31 March 2023. Subject to availability of funding, we anticipate the exhibition will first take place between April and December 2023.

#### Minimum experience and expertise

We expect the supplier to deliver to the highest professional industry standards and expect the exhibition to meet UK health and safety standards and that all reasonable care is taken to avoid any unnecessary risks to members of the public or WFD staff.

# **Bid process**

#### **Bid requirements**

In general, the bid should include the following:

1. Organisational profile



- 2. Proposed solution and how it meets the specification
- 3. Financial proposal
- 4. References
- 5. Confirmation of compliance with General Terms and Conditions of Tendering

## Organisational profile:

- · Company profile, including brief history and financial overview
- Case studies/credentials demonstrating relevant experience and skills profile
- Names and brief biographies of key staff

WFD is particularly keen to receive bids from organisations which are – or are working towards becoming – living wage employers and that have a broadly representative and balanced Board from gender and ethnicity perspectives.

## Proposed solution:

- Clear explanation as to the proposed approach to meeting the specification set out in this ITT.
- Detailed project plan for phase 1, including timelines, assumptions and dependencies, resourcing, and risks, and your proposed approach to planning for phase 2.

#### Financial proposal:

- Full breakdown costings for phase 1 and an indicative cost estimate for phase 2 of the proposed solution in sterling
- Separate accounting of VAT and/or any other applicable tax, duty, or charge.
- Detailing of any discount applied in view of WFD's not-for-profit status.

#### References:

 The bid should include details of two references relating to similar goods/services provided in the last three years. Please note – referees will only be contacted once Preferred Bidder status is assigned.

#### Confirmation of acceptance of General Terms and Conditions of Tendering:

 All bids should include a signed copy of the Confirmation of Compliance form as annexed to this ITT.

#### All bidders should also note the following:

- all bids should be submitted in English;
- all bids should be submitted in electronic form only;
- this ITT and the response may be incorporated in whole or in part into the final contract;
- only information provided in response to questions set out in this documentation will be taken into consideration for the purposes of evaluating the ITT;



- bids which are poorly organised or poorly written, such that evaluation and comparison with other submissions is notably difficult, may exclude the bidder from further consideration; and
- any bids which do not fully comply with the requirements of this ITT may be disregarded at the absolute discretion of WFD.

#### **Evaluation criteria**

WFD does not provide a mathematical formula by which bids will be weighted evaluated, but the procurement committee will usually consider the following criteria, among others in the evaluation of all responses:

- ✓ Quality of bid document
- ✓ Service offer and solution fit to specification
- ✓ Quality, capacity, and track-record of bidders based on references
- √ Value for money and pricing factors
- ✓ Professional profile, track record, and references
- ✓ Relevant experience, including case studies

WFD will score each criterion using the following table:

0	The proposal submitted omits and fundamentally fails to meet WFD's scope and specifications. Insufficient evidence to support the proposal to allow WFD to evaluate. <b>Not Answered</b>
1	The information submitted has a severe lack of evidence to demonstrate that WFD's scope and specifications can be met. Significant omissions, serious and/or many concerns. <b>Poor</b>
2	The information submitted has some minor omissions in respect of WFD's scope and specifications. The tender satisfies the basic requirements in some respects but is unsatisfactory in other respects and raises some concerns. <b>Satisfactory</b> .
3	The information submitted provides some good evidence to meet the WFD's scope and specifications and is satisfactory in most respects and there are few concerns. <b>Good.</b>
4	The information submitted provides good evidence that all of WFD's scope and specification can be met. Full and robust response, any concerns are addressed so that the proposal gives confidence. <b>Very Good.</b>



The information submitted provides strong evidence that all of WFD's scope and specification can be met and the proposal exceeds expectation i.e., exemplary in the industry. Provides full confidence and no concerns. **Outstanding**

## WFD, General Terms and Conditions for Tendering

#### Part One - tender processes

#### 1. Definitions

In addition to the terms defined in the Invitation to Tender or Call for Experts, the following definitions apply:

- a. Award Criteria the award criteria set out in the Invitation to Tender.
- b. **Bidder** a person or organisation who bids for the tender or submits a proposal in response to the Call for Experts.
- c. Conditions the conditions set out in this 'Conditions of Tendering' document.
- d. Goods and/or Services everything purchased by WFD under the contract.
- e. **WFD** Westminster Foundation for Democracy, a company limited by guarantee incorporated in England and Wales (company number 02693163); whose registered office is at Clive House, 70 Petty France, London, SW1H 9EX.
- f. **Invitation to Tender** the document entitled "Invitation to Tender" or "Call for Experts", WFD's General Terms and Conditions of Purchase (Part Two below), and all relevant policies notified to the supplier.
- g. **Preferred Bidder** the bidder selected as being the organisation to whom WFD intends to offer the contract for the work within this ITT, subject to satisfactory due diligence checks.
- h. **Specification** any specification or terms of reference for the Goods and/or Services, including any related plans and drawings, supplied by WFD to the Supplier, or specifically produced by the Supplier for WFD, in connection with the tender or call.
- i. **Supplier** the party which provides Goods and/or Services to WFD.

#### 2. The Contract

The contract awarded shall be for the supply of goods and/or services, subject to WFD's Terms and Conditions of Purchase (attached to these Conditions). WFD reserves the right to undertake a formal review of the contract after twelve (12) months or at the expiry of a period equivalent to 50% of the term of the contract, whichever is sooner.

#### 3. Late tenders or proposals

Tenders or proposals received after the Closing Date will not be considered, unless there are, in WFD's sole discretion, exceptional circumstances which have caused the delay.



#### 4. Correspondence

All communications from Bidders to WFD relating to the tender must be in writing and addressed to the person identified in the Invitation to Tender or Call for Experts. Any request for information should be received at least 5 days before the Closing Date, as defined in the Invitation to Tender or Call for Experts. Responses to questions submitted by any Bidder will be circulated (or otherwise made available) by WFD to all Bidders to ensure fairness in the process.

#### 5. Acceptance of tenders

WFD may, unless the Bidder expressly stipulates to the contrary in the tender or proposal, accept whatever part of a tender or proposal that WFD so wishes. WFD is under no obligation to accept the lowest or any tender or proposal.

#### 6. Alternative offer

If the Bidder wishes to propose modifications to the tender or proposal (which may provide a better way to achieve WFD's Specification) these may, at WFD 's discretion, be considered as an Alternative Offer. The Bidder must make any Alternative Offer in a separate letter to accompany the Tender or proposal. WFD is under no obligation to accept Alternative Offers.

#### 7. Prices

Tendered or proposed prices must be shown as both inclusive of and exclusive of any Value Added Tax chargeable or any similar tax (if applicable).

## 8. No reimbursement of tender expenses

Expenses incurred in the preparation and dispatch of the tender or proposal will not be reimbursed.

## 9. Non-Disclosure and Confidentiality

Bidders must treat the Invitation to Tender or Call for Experts, contract and all associated documentation (including the Specification) and any other information relating to WFD's employees, servants, officers, partners or its business or affairs (the "Confidential Information") as confidential. All Bidders shall:

- a. recognise the confidential nature of the Confidential Information;
- b. respect the confidence placed in the Bidder by WFD by maintaining the secrecy of the Confidential Information;
- c. not employ any part of the Confidential Information without WFD 's prior written consent, for any purpose except that of tendering for business from WFD;
- d. not disclose the Confidential Information to third parties without WFD's prior written consent:



- e. not employ their knowledge of the Confidential Information in any way that would be detrimental or harmful to WFD;
- f. use all reasonable efforts to prevent the disclosure of the Confidential Information to third parties;
- g. notify WFD immediately of any possible breach of the provisions of this Condition 9 and acknowledge that damages may not be an adequate remedy for such a breach.

#### 10. Award Procedure

WFD's Selection Panel or Procurement Committee will review the Bidders and their tenders to determine, in accordance with the Award Criteria, whether they will award the contract to any one of them.

## 11. Information and Record Keeping

WFD shall consider any reasonable request from any unsuccessful Bidder for feedback on its tender or proposal and, where it is appropriate and proportionate to do so, provide the unsuccessful Bidder with reasons why its tender or proposal was rejected. Where applicable, this information shall be provided within 30 business days from (but not including) the date on which WFD receives the request.

## 12. Anti-Fraud, Bribery and Corruption

All Bidders are required to comply fully with the principles of WFD's Anti-Bribery, Corruption & Fraud Policy (a summary of which is attached to these Conditions).

#### 13. Safeguarding

All Bidders are required to comply fully with the principles of WFD's Safeguarding Policy (a summary of which is attached to these Conditions).

#### 14. Terrorism

All Bidders are required to comply fully with the principles of WFD's Anti-Terrorism Policy (a summary of which is attached to these Conditions).

#### 15. Exclusion Criteria

Any Bidder is required to confirm in writing that:

- Neither it nor any related company to which it regularly subcontracts is insolvent or being wound up, is having its affairs administered by the courts, has entered into an arrangement with creditors, has suspended business activities, is the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
- Neither it nor a company to which it regularly subcontracts has been convicted of fraud, corruption, involvement in a criminal organisation, any money laundering or



terrorism-related offence, any offence concerning professional conduct, breaches of applicable labour law or labour tax legislation or any other illegal activity by a judgment in any court of law whether national or international;

Neither it nor a company to which it regularly subcontracts has failed to comply with
its obligations relating to the payment of social security contributions or the payment
of taxes in accordance with the legal provisions of the relevant country in which it the
Bidder operates.

Any Bidder will automatically be excluded from the tender process if it is found that they are responsible for any misrepresentation in supplying the required information within their tender bid or fail to supply the required information.

#### 16. Conflict of Interest / Non-Collusion

Any Bidder is required to confirm in writing:

- That it is not aware of any connection between it or any of its directors or senior managers and the governors and staff of WFD which may affect the outcome of the selection process. If there are such connections the Bidder is required to disclose them.
- Whether or not there are any existing contacts between WFD and if there are any arrangements which have been put in place over the last twenty-four (24) months.
- That it has not communicated to anyone other than WFD the amount or approximate amount of the tender.
- That it has not and will not offer pay or give any sum of money commission, gift, inducement or other financial benefit directly or indirectly to any person for doing or omitting to do any act in relation to the tender process.
- That none of the key staff proposed for involvement in the services have been employed by the Crown within the past twenty-four (24) months.

## Part Two – terms and conditions of purchases

#### 1. Definitions and Interpretation

These general terms and conditions ("**Conditions**") provide the basis of any contract between the supplier ("**Supplier**") and WFD (the "**Customer**"), in relation to a purchase ("**Order**") (the Order and the Conditions are together referred to as the "**Contract**"). All references in these terms and conditions to defined terms - Goods, Services, Prices and Delivery - refer to the relevant provisions of the Order.

These Conditions may be superseded at any time by a signed agreement in writing between the Parties on the same, similar, or different terms.

#### 2. Quality and Defects



- 1. The Goods and/or the Services shall, as appropriate:
- a. correspond with their description in the Order and any applicable specification;
- b. comply with all applicable statutory and regulatory requirements;
- c. be of the highest quality and fit for any purposes held out by the Supplier or made known to the Supplier by WFD;
- d. be free from defects in design, material, workmanship and installation; and
- e. be performed with the best care, skill and diligence in accordance with best practice in the Supplier's industry, profession or trade.
- 2. WFD (including its representatives or agents) reserves the right at any time to audit the Supplier's records, inspect work being undertaken in relation to the supply of the Goods and Services and, in the case of Goods, to test them.

#### 3. Ethical Standards

- The Supplier shall observe the highest ethical standards during the performance of its obligations under this Contract including international labour standards promoted by the International Labour Organisation specifically in the areas of child labour and forced labour.
- 2. The Supplier, its suppliers and sub-contractors shall comply with all environmental statutory and regulatory requirements and shall not in any way be involved in (a) the manufacture or sale of arms or have any business relations with armed groups or governments for any war related purpose; or (b) terrorism, including checking its staff, suppliers and sub-contractors against the following sanctions lists: UK Treasury List, EC List, OFAC List and US Treasury List.
- 3. The Supplier shall comply with the following Customer Policies, which are available upon request: Code of Conduct, Reporting Concerns Policy, Safeguarding, Anti-Terrorism, and Anti-Fraud, Bribery and Corruption.

## 4. Delivery / Performance

- The Goods shall be delivered to, and the Services shall be performed at the address and on the date or within the period stated in the Order, and in either case during WFD's usual business hours, except where otherwise agreed in the Order. Time shall be of the essence in respect of this Condition
- 2. Where the date of delivery of the Goods or of performance of Services is to be specified after issue of the Order, the Supplier shall give WFD reasonable written notice of the specified date.
- 3. Delivery of the goods shall take place and title in the Goods will pass on the completion of the physical transfer of the goods from the Supplier or its agents to WFD or its agents at the address specified in the Order.



- 4. Risk of damage to or loss of the Goods shall pass to WFD in accordance with the relevant provisions of Incoterms rules as in force at the date the Contract is made or, where Incoterms do not apply, risk in the Goods shall pass to WFD on completion of delivery.
- 5. WFD shall not be deemed to have accepted any Goods or Services until WFD has had reasonable time to inspect them following delivery and/or performance by the Supplier.
- 6. WFD shall be entitled to reject any Goods delivered or Services supplied which are not in accordance with the Contract. If any Goods or Services are so rejected, at WFD's option, the Supplier shall forthwith re-supply substitute Goods or Services which conform with the Contract. Alternatively, WFD may cancel the Contract and return any rejected Goods to the Supplier at the Supplier's risk and expense.

## 5. Indemnity

The Supplier shall indemnify WFD in full against all liability, loss, damages, costs and expenses (including legal expenses) awarded against or incurred or paid by WFD as a result of or in connection with any act or omission of the Supplier or its employees, agents or sub-contractors in performing its obligations under this Contract, and any claims made against WFD by third parties (including claims for death, personal injury or damage to property) arising out of, or in connection with, the supply of the Goods or Services.

## 6. Price and Payment

Payment in arrears will be made as set out in the Order and WFD shall be entitled to off-set against the price set out in the Order all sums owed to WFD by the Supplier.

#### 7. Termination

- 1. WFD may terminate the Contract in whole or in part at any time and for any reason whatsoever by giving the Supplier at least one month's written notice.
- 2. WFD may terminate the Contract with immediate effect by giving written notice to the Supplier and claim any losses (including all associated costs, liabilities and expenses including legal costs) back from the Supplier at any time if the Supplier:
- a. becomes insolvent, goes into liquidation, makes any voluntary arrangement with its creditors, or becomes subject to an administration order; or
- is in material breach of its obligations under the Contract or is in breach of its obligations and fails to remedy such breach within 14 days of written request from WFD.
- 3. In the event of termination, all existing purchase orders must be completed.

#### 8. Supplier's Warranties

1. The Supplier warrants to WFD that:



- a. it has all necessary internal authorisations and all authorisations from all relevant third parties to enable it to supply the Goods and the Services without infringing any applicable law, regulation, code or practice or any third party's rights;
- it will not and will procure that none of its employees will accept any commission, gift, inducement or other financial benefit from any supplier or potential supplier of WFD;
   and
- c. the Services will be performed by appropriately qualified and trained personnel, with the best care, skill and diligence and to such high standard of quality as it is reasonable for WFD to expect in all the circumstances.

#### 9. Force majeure

- 1. Neither party shall be liable for any failure or delay in performing its obligations under the Contract to the extent that such failure or delay is caused by an event that is beyond that party's reasonable control (a "Force Majeure Event") provided that the Supplier shall use best endeavours to cure such Force Majeure Event and resume performance under the Contract.
- 2. If any events or circumstances prevent the Supplier from carrying out its obligations under the Contract for a continuous period of more than 14 days, WFD may terminate the Contract immediately by giving written notice to the Supplier.

#### 10. General

- 1. The Supplier shall not use WFD's name, branding or logo other than in accordance with WFD's written instructions or authorisation.
- 2. The Supplier may not assign, transfer, charge, subcontract, novate or deal in any other manner with any or all its rights or obligations under the Contract without WFD's prior written consent.
- 3. Any notice under or in connection with the Contract shall be given in writing to the address specified in the Order or to such other address as shall be notified from time to time. For the purposes of this Condition, "writing" shall include e-mails.
- 4. If any court or competent authority finds that any provision of the Contract (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision shall, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of the Contract shall not be affected.
- 5. Any variation to the Contract, including the introduction of any additional terms and conditions, shall only be binding when agreed in writing and signed by both parties.
- 6. The Contract shall be governed by and construed in accordance with English law.

  The parties irrevocably submit to the exclusive jurisdiction of the courts of England



- and Wales to settle any dispute or claim arising out of or in connection with the Contract or its subject matter or formation.
- 7. A person who is not a party to the Contract shall not have any rights under or in connection with it.



## WFD, Certificate of Compliance

## On behalf of the potential supplier or consultant:

- I warrant that all the information contained in our Bid or Proposal (including any attachments) is accurate and true and I/we undertake to notify WFD of any changes as soon as reasonably practicable.
- I warrant that we have complied with all the requirements set out in the Invitation to Tender or Call for Experts and in particular:
- i. We have acted in good faith in preparing this Bid or Proposal
- ii. We have not engaged in any collusive behaviour; and
- iii. We have not canvassed or sought information from any Crown or WFD employee.
  - I confirm that the potential supplier is not aware of any connection with a member of WFD's staff that could affect the outcome of the procurement.
  - I confirm that we have not communicated with any person other than WFD the value, price, or rates set out in the Bid or Proposal or shared any other information related to the Bid or Proposal with any other person.
  - I confirm that we have not offered or agreed to pay or paid or given any sum or sums
    of money, inducement, or valuable consideration directly or indirectly to any other
    person for doing or having done or causing or having caused to be done in relation
    to this Bid or Proposal any act or omission.

## WFD, Summary of Safeguarding Policy

#### Our values and principles

Child abuse is when anyone under 18 years of age is being harmed or isn't being looked after properly. Abuse can also be directed at vulnerable adults. Vulnerable adults are those aged 18 years or more who either identify themselves as unable to take care of themselves or protect themselves from harm or exploitation, or due to their gender, age or physical illness, mental health, learning or physical disabilities, as well as disasters and conflicts, and who are unable or unwilling as a result to identify themselves as vulnerable or subject to abuse, but are deemed at risk, because they are or may be unable to take care of themselves or protect themselves from harm or exploitation. Vulnerable adults may include employees, contractors, and/or beneficiaries.

The abuse can be physical, sexual, emotional or neglect. The abuse and exploitation of children and vulnerable adults happens in all countries and societies across the world. Abuse towards children and vulnerable adults is never acceptable.

It is expected that all who work with WFD are committed to safeguard children and any vulnerable individuals whom they employ or are in contact with.

#### What we do

WFD is committed to safeguard children and vulnerable individuals through the following means:

**Awareness:** Ensuring that all staff and those who work with WFD are aware of the problem of child and vulnerable person abuse and the risks to children and vulnerable adults.

**Prevention:** Ensuring, through awareness and good practice, that staff and those who work with WFD minimise the risks to children and vulnerable adults.

**Reporting:** Ensuring that you are clear on what steps to take where concerns arise regarding the safety of children and vulnerable adults.

**Responding:** Ensuring that action is taken to support and protect children and vulnerable adults where concerns arise regarding possible abuse.

To help you clarify our safeguarding approach, we list here examples of the behaviour by a representative of WFD which are prohibited. These include but are not limited to:

- 1. Hitting or otherwise physically assaulting or physically abusing children or vulnerable adults.
- 2. Engaging in sexual activity or having a sexual relationship with anyone under the age of 18 years regardless of the age of majority/consent or custom locally. Mistaken belief in the age of a child is not a defence.
- 3. Developing relationships with children or vulnerable adults which could in any way be deemed exploitative or abusive.



- 4. Acting in ways that may be abusive in any way or may place a child or vulnerable adult at risk of abuse.
- 5. Using language, making suggestions or offering advice which is inappropriate, offensive or abusive.
- 6. Behaving physically in a manner which is inappropriate or sexually provocative.
- 7. Sleeping in the same bed or same room as a child or vulnerable adult or having a child/children or vulnerable adult with whom one is working to stay overnight at a home unsupervised.
- 8. Doing things for children or vulnerable adults of a personal nature that they can do themselves.
- 9. Condoning, or participating in, behaviour of children or vulnerable adults which is illegal, unsafe or abusive.
- 10. Acting in ways intended to shame, humiliate, belittle or degrade children or vulnerable adults, or otherwise perpetrate any form of emotional abuse.
- 11. Discriminating against, showing unfair differential treatment or favour to particular children or vulnerable adults to the exclusion of others.
- 12. Spending excessive time alone with children or vulnerable adults away from others.
- 13. Placing oneself in a position where one is made vulnerable to allegations of misconduct.

In order that the above standards of reporting and responding are met, **this is what is expected of you**:

You should ensure that your staff are aware of the importance of good practice in safeguarding and have access to a whistleblowing facility.

If you or your staff are worried that a child or young person or a vulnerable adult is being abused or neglected or you are concerned about the inappropriate behaviour of an employee, or someone working with WFD, towards a child or young person or vulnerable adult, whether they are an employee or beneficiary, then you are obliged to:

- act quickly and get help
- support and respect the child or vulnerable adult
- where possible, ensure that the child or vulnerable adult is safe
- contact your WFD manager and/or the WFD Director of Operations & Company Secretary, Chris Lane, at chris.lane@wfd.org with your concerns immediately
- keep any information confidential to you and the manager.

## WFD, Summary of Anti-Fraud Bribery and Corruption Policy

## Our values and principles

WFD does not allow any partner, supplier, sub-contractor, agent or any individual engaged by WFD to behave in a corrupt manner while carrying out WFD's work.

#### What we do

WFD is committed to preventing acts of fraud, bribery and corruption through the following means:

**Awareness:** Ensuring that all staff and those who work with WFD are aware of the problem of fraud and bribery and corruption.

**Prevention:** Ensuring, through awareness and good practice, that staff and those who work with WFD minimise the risks of fraud and bribery and corruption.

**Reporting:** Ensuring that all staff and those who work with WFD are clear on what steps to take where concerns arise regarding allegations of fraud and bribery and corruption.

**Responding:** Ensuring that action is taken to support and protect assets and identifying cases of fraud and bribery and corruption.

To help you identify cases of fraud and bribery and corruption, behaviour which amounts to corruption includes but is not limited to:

- a. <u>Paying or Offering a Bribe</u> where a person improperly offers, gives or promises any form of material benefit or other advantage, whether in cash or in kind, to another in order to influence their conduct in any way.
- Receiving or Requesting a Bribe where a person improperly requests, agrees to receive or accepts any form of material benefit or other advantage, whether in cash or in kind, which influences or is designed to influence the individual's conduct in any way.
- c. <u>Receiving or Paying a so-called 'Grease' or 'Facilitation' payment</u> where a person improperly receives something of value from another party for performing a service or other action that they were required by their employment to do anyway.
- d. <u>Nepotism or Patronage</u> where a person improperly uses their employment to favour or materially benefit friends, relatives or other associates in some way. For example, through the awarding of contracts or other material advantages.
- e. <u>Embezzlement</u> where a person improperly uses funds, property, resources or other assets that belong to an organisation or individual.



- f. Receiving a so-called 'Kickback' Payment where a person improperly receives a share of funds, a commission, material benefit or other advantage from a supplier as a result of their involvement in a corrupt bid or tender process.
- g. <u>Collusion</u> where a person improperly colludes with others to circumvent, undermine or otherwise ignore rules, policies or guidance.
- h. <u>Abuse of a Position of Trust</u> where a person improperly uses their position within their organisation to materially benefit themselves or any other party.

In addition, fraud takes place whenever a staff member or someone WFD is working with acts dishonestly and does something with the intention of making a gain for themselves or causes someone else a loss.

In order that the above standards of reporting and responding are met, this is what is expected of you:

You have a duty to protect the assets of WFD from any form of fraud or corruption. Furthermore, you must immediately inform your WFD representative and/or the WFD Director of Operations & Company Secretary, Chris Lane, at chris.lane@wfd.org. Failure to report will be treated as serious and may result in termination of any agreement with WFD.

You are obliged to:-

- act quickly and get help
- encourage your own staff to report on bribery and corruption
- contact your WFD representative and/or the WFD Director of Operations & Company Secretary, Chris Lane, at chris.lane@wfd.org with your concerns immediately
- keep any information confidential to you and the representative.

Attempted corruption is as serious as the actual acts and will be treated in the same way under this policy.

## WFD, Summary of Anti-Terrorism Policy

## Our values and principles

WFD requires that all partners, suppliers, sub-contractors, agents or individual engaged by WFD complies with all laws, including, specifically, the laws of the United Kingdom, the European Union and the United Nations, as well as any other applicable legal or regulatory requirements, such as local laws.

WFD condemns terrorist acts and those who promote and fund such activities.



#### What we do

WFD is committed to preventing acts of terrorism through the following means:

**Awareness:** Ensuring that all staff and those who work with WFD are aware of the problem of terrorism.

**Prevention:** Ensuring that WFD funds and/or resources are not used to support terrorism.

**Reporting:** Ensuring that action is taken to report any known or suspected acts of terrorism, or connections between WFD partners and terrorist organisations.

**Responding:** Ensuring that action is taken to prevent terrorism or the support of terrorism.

To help you identify cases of terrorism being support, behaviour which must be reported includes but is not limited to the belief or suspicion that WFD staff or a third party:

- has sought to raise finds or secure property for the purposes of terrorism;
- has received funds or property for the purposes of terrorism;
- is providing funds or property to another with the intention or suspicion that it is to be used for the purposes of terrorism;
- uses or possesses any money or property for the purposes of terrorism; and/or
- becomes concerned in an arrangement relating to such matters above;

In order that the above standards of reporting and responding are met, **this is what is expected of you**:

You have a duty to protect WFD from involvement in any form of terrorist activity. Furthermore, you must immediately inform your WFD representative and/or the WFD Director of Operations & Company Secretary, Chris Lane, at chris.lane@wfd.org. Failure to report will be treated as serious and may result in termination of any agreement with WFD.

You are obliged to:-

- act guickly and get help
- encourage your own staff to report on terrorist activity
- contact your WFD representative with your concerns immediately and/or the WFD Director of Operations & Company Secretary, Chris Lane, at chris.lane@wfd.org
- keep any information confidential to you and the WFD representative.

There is <u>no minimum</u> amount for an incident to be reportable. If you want to know more about the WFD Anti-Terrorism Policy, then please contact your WFD representative.
