CONTRACT VARIATION AGREEMENT

THIS VARIATION AGREEMENT is made on May 2022

BETWEEN:

- (1) **NHS COMMISSIONING BOARD** (also referred to as NHS England) of Quarry House, Quarry Hill, Leeds, LS2 7UE (**"the Authority"**); and
- (2) **NHS Confederation** a company registered in England under company number 04358614 and Charity number 283447 and whose registered office is at Floor 15, Portland House, Bressenden Place, London SW1 5BH (**the "Supplier"**).

Each a **"Party"** and together referred to as **"the Parties"**.

BACKGROUND:

- (A) NHS England has appointed the Supplier to provide the Services under contract dated 2nd July 2021 (the Contract) for the provision of 'NHS Race and Health Observatory (RHO)'.
- (B) The Authority and the Supplier have mutually agreed to vary the Contract in accordance with Clause 21 (Change Management) of the Contract as outlined below in (2) Contract Variation.
- (C) The Authority will make payment to the Supplier as detailed below in (3) Costs / Commercial Schedule 6 of the Contract.

IT IS AGREED as follows:

1. Definitions and Interpretation

- Capitalised words and phrases in this Agreement shall have the meanings given to them in the Contract.

- The Contract, including any previous Variations, shall remain effective and unaltered except as amended by this Agreement.

2. Contract Variation

- In accordance with Clause 21 (Change Management) and Clause 21.1, the Authority is varying the Contract as detailed below:
- The resource is to support RHO to commission an organisation to review inequalities that impact on health outcomes faced by those with a learning disability who are from a minority ethnic community and provide clear policy recommendations in this area.
- The resulting information will then need to provide recommendations to improve outcomes for patients in this cohort which help reduce the inequalities seen.

Timescale

- The variation has been agreed to cover the service from January 2022 till December 2022.

Charges and Invoicing

- The Supplier will be paid a maximum of £78,000 including VAT (£65,000 plus £13,000 VAT) to commission this service on behalf of NHS England.
