### 1. INTRODUCTION

- 1.1 The purpose of this Document is to set the specification for the provision of Powder Paint to the Engineering Industry to be procured for the Ministry of Justice under contract.
- 1.2 The Contract will be set for a minimum of two years with an option to extend for two further years (2 + 1 + 1).

### 2. PURPOSE

- 2.1 Public Sector Prison Industries is part of the National Offender Management Service (NOMS) delivering work opportunities in prison workshops for over 10,000 prisoners on a daily basis. There are numerous workshops in different establishments, employing prisoners. The purpose of this project is to source goods for use in these workshops.

### 3. BACKGROUND TO THE AUTHORITY

- 3.1 (NOMS) is an executive agency of the Ministry of Justice responsible for commissioning and delivering adult offender management services in custody and the community in England and Wales. Its duty is to look after them with humanity and help them lead law-abiding and useful lives after release from custody. - 3.2 NOMS is referred to as the Authority hereafter.

### 4. BACKGROUND TO REQUIREMENT/OVERVIEW OF REQUIREMENT

4.1 Public Sector Prison Industries provides employment for approximately 9000 prisoners in industrial based workshops. The Engineering Industry employs approximately 600 prisoners on a daily basis in 13 establishments across the UK-wide Prison estate. These workshops manufacture a range of welding and fabrication, sheet metal, machining and powder painted products predominately for the internal market with a view to filling additional capacity with commercial work. To produce the range of products requires the procurement of numerous different types of raw materials, including powder paint.

### 5. SCOPE OF REQUIREMENT

- 5.1 To appoint a sole provider with capability to competitively purchase powder paint and supply to nominated engineering workshops across the prison estate in accordance with the Specifications provided at Annex A of this document.
- 5.2 The contract will be let to a single provider who best meets this specification in terms of best whole life value for money. The Authority does not commit to any minimum quantities or order value(s), under contract.

- 5.3 The Contract will enable the Authority's 6 main Engineering workshops, along with others as required, to purchase powder paint, within the time restraints of the contract, which are:
  - 5.3.1 Delivery from receipt of Purchase Order within 5 working days for items listed (but not exhaustive) within Annex A.
  - 5.3.2 Substantive 24 hour response to any Quality, Delivery, or Performance issues raised by the Authority, with proposals for their resolution. The supplier must make an onsite technical visit the next working day, if the Authority requests such a visit by midday.
- 5.4 The provider must have the ability to supply powder paint in small quantities when required (no minimum order volumes), and to provide samples of powder paint to any of the Authority's establishment on request.
- 5.5 Prior to despatch, the powder paint must be clearly marked with product code, number, product description, quantity of each item, Order number, and the providers' name and contact details.
- 5.6 The provider must demonstrate it has relevant technical expertise to understand developments in relevant markets and to maximise them for the Authority's benefits; offer innovation and technical advice and support and to propose alternative materials, which may enhance performance, improve quality, or offer financial savings.
- 5.7 The provider must hold a large and wide range of stock items, which can be provided to the Authority quickly and in small quantities to assist with development work or commercial enquiries.
- 5.8 The provider must appoint a Contract Manager responsible as its point of contact, who can easily be contacted by the Authority during normal office hours when required.
- 5.9 The provider must attend regular service review meetings (at least 6 monthly) to discuss how the contract is operating, to address any issues raised by the Authority; to provide advice and technical support on any new innovations the Authority is working on and any changes to the service. Meetings will be at the Authority's nominated premises and will be at nil extra cost to the Authority.

### 6. SERVICE LEVELS AND PERFORMANCE

- 6.1 The Authority will measure the quality of the providers' delivery by:
  - 6.1.1 Ability to provide powder paint within the stated lead times.
  - 6.1.2 A response within 24 hours is expected on any reported quality issues. An on site technical visit is required next working day when requested by the Authority. (If notified by midday)
  - 6.1.3 Provider shall evidence their technical expertise in understanding developments in the market, by offering improvements or alternative

materials, which may enhance performance, improve delivery or offer financial savings.

### 7. ADDITIONAL REQUIREMENTS

- 7.1 This exercise will operate in accordance with the following:
  - 7.1.1 The provider will need to arrange delivery around the operational constraints of each of the 13 individual prison establishments. These include, but are not limited to, physical size of gates to access premises, staff constraints on time slots for delivery and limited access to areas of sites.
  - 7.1.2 Delivery arrangements must be agreed with individual establishments prior to delivery of an order. The Authority anticipates that the lead time for orders placed will be within the 4 days; therefore bidders must indicate they can meet these times.
  - 7.1.3 The provider must ensure compliance against product specifications, and in particular the standards outlined in the technical specification, throughout the tenure of the contract see Annex A..
  - 7.1.4 The procurement exercise will be compliant with the EU procurement directives as enacted by the UK Public Contracts Regulations 2006;
  - 7.1.5 A contract will be in place for all of the in-scope powder paint requirements;
  - 7.1.6 Value for money will be achieved over the life of the contract by testing the market and specifications and, testing the product range., Clear price reviews will be agreed on a 6 monthly basis and compared against independent indices;
  - 7.1.7 The target for savings compared to the prices currently paid is a reduction of 10% overall for the in-scope products. The Authority will therefore scrutinise prices submitted to gauge how they compare to current prices.
  - 7.1.8 An efficient and effective supply chain, including efficient delivery and storage of products;
  - 7.1.9 Joint product development and innovation between the Authority and the provider in order to make quality improvements and vary the range of powder paints where appropriate;
  - 7.1.10 The provider will support the Authority to facilitate flexibility, innovation and quicker supply where required;
  - 7.1.11 Contingency within supply chain to ensure security of supply at the best prices and required quality;
  - 7.1.12 The contractual arrangements will ensure environmental sustainability with respect to reducing carbon emissions, pollution, water consumption, exposure to hazardous substances and other environmental harm. The supplier will comply with the Government Buying Standards

- 9.1 All delivery drivers will need to adhere to the local security procedures in place at each location.
- 9.2 Prices should be inclusive of expenses and exclusive of VAT.
- 9.3 All costs submitted within the tender will need to include transport delivery costs.
