Appendix A

Scope of the Requirement

1. scope of requirement

- 1.1 The requirement is for external legal support during the mobilisation of the new East Midlands rail franchise operator, covering the period from Contract Award to Franchise start (April August 2019).
- 1.2 This requirement will not cover legal advice or services for the 'in-life' element of the East Midlands franchise (post-August 2019 Franchise start) as this is/will be covered by an [existing] alternative contract.

2. The requirement

- 2.1 The requirement is for external legal advice for the East Midlands Franchise Competition mobilisation phase.
- 2.2 Provide advice and support on issues that arise with franchise documentation prior to the Department's signature and procurement issues.
- 2.3 Provide advice on issues that arise with the winning bidder during the mobilisation stage.
- 2.4 Undertake drafting of any outstanding legal documentation following franchise signature.
- 2.5 Provide legal advice in relation to the Conditions Precedent Agreement.
- 2.6 Provide legal support in reviewing the evidence from the incoming franchisee that the Conditions Precedent have been achieved and make recommendation(s) to the Department on the issue or not of the Commencement Certificate.
- 2.7 Produce or review and advise the Department on the relevant legal documents required for the franchise to commence e.g. Transfer Scheme.
- 2.8 Work with Financial and Technical Advisers to produce mobilisation packs detailing franchise deliverables and key performance indicators that will form the basis for the on going Contract Management.
- 2.9 Work with the winning bidder and the Department's mobilisation team providing advice on legal issues that arise with during the mobilisation stage.
- 2.10 Attend meetings with the Department and the winning bidder where requested by the Department, including the Conditions Precedent Review meeting.
- 2.11 Producing bibles of Start Date documentation, including but not limited to documentation relating to conditions precedent satisfaction and transfer scheme documentation.
