


### BULK SUBSCRIPTIONS ORDER FORM

This Bulk Subscriptions Order Form (the "Order Form") to the Bloomberg (Bulk Data) Datalicense Schedule of Services under Account number 30527661 to the Bloomberg Per Security Datalicense Agreement, Bloomberg Datalicense Agreement, Bloomberg Bulk Datalicense Agreement or Bloomberg Custody Datalicense Agreement No. 3143255 (respectively, the "Schedule" and the "Agreement") is by and between BLOOMBERG FINANCE L.P. ("Licensor") and **DEPARTMENT FOR INTERNATIONAL TRADE** ("Licensee"). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Schedule or the Agreement, as applicable.

The Bulk Subscriptions set forth below are provided to Licensee as part of the Services under the Schedule. All amounts displayed on this Order Form are in U.S. dollars.

1. In addition to any termination rights of the parties set forth in the Agreement, Schedule or this Order Form, Licensee may, upon at least seven (7) days' written notice to Licensor, terminate any Bulk Subscription listed above during the twelve (12) month period ("Year One") immediately following the date the Bulk Subscription was first provided to Licensee (the "Termination Period"). Licensee shall not be required to pay the 50% termination charge set forth in paragraph 3 of the Schedule in connection with the termination of any such Bulk Subscription by Licensee during the Termination Period. For the avoidance of doubt, no *pro rata* refund of Monthly Fees paid in accordance with Appendix A (as defined below) will be provided in the event that one or more of the Bulk Subscription(s) are terminated pursuant to this paragraph prior to the end of Year One.
  2. Each Bulk Subscription listed above that is also set forth in Appendix A hereto ("Appendix A") shall be charged at the rates and for the periods indicated in Appendix A during the initial Bulk Subscription Term of such Bulk Subscription, starting from the date such Bulk Subscription is first provided. For the avoidance of doubt, upon the renewal of any such Bulk Subscription, Licensor's charges payable for the Bulk Subscription shall be calculated at the prevailing rates then offered by Licensor.
  3. Notwithstanding anything to the contrary in paragraph 3 of the Schedule, if any Bulk Subscription listed above is terminated for any reason following Year One of its initial Bulk Subscription Term, Licensee shall be liable for, and pay upon presentation of an invoice, all amounts payable for such terminated Bulk Subscription under the Schedule and the Order Form through the date of termination, including without limitation, all applicable termination charges calculated based on the Licensor charges that Licensee would have owed for such Bulk Subscription if no rate reductions were applied (excluding, if applicable, any Licensor charges that Licensee would have owed for such Bulk Subscription during an Implementation Period).
