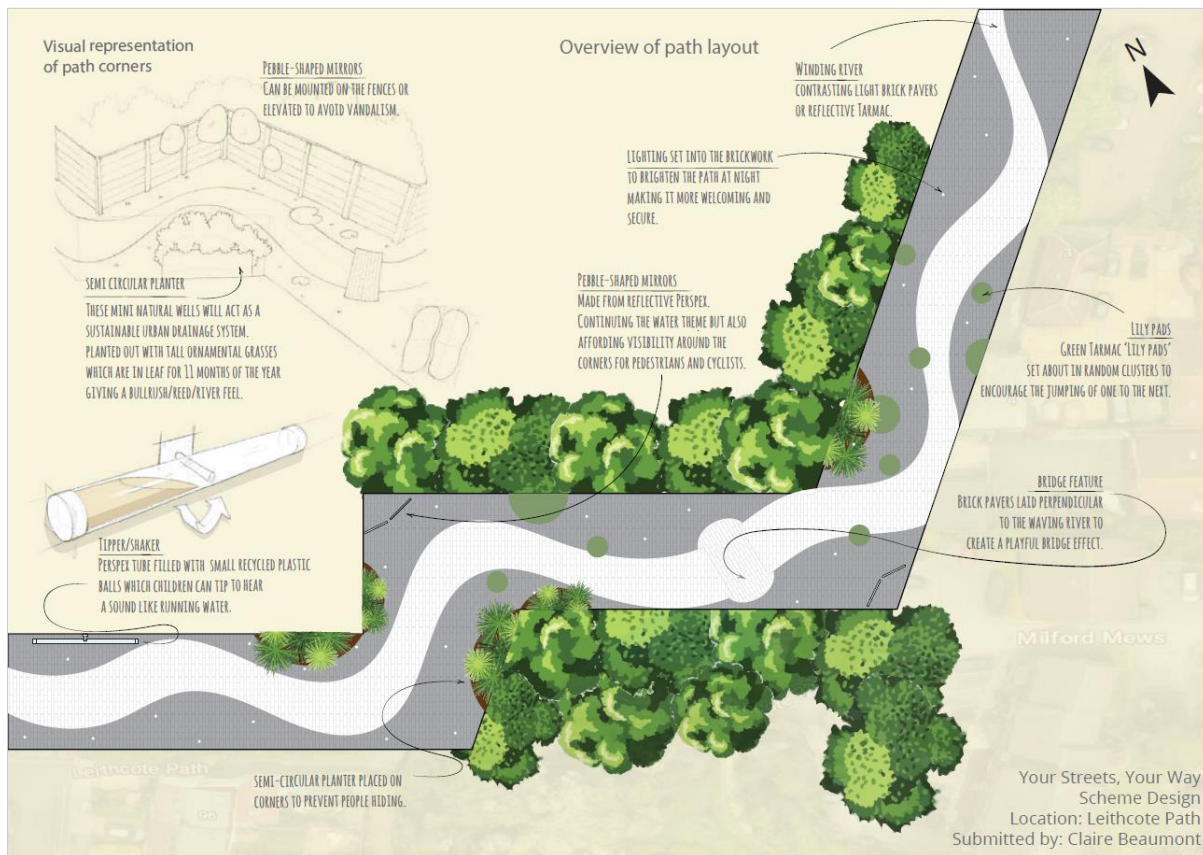

## Description

### 1. Background and Rationale

This commission is one of several locations chosen for the Your Street Your Way (YSYW) project. YSYW is a key part of the Healthy Neighbourhoods plan that supports traffic reduction and behaviour change. The designs were submitted by the public. Lambeth Council is seeking an artist / designer to realise a mural along the floor and walls of Leithcote Path. The winning concept depicts a river running along the floor of the path with other natural elements.



The mural will be used to:

- Brighten the space and improve the experience of active travel in the area  
Improve visibility for path users around corners
- Celebrate nature in the area and make the space more welcoming to school children and those walking and cycling.

## 2. Project Specifics

Leithcote Path is a 132m footpath starting at the end of Leithcote Gardens. It is located in Streatham ([Link](#)).

The commission will include:

- A nature inspired mural that represents a flowing river on the floor of the path.
- A bridge and lily pads that can be used for play while travelling along the path painted on the floor.
- A wall mural to tie into the floor design.

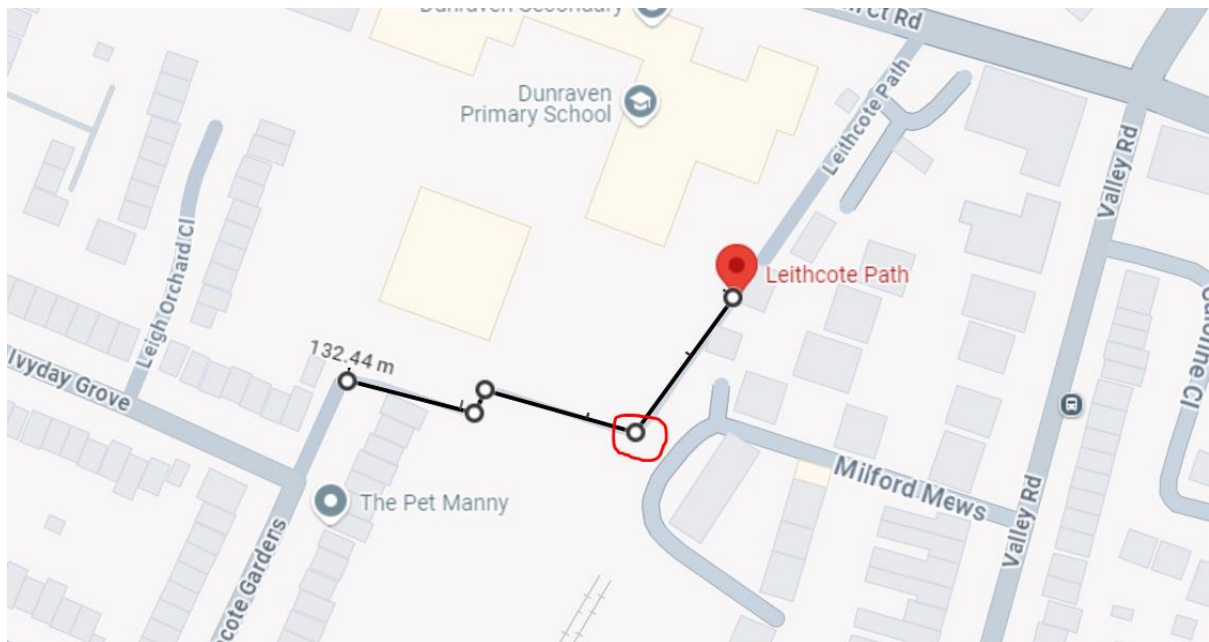
The original design included many other elements that have had to be removed due to budget constraints and highways regulations. The design will no longer include:

- Planters
- Tipper / shaker
- Lighting set into the path
- Mirrors

We would like for the design to include alternative elements to the lights such as glow paint.

The original design did not feature a wall mural. We would like a wall mural to be designed as part of the quote. This mural should tie into the themes of nature and the river flowing along the floor.

Cars drive along the wider end of Leithcote Path, this is between red dropper and red circled point on the map below. On this stretch of the path, we would like for the river on the floor to flow onto the wall. This section will only include a wall mural to avoid cars regularly driving over the floor paint and decreasing its lifespan.



### 3. Key considerations

- You must replicate the design, however as part of your commission you must advise on potential changes to best suit the medium and produce up to three design iterations based on comments received from stakeholders.
- You must prime / prepare the substrate (tarmac, concrete fence) prior to installation. Materials used must be long lasting and appropriate for the surfaces.
- All materials should be chosen with durability and longevity in mind.

- The design must be created with very low or no maintenance costs.
- The design will need to consider how best to deter or minimise the impact of tagging and graffiti.
- The work will need to be delivered in a short space of time to reduce disruption caused to residents and commuters.
- The design will need to be edited to avoid any buried utilities to minimise any damage to the mural if works are required.
- The nearby school has requested that installation be done during the school holidays to minimise disruptions to students that use the path. Depending on the iteration process installation should be scheduled for the next closest school holiday. This is likely to be in the February half term, however this will depend on how long the iteration process takes and could be sooner.

#### **4. Budget**

The total budget for this project is £20,000. This needs to cover the design iteration process, installation, any materials or equipment, and any insurance needed.

Application deadline: 10 December 2024

Winner announced: 12 December 2024

Inception meeting: 16 December 2024

Iteration process: 23 December 2024

Installation: 17 February 2025

#### **6. Assessment Criteria and Scoring**

Submissions will be assessed 30% on price and 70% on quality. The lowest priced bid will score the maximum 40 points with others benchmarked against it, calculated as below:

$$\frac{\text{Lowest priced bid}}{\text{Your bid}} \times 30 = \text{your price score}$$

The quality evaluation criteria will consider:

Project plan and methodology	25%
Social value	25%
Overall design	25%
