- 1) All values quoted on the Order Form are exclusive of VAT which will be included on any invoice at the prevailing rate. 2) Upon completion of the Initial Period this Agreement shall automatically be subject to an Annual Extension (of 12 months) unless either Party gives written notice to the other Party of its intention not to renew the Agreement at least 90 days before the expiry of the Initial Period or any Annual Extension, in which case this Agreement will terminate at the end of that notice period. (Does not apply if the order is an Evaluation)
- 3) Unless otherwise agreed, the Total Charges are payable annually in advance ('Prepayments') and are non-refundable. Invoices for Prepayments will be dated as per the Contract Start Date above (or the anniversary thereof in the case of an Annual Extension) and are payable under GBG's normal payment terms.
- 4) Where the Client exceeds the amount of Credits/Click or Users included annually in the search Prepayment amount, such usage will be charged at the Charges set out above and will be invoiced monthly in arrears.
- 5) If GBG has agreed preferential Charges or payment terms under this Agreement or if the standard Charges or payment terms that applied on the Contract Start Date have changed during the Initial Period then unless otherwise expressly agreed in writing between the Parties, GBG's standard List Prices and payment terms will prevail in respect of the Client's continued use of the Services/Licensed Products and Data after the Initial Period.
- 6) Unless otherwise detailed in the Agreement or agreed in writing between the parties, all payments will become due upon termination of this Agreement before the end of the Initial Period.
- 7) Professional Services and Prepayments are only valid for delivery by GBG in the 12 month period to which they apply and cannot be carried over into other Periods.
- 8) After the expiry of the Initial Period GBG shall be entitled to increase its Charges by giving the Client not less than 30 days' notice of the change. For the avoidance of doubt, GBG will not revise the Charges before the end of the Initial Period.
