With reference to the contractual letter dated 23 November 2011, (as most recently amended by the letter of 28 June 2015), whereby your firm was engaged to deliver the Terms of Reference of the Contract, I confirm that the UK Government wishes to make the following further amendments to the letter of 23 November 2011:

## Section 1, Form of Contract, Paragraph 3, Commencement and duration of the Services

**Delete:** 'and shall complete them by 19 August 2016 ("the End Date") unless the Contract is terminated

earlier in accordance with its terms and conditions.'

**Insert:** 'and shall complete them by 31 March 2017 ("the End Date") unless the Contract is terminated

earlier in accordance with its terms and conditions.'

## Section 1, Form of Contract, Paragraph 4, Financial Limit

**Delete:** 'Payments under this Contract shall not, in any circumstances, exceed £5,455,278 exclusive of

any government tax, if applicable ("the Financial Limit").'

Insert: 'Payments under this Contract shall not, in any circumstances, exceed £6,591,138 exclusive of

any government tax, if applicable ("the Financial Limit").'

## Section 3, Terms of Reference

**Delete:** Terms of Reference updated September 2015

**Insert:** Terms of reference updated June 2016

Add: Annex A PGF Completion Phase note\_25 June 2016
