### **CUBITT TOWN (from OLD STREET STATION)**

Buses proceed from Manchester Road departing to Manchester Road. Set down in Manchester Road, at stop M (15156 - Stewart Street, Last Stop on LOR: 15156 - Stewart Street) and pick up in Manchester Road, at stop J (15157 - Stewart Street, First Stop on LOR: 15157 - Stewart Street).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	<b>Turning Point Only - Buses must not stand</b>
BLIND DISPLAY:	Isle of Dogs, Cubitt Town.

### **CANARY WHARF, TRAFALGAR WAY (from OLD STREET STATION)**

Public stand for up to two buses on southbound carriageway of Trafalgar Way, 149 metres south of Broadwalk Place and 204 metres north of Cartier Circle.

Buses proceed from Canada Square via The North Colonnade, Churchill Place, Cartier Circle and Trafalgar Way to stand, departing via Trafalgar Way, Cartier Circle, Churchill Place and The South Colonnade to Canada Square. Set down in Canada Square, at Stop H (BP3588 - Canada Square North and pick up in Canada Square, at Stop J (R0314 - Canada Square South).

MEAL RELIEFS:	No meal relief vehicles to stand at any time.

## **LIMEHOUSE, BURDETT ROAD**

Private stand for two buses in bus station at the junction of East India Dock Road and Burdett Road, commencing 20 metres east of eastern kerblines of Burdett Road and extending 30 metres south.

### **From Crossharbour, Asda.**

Buses proceed from West India Dock Road via East India Dock Road and Limehouse Bus Station to stand, departing via Limehouse Bus Station and Burdett Road to West India Dock Road. Set down in West India Dock Road, at Stop WM (BP107 - Limehouse Police Station, Last Stop on LOR: BP107 - Limehouse Police Station) and pick up in West India Dock Road, at Stop WU (36875 - Limehouse Police Station, First Stop on LOR: 36875 - Limehouse Police Station).

### **From Old Street Station.**

Buses proceed from Commercial Road via East India Dock Road and Limehouse Bus Station to stand, departing via Limehouse Bus Station and Burdett Road to Commercial Road. Set down in Commercial Road, at Stop LE (887 - Burdett Road, Last Stop on LOR: 887 - Burdett Road) and pick up in Commercial Road, at Stop LH (1689 - Limehouse Town Hall, First Stop on LOR: 1689 - Limehouse Town Hall).

OPERATING RESTRICTIONS:	Unscheduled curtailments only
MEAL RELIEFS:	No meal relief vehicles to stand at any time.

## **STEPNEY, ARBOUR SQUARE**

Public stand for two buses (one in each of two sections) on east side of Arbour Square facing north.

Buses proceed from Commercial Road via Arbour Square (East) and Arbour Square (East Side) to stand, departing via Arbour Square (East Side), Arbour Square (North Side), Arbour Square (West Side) and Arbour Square to Commercial Road. Set down in Commercial Road, at Stop LM (1865 - Marion Richardson School, Last Stop on LOR: 1865 - Marion Richardson School) and pick up in Commercial Road (1866 - Arbour Square, First Stop on LOR: 1866 - Arbour Square).

### **From Old Street Station.**

Buses proceed from Commercial Road via Arbour Square (East) and Arbour Square (East Side) to stand, departing via Arbour Square (East Side), Arbour Square (North Side), Arbour Square (West Side) and Arbour Square to Commercial Road. Set down in Commercial Road (1866 - Arbour Square, Last Stop on LOR: 1866 - Arbour Square) and pick up in Commercial Road (881 - Exmouth Estate, First Stop on LOR: 881 - Exmouth Estate).

OPERATING RESTRICTIONS:	Unscheduled curtailments only
MEAL RELIEFS:	No meal relief vehicles to stand at any time.
FERRY VEHICLES:	No ferry vehicles to park on stand at any time.

## **ALDGATE**

### **From Crossharbour, Asda.**

Buses proceed from Whitechapel High Street via Aldgate High Street, Minories, Aldgate Bus Station and Aldgate High Street departing to Whitechapel High Street. Set down in Whitechapel High Street, at Stop J (BP5244 - Aldgate East Station <>, Last Stop on LOR: BP5244 - Aldgate East Station <>) and pick up in Whitechapel High Street, at Stop G (33431 - Aldgate East Station <>, First Stop on LOR: BP6052 - Aldgate East Station <>).

### **From Old Street Station.**

Buses proceed from St Botolph Street via Aldgate High Street, Minories, Aldgate Bus Station and Aldgate High Street departing to St Botolph Street. Set down in St Botolph Street, at Stop A (34189 - Aldgate Station <>, Last Stop on LOR: 34190 - St Botolph Street) and pick up in St Botolph Street, at Stop B (34190 - St Botolph Street, First Stop on LOR: BP6391 - Duke's Place).

OPERATING RESTRICTIONS:	<b>Turning Point Only - Buses must not stand</b>
BLIND DISPLAY:	Aldgate.

### **LIVERPOOL STREET, WORSHIP STREET (from Crossharbour, Asda)**

Buses proceed from Bishopsgate via Primrose Street, Appold Street, Worship Street and Norton Folgate departing to Bishopsgate. Set down in Bishopsgate, at Stop H (2114 - Primrose Street, Last Stop on LOR: 2114 - Primrose Street) and pick up in Bishopsgate, at Stop J (BP244 - Primrose Street, First Stop on LOR: BP244 - Primrose Street).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	<b>Turning Point Only - Buses must not stand</b>
BLIND DISPLAY:	Liverpool Street.

### **OLD STREET STATION, EAST ROAD**

Public stand for two buses on east side of East Road, commencing at bus stop 36838 and extending 19 metres north.

Buses proceed from Provost Street via Vestry Street and East Road to stand, departing to East Road. Set down in Provost Street, at Stop A (33436 - Moorfields Eye Hospital, Last Stop on LOR: 33436 - Moorfields Eye Hospital) and pick up in East Road, B (36838 - Old Street Station <> #, First Stop on LOR: 36838 - Old Street Station <> #).

6. Spare Vehicle - The Operator shall ensure that the following number of spare vehicles, which are specified in Schedule IIA Part 1, are available for the provision of the Services. 2
7. Existing Vehicles – The Operator shall ensure that all vehicles entering service on this route undergo refurbishment to the March 2014 Refurbishment Specification prior to entering service.
8. Route Risk Assessment - The Corporation acknowledges receipt of the Route Risk Assessment pertaining to route 135.
9. Contract Price Adjustment – applied from Tranche 730 onwards:

Paragraph 9.2.2 is deleted and replaced by the following:

The percentage price adjustment (R) is a 12-month rolling average given by: -

$$R = W \times \frac{1}{12} \times \sum_{i=1}^{n=12} \frac{P_{i+1} - P_{i+13}}{P_{i+13}}$$

Where:

- W = 0.85 representing the proportion of the Contract Price that is to be adjusted by movement in the Consumer Price Index.
- $P_{i+1}$  = The Consumer Prices Index published for the month that is i+1 month prior to the anniversary of the Date of Tender as set out in Table D7BT published by the Office for National Statistics (ONS).
- $P_{i+13}$  = The Consumer Prices Index published for the month that is i+13 months prior to the anniversary of the Date of Tender as set out in Table D7BT published by the Office for National Statistics (ONS).
