

AMENDMENT TO CONTRACT

The details contained in this document form a binding amendment to the Contract referenced below between the Contractor and the Secretary of State for the Ministry of Housing, Communities and Local Government ("MHCLG").

Details of Amendment	:	As follows.

Extension of the Contract for a further 12 months to undertake the English Housing Survey (EHS) 2021-22 using a 'knock-to-nudge' or a 'push-to-phone' approach. The 2021-22 EHS would use a 'knock-to-nudge' approach if England is not in a lockdown due to COVID-19 and if social distancing guidelines in force at the time of the interview allow it. Otherwise, the survey would use a 'push-to-phone; approach. A knock-to-nudge approach involves first writing to respondents and sending interviewers to visit sampled addresses, as is the case with the traditional in-home face-to-face approach. The interviewer would arrange for a face-to-face interview if the respondent is willing to do so. Otherwise, the interviewer would arrange for a remote telephone interview i.e. an interview conducted by an EHS interviewer using the existing questionnaire but over the telephone, rather than in respondents' homes. A 'push-to-phone' approach involves recruiting respondents by writing to them and inviting them to provide their contact telephone details (i.e. an opt-in) so an interviewer would carry out a a face-to-face interview.

In accordance with paragraph 10.6 of the Service Requirements, the Contract term is extended for the running of the survey for the year 2020/21. The Contract Completion date is therefore amended to **06 March 2024**.
