Section 4 – Specification and about this Procurement

Introduction

As a part of Prospering from the Energy Revolution (PFER) we have funded a portfolio of projects to design models for smart local energy systems (SLES) that can decarbonise heat, power and mobility across their region. A key requirement of the programme is to develop business models that will enable them to deliver these models as a cohesive investable proposition. As part of this work projects in the detailed design phase are considering how best to finance their integrated, cross-sector portfolios and overcome barriers to investment.

Work is active and underway to better understand how to unlock these barriers. In the last 12 months a SLES Investor Panel has been established by a group of detailed design projects bringing together infrastructure projects with policy stakeholders and the investment community in collaboration around this issue. It has identified barriers in securing project finance to deliver a coherent, integrated network of inter-dependent net zero projects which constitute a SLES and delivers whole system benefits. An early conclusion is that further de-risking support is needed along with a stronger understanding of how to standardise these types of cross-sector, place-based portfolios and package them up for investment in a way that avoids investor cherry-picking.

PFER also recently published a joint report with the Green Finance Institute [Mobilising Local Net Zero Investment](#) which outlined the role of local authorities in mobilising capital at the local level. The top three gaps which need to be addressed in order to achieve this potential are i) a lack of technical development assistance, ii) a lack of expert financial advisory support to help local authorities to develop financial structuring to finance cross-sector portfolios and iii) an overall funding gap.

Potential solutions are emerging. [3Ci, a partnership between Connected Places Catapult, Core Cities UK, and London Councils](#), have secured BEIS funding to build the case for a multi-intervention, place-based net zero demonstrator across core cities underpinned by a blended investment model. In doing so, it aims to provide a framework within which cross-city portfolios are aggregated to reach the necessary scale to attract long-term, patient capital. It also aims to create a development fund that could deliver a national technical assistance programme for local authorities. At the same time, the UK Infrastructure Bank (UKIB) is offering a local lending service and developing an accompanying advisory service to local authorities [due to pilot with Bristol City Council, Greater Manchester Combined Authority and West Midlands Combined Authority this Autumn](#).

Emerging solutions such as these understandably, are likely to focus their immediate attention on piloting and demonstration in places furthest ahead in their net zero journeys and the capacity to see it through, such as core cities and combined authorities.

Given the urgency to meet net zero, and the level of ambition shown by local authorities across the board, we need to accelerate our understanding of possible funding routes for those beyond cities such as those in smaller towns & cities, rural areas and coastal communities, simultaneously to ensure the transition moves at the pace required to meet our national net zero targets. It is possible that these other local authorities may not be ready to engage with emerging solutions targeting those further ahead in their journey, and potentially, may not even be compatible. This piece of work aims to understand the development and financing needs of these types of local authorities to ensure we do not risk losing pace on reaching net zero while we wait for solutions for those larger scale local authorities to prevail.

The project portfolio within UKRI's Prospering from the Energy Revolution Challenge (PFER) provides access to a diverse mix of different local authority led projects with established detailed designs for decarbonisation across heat, power and mobility. They are at the critical development phase where work to

understand financing structures is underway to varying degrees across the portfolio. This provides an opportunity to explore to what extent local authorities outside of core cities (CC's) and combined authorities (CA's) could pursue an accelerated pathway to securing finance for their net zero projects while large scale solutions are in development.

Aims & Objectives

The aim of this research is to explore to what extent local authorities outside of core cities and combined authorities could pursue an accelerated pathway to securing finance for their net zero projects while large scale solutions are in development.

The objectives are:

- To understand the needs of local authorities outside of CC's and CA's when it comes to the development and financial structuring of their cross-sector net zero portfolios via PFER's portfolio of SLES projects
- Assess whether, and to what extent, these needs differ to those of CC's and CA's and if so, what financial solutions, support and innovation may be required to ensure they have adequate access to finance for their net zero projects
- Build on the SLES investor panel work to understand
 - *what kind of financial framework/structuring could prevent investor cherry-picking and enable whole-system value to be achieved*
 - *what level of project standardisation is required/possible to achieve strong levels of investability across a place-based portfolio using SLES as an example*
- Identify suitable funding models and assess whether they lend themselves to a particular set of either place-based or project characteristics that might allow the development of a more diverse set of (archetypal) local net zero funding solutions
- Better understand potential market failures around financing place-based net zero projects which could be addressed by future programmes
- Support and inform emerging solutions under development by BEIS, 3Ci and UKIB
- Provide direct support to PFER projects in enhancing their understanding of optimum ways to finance their SLES

Objectives

Financial structuring support

- Develop a criteria for project selection and participation and work with Innovate UK to engage with PFER projects across the UK
- Identify at least five PFER projects across the UK which fall into the defined local authority subset which can be used as example cross-sector, place-based portfolios to further our understanding of typical financial structuring needs across different typologies
- Carry out deep-dives with the five or more projects identified across their current detailed design to understand and advise on optimum routes to financing identifying barriers that need to be addressed
- Support the development of financial frameworks for each project identifying optimum funding and finance options

- Work with the SLES Investor Panel and PFER's 'decarbonisation pathway planning optimisation' workstream to share learnings on how SLES projects could best achieve a level of standardisation across them in order to make them easier to evaluate by, and more attractive to, potential investors

Evaluation and insights

- While engaging with PFER projects:
 - assess their needs as a subset of local authorities outside of cities, and consider how and to what extent, their needs differ
 - evaluate how well suited these projects are to integrate with emerging solutions in development
 - consider whether any modification to current thinking should be considered in order to ensure these local authorities can access funding and finance as quickly as possible
- Outline any funding models or routes identified as part of the financial structuring support that could compliment emerging solutions and accelerate this subset of local authorities in their journey to developing and financing their net zero portfolios
- Make recommendations as to whether any funding models/routes could lend themselves to a particular place or type of project which could enable the development of a more diverse set of archetypal local net zero funding solutions
- Consider the delivery mechanisms that would be needed to accommodate these funding models alongside other emerging funding solutions
- Consider what would be required of investors to enable these accelerated pathways and funding models for local authorities
- Create a brief summary setting out key findings on the need for additional funding models suited to local authorities outside of cities including examples and key learnings around potential archetypes and standardisation

Engagement and impact

- Gather evidence from projects to understand the views of those involved, including local authorities, on how they want to finance their projects, and what funding mechanisms they are and are not comfortable with
- Collate this along with wider findings to deliver a list of key recommendations for what action should be taken next by different stakeholders in this space to better understand the needs of local authorities outside of cities and ensure their financing needs are met without delay
- Include recommendations for aligning efforts across existing workstreams including BEIS, 3Ci, UKIB and GFI to achieve a more streamlined approach that can maximise impact and accelerate our understanding of the diverse needs of diverse places in funding net zero with collective momentum

Background to the Requirement

The PFER programme, part of UK Research and Innovation's Industrial Strategy Challenge Fund, began in 2018. It is investing up to £103.8m, matched by industry, to help businesses, researchers and local communities develop, test and prove smart local energy systems. We have invested in 87 projects working with 232 participants to deliver outputs ranging from small feasibility studies to large-scale demonstrators. Our programme portfolio overview (<https://www.ukri.org/publications/smart-local-energy-systems-the-energy-revolution-takes-shape/>) describes our vision, and the aims, locations, funding, and partners of the

projects. Here you will find a full overview of the detailed design projects you will be required to engage with. The earlier projects have already completed and others will cease to be funded at different points during 2022 and early 2023, with all PFER funding ending by March 2023.

For 2022, a primary communication objective for the PFER programme is to tell government, industry, investors and other stakeholders what impacts and learnings are resulting from the projects. Four insights papers are being developed currently and will be published in November, including one on 'Finance and Investment' which brings together key insights and learnings from the projects involved in the programme. Scope

This work must be completed by 31st May 2023 at the latest.

GDPR - There will be no personal data used during this research.

Requirement

- Detailed financial modelling for each project engaged in the work. This should include:
 - *Financial appraisals of any existing models for each specific project*
 - *Analysis of alternative capital sources/instruments that would be better deployed*
 - *Accompanying summaries setting out the funding potential*
 - *Illustrative graphics to visualise the different sources of capital and financial instruments for each project or as archetypal examples*
- Insights report drawing conclusions from across the projects to meet the objectives set out above with key recommendations for Innovate UK, government and local authorities on future action and optimum alignment of workstreams required
- A slide deck of the report for engagement and dissemination activity

The results of the Local Net Zero Investments: Diverse Solutions for Diverse Places work and related materials may be delivered into the public domain at the end of the project, enabling quality assurance and socialising the direction of travel from local stakeholders through to UK government officials.

Approach to Delivery

For the delivery of this work, we expect the successful supplier to;

- Present the final fully designed report and presentation in a manner that is clear, understandable and user friendly. The report should contain an executive summary suitable for non-specialists. Responses that propose a high standard front-end delivery will be scored favourably. Design must comply with UKRI design standards which will be provided.
- Ensure that the outputs can be hosted in a way that UKRI find acceptable as an organisation operating in complex and dynamic stakeholder environment, whilst also best meeting the needs of the local stakeholders and business communities. We expect methodologies, research, data, and recommendations to be made publicly available for at least two years online.

Branding

It is anticipated that the report will be published in the name of the supplier with UKRI being associated as the sponsor.

Target audience

The target audience for this piece of work includes BEIS, PFER, local authorities and other stakeholders involved in local net zero financing at a local and regional level such as 3Ci and UKIB. The successful tenderer must be able to understand and clearly convey how this work integrates with other existing workstreams in this space.

Dissemination

We expect the successful supplier to participate in PFER's conference in February 2023 to highlight project objectives and any initial findings and publish a final report in May 2023. IP Considerations

The successful supplier should describe their approach to IP Management in their bid, including background IP and ability for UK Research and Innovation to share arising IP.

We expect the successful supplier to submit their ED&I policy with their bid or agree to the UKRI ED&I policy.

Sub-Contracting

Given the breadth of the knowledge required, UKRI welcome bids from single/sole suppliers as well as bids made up of multiple partners, or a consortium of suppliers, demonstrating an ability to meet the above requirements. Where subcontractors or additional support is used it is requested that the detail of the budgets and management of these individuals is provided within the supplier's application.

Reporting

The successful supplier will be required to attend a weekly meeting to provide a regular update on the progress of the objectives set out above. This meeting will be held via videoconference.

Timetable

To ensure the projects can be delivered on time, we would expect work to begin as soon as the procurement contract is signed.

All outputs must be delivered by the deadline of 31st May 2023.

Award Evaluation of criteria

Non-Commercial Elements

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

$$\text{Score} = \{\text{weighting percentage}\} \times \{\text{bidder's score}\} = 20\% \times 60 = 12$$

The same logic will be applied to groups of questions which equate to a single evaluation criterion.

The 0-100 score shall be based on (unless otherwise stated within the question):

0	The Question is not answered, or the response is completely unacceptable.
10	Extremely poor response – they have completely missed the point of the question.
20	Very poor response and not wholly acceptable. Requires major revision to the response to make it acceptable. Only partially answers the requirement, with major deficiencies and little relevant detail proposed.
40	Poor response only partially satisfying the question requirements with deficiencies apparent. Some useful evidence provided but response falls well short of expectations. Low probability of being a capable supplier.
60	Response is acceptable but remains basic and could have been expanded upon. Response is sufficient but does not inspire.
80	Good response which describes their capabilities in detail which provides high levels of assurance consistent with a quality provider. The response includes a full description of techniques and measurements currently employed.
100	Response is exceptional and clearly demonstrates they are capable of meeting the requirement. No significant weaknesses noted. The response is compelling in its description of techniques and measurements currently employed, providing full assurance consistent with a quality provider.

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Example

Evaluator 1 scored your bid as 60

Evaluator 2 scored your bid as 60

Evaluator 3 scored your bid as 40

Evaluator 4 scored your bid as 40
Your final score will $(60+60+40+40) \div 4 = 50$

Commercial Elements will be evaluated on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the Commercial criterion.

For example - Bid 1 £100,000 scores 100.

Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80

Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.

Bid 4 £175,000 differential £75,000 remove 75% from price scores 25.

Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.

Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50.

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 $(80/100 \times 50 = 40)$

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

This evaluation criteria will therefore not be subject to any averaging, as this is a mathematical scoring criterion, but will still be subject to a commercial review.

7.4. Freedom of information

- 7.4.1. In accordance with the obligations and duties placed upon public authorities by the Freedom of Information Act 2000 (the 'FoIA') and the Environmental Information Regulations 2004 (the 'EIR') (each as amended from time to time), UK SBS and the Contracting Authority may be required to disclose information submitted by the Bidder to the to the Contracting Authority.

7.8. Preparation of a Response

- 7.8.1. Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. Bidders are solely responsible for all costs, expenses and other liabilities arising in connection with the preparation and submission of their Response and all other stages of the selection and evaluation process. - 7.9.4. Any financial data provided must be submitted in or converted into pounds sterling. Where official documents include financial data in a foreign currency, a sterling equivalent must be provided. Failure to adhere to this requirement will result in the Response not being considered.
- 7.9.5. The Contracting Authority do not accept responsibility for the premature opening or mishandling of Responses that are not submitted in accordance with the instructions of this document.
- 7.9.6. The Response and any documents accompanying it must be in the English language
- 7.9.7. Bidders must submit their response through the e-sourcing tool, unless explicitly requested by the Contracting Authority either in the procurement documents or via a formal clarification from the Contracting Authority. Responses received by any other method than requested will not be considered for the opportunity.
- 7.9.8. Responses will be submitted any time up to the date indicated in [Section 3](#). Responses received before this deadline will be retained in a secure environment, unopened until this deadline has passed.
- 7.9.9. Responses received after the date indicated in [Section 3](#) shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay is solely attributable to the Contracting Authority
- 7.9.9.1. The Bidder must demonstrate irrefutable evidence in writing they have made best endeavours to ensure the Response was received on time and that the issue was beyond their control.
 - 7.9.9.2. Any request for a late Response to be considered must be emailed to the Buyer in [Section 3](#) in advance of 'the deadline' if a bidder believes their Response will be received late.
 - 7.9.9.3. The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.

- 7.9.10. Do not seek changes to the Bid after responses have been submitted and the deadline (date and time) for receipt of responses has passed.

7.10. Canvassing

- 7.10.1. Any Bidder who directly or indirectly canvasses any employee, or agent of UK SBS, the Contracting Authority, or its members or any relevant OPB or any of its employees concerning the establishment of the Contract or who directly or indirectly obtains or attempts to obtain information from any such officer, member, employee, or agent or concerning any other Bidder, Response or proposed Response will be disqualified.

7.11. Disclaimers

- 7.11.1. Whilst the information in this RFP, Due Diligence Information and supporting documents has been prepared in good faith, it does not purport to be comprehensive, nor has it been independently verified.
- 7.11.2. Neither UK SBS, the Contracting Authority, nor any relevant OPB's nor their advisors, nor their respective directors, officers, members, partners, employees, other staff or agents:
- 7.11.2.1. makes any representation or warranty (express or implied) as to the accuracy, reasonableness, or completeness of the RFP; or
 - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3. Any persons considering making a decision to enter into contractual relationships with the Contracting Authority and/or, as applicable, relevant OPB following receipt of the RFP should make their own investigations and their own independent assessment of the Contracting Authority and/or, as applicable, relevant OPB and its requirements for the services and should seek their own professional financial and legal advice.  - 7.12.1.2. communicates to any party other than UK SBS, the Contracting Authority or, as applicable, relevant OPB the amount or approximate amount of its proposed Response or information which would enable the amount or approximate amount to be calculated (except where such disclosure is made in confidence in order to obtain quotations necessary for the preparation of the Response or insurance or any necessary security); or
 - 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or

- 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
- 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,

shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

- 7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within two days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the Jaggaer eSourcing portal unless the Jaggaer eSourcing portal is unavailable due to system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in [Section 3](#).
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the Jaggaer eSourcing portal they should use the contact details defined in [Section 3](#).
- 7.15.4. No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.
- 7.15.5. In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6. Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one

which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:

- 7.15.6.1. invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
 - 7.15.6.2. request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.
- 7.15.7. The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

- 7.16.1. At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the Jaggaer eSourcing portal. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses or any other time prior to accepting the offer of a Contract. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
- 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
- 7.19.1.1. cancel the evaluation process at any stage; and/or
 - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in Find a Tender in accordance with the Regulations within 30 days of the award of the contract.
- 7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.

What makes a good bid – some simple do's 😊

DO:

- 7.21.1. Do comply with Procurement document instructions. Failure to do so may lead to disqualification.
- 7.21.2. Do provide the Bid on time, and in the required format. Remember that the date/time given for a response is the last date that it can be accepted; we are legally bound to disqualify late submissions. Responses received after the date indicated in the RFP shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay, is solely attributable to the Contracting Authority
- 7.21.3. Do ensure you have read all the training materials to utilise e-sourcing tool prior to responding to this Bid. If you send your Bid by email or post it will be rejected.
- 7.21.4. Do use Microsoft Word, PowerPoint Excel 97-03 or compatible formats, or PDF unless agreed in writing by the Buyer. If you use another file format without our written permission, we may reject your Bid.
- 7.21.5. Do ensure you utilise the Jaggaer eSourcing messaging system to raise any clarifications to our RFP. You should note that we will release the answer to the question to all Bidders and where we suspect the question contains confidential information, we may modify the content of the question to protect the anonymity of the Bidder or their proposed solution
- 7.21.6. Do answer the question, it is not enough simply to cross-reference to a 'policy', web page or another part of your Bid, the evaluation team have limited time to assess bids and if they can't find the answer, they can't score it.
- 7.21.7. Do consider who the Contracting Authority is and what they want – a generic answer does not necessarily meet every Contracting Authority's needs.
- 7.21.8. Do reference your documents correctly, specifically where supporting documentation is requested e.g. referencing the question/s they apply to.
- 7.21.9. Do provide clear, concise, and ideally generic contact details; telephone numbers, e-mails and fax details.
- 7.21.10. Do complete all questions in the questionnaire or we may reject your Bid.

7.21.11. Do ensure that the Response and any documents accompanying it are in the English Language, the Contracting Authority reserve the right to disqualify any full or part responses that are not in English.

7.21.12. Do check and recheck your Bid before dispatch.

What makes a good bid – some simple do not's ☹

DO NOT

- 7.22.1. Do not cut and paste from a previous document and forget to change the previous details such as the previous buyer's name.
- 7.22.2. Do not attach 'glossy' brochures that have not been requested, they will not be read unless we have asked for them. Only send what has been requested and only send supplementary information if we have offered the opportunity so to do.
- 7.22.3. Do not share the Procurement documents, they may be confidential and should not be shared with anyone without the Buyers written permission.
- 7.22.4. Do not seek to influence the procurement process by requesting meetings or contacting UK SBS or the Contracting Authority to discuss your Bid. If your Bid requires clarification the Buyer will contact you. All information secured outside of formal Buyer communications shall have no Legal standing or worth and should not be relied upon.
- 7.22.5. Do not contact any UK SBS staff or the Contracting Authority staff without the Buyers written permission or we may reject your Bid.
- 7.22.6. Do not collude to fix or adjust the price or withdraw your Bid with another Party as we will reject your Bid.
- 7.22.7. Do not offer UK SBS or the Contracting Authority staff any inducement or we will reject your Bid.
- 7.22.8. Do not seek changes to the Bid after responses have been submitted and the deadline for Bids to be submitted has passed.
- 7.22.9. Do not cross reference answers to external websites or other parts of your Bid, the cross references and website links will not be considered.
- 7.22.10. Do not exceed word counts, the additional words will not be considered.
- 7.22.11. Do not make your Bid conditional on acceptance of your own Terms of Contract, as your Bid will be rejected.
- 7.22.12. Do not unless explicitly requested by the Contracting Authority either in the procurement documents or via a formal clarification from the Contracting Authority send your response by any way other than via the Jaggaer eSourcing portal. Responses received by any other method than requested will not be considered for the opportunity.
