

RE: Covid-19 Public Sector Fraud Reporting Hotline

We are writing to formally vary the existing contract for 'Covid-19 Public Sector Fraud Reporting Hotline" with your organisation signed on 1st October 2020", Contract reference RM'Covid-19 Public Sector Fraud Reporting Hotline' ("the Contract") on the terms set out in this letter.

Background

The Parties initially Contracted 01/10/2020". However, due to the unforeseen circumstances brought about by the global COVID-19 pandemic which has resulted in the C-19 Intelligence Unit extending through to March 2022. The hotline is essential in the information flow to understand the threat of fraud during Covid-19.

The proposal is to:

- extend the term of Contract by a period of 6 (six) months;
- Increase contract value by £52,500 exclusive of VAT
- provide for the completion of Services as outlined in Annex 1 of the contract dated 01st October 2020 Services and some optional additional Services as outlined

Variation

- 1. The variations are made in accordance with Clause '8 (eight)" of the Contract. With effect from '20th July 2021" the Parties agree to amend the Contract as follows:
 - 1.1 The Contract Period is extended for an additional period of '6 (six)" months, commencing on '01st October 2021" and expiring on '31st March 2022". Accordingly:
 - 1.1.1 The definition of Contract Period is deleted and replaced by the following:

"Contract Period" means the period from the Commencement Date to:

- the date of expiry set out in clause 'X"(Initial Contract Period), or
- following an extension pursuant to clause 'X" (Extension of Initial Contract Period), the date of expiry of the extended period, or
- expiry of the Extended Final Phase as described in Schedule 1 (Statement of Requirements);
- or such earlier date of termination or partial termination of the agreement in accordance with the Law or the provisions of the Contract.

Unless agreed otherwise, all other terms and conditions of the Contract remain unchanged. In this letter, unless stated to the contrary, terms defined in the Contract and used in this letter have the meanings set out in the Contract. The rules of interpretation set out in the Contract shall apply to this letter.

I would be grateful if you can sign one copy of this letter, confirming your acceptance of the variations to the Contract including the extension of the Contract Period and return this within 10 (ten) working

days to me at the above address.
