With reference to the contract dated 02<sup>nd</sup> November 2015, (as most recently amended by the letter dated 30<sup>th</sup> May 2018) both Parties have in principle agreed to the following variations to the Contract:

## Section 1 - Form of Contract

#### 3. Commencement and Duration of Services

**Delete:** "The supplier shall start the services on 1st September 2015 (the "Start Date") and shall complete them by 31st December 2019 (the "End Date") unless this contract is terminated earlier in accordance with its terms and conditions. As per the advertised ITT documentation there may be, at DFID's discretion the opportunity of a 24 month extension period to this contract."

**Insert:** "The supplier shall start the services on 1<sup>st</sup> September 2015 (the "Start Date") and shall complete them by 27<sup>th</sup> February 2021 (the "End Date") unless this contract is terminated earlier in accordance with its terms and conditions. As per the advertised ITT documentation there may be, at DFID's discretion the opportunity of a 24 month extension period to this contract."

# Section 3 - International Citizen Service Terms of Reference for ICS2 Extension #2

## Introduction

- The Department for International Development (DFID) is currently funding phase 2 of the International Citizen Service (ICS) programme, which provides opportunities for young people across the UK and the global south. This programme contributes to development by deploying youth volunteers from the UK and overseas to work with local organisations on poverty reduction projects in developing countries.
- 2. We are currently designing the next phase of the programme, ICS3. ICS3 will build on the successes of ICS2 but bring a range of key changes, including an increased focus on employability, skills and diversity in an innovative and ambitious way to maximise the benefits delivered by the programme.

## The Objective

- 3. DFID ministers would like to avoid a gap in delivery between ICS2 and ICS3. An extension of ICS2 has already been agreed from February 2019 to December 2019 to the value of £15 million. The extension proposed here will cover a gap in delivery between the previous ICS2 extension and the start of ICS3.
- 4. ICS2 extension 2 will continue the same objectives, recipient, scope, methodology, reporting and outputs, timing, performance requirements, duty of care and safeguard considerations, transparency and delivery chain mapping, and as procurement and contractual obligations as the ICS2 extension 1 and the original contract before it, apart from the stipulations noted below.
- 5. In terms of scope, whilst the original contract delivered up to 7,000 volunteers per year, and the previous extension delivered 3,000 volunteers over 10 months to the value of £15 million, this extension will deliver volunteer placements (50% UK, 50% developing countries) at the same rate as the extension (REDACTED per annum pro rata), but over a flexible period up to a maximum of 14 months.
- 6. This extension will not extend beyond the end of February 2021, in line with the 24-month maximum extension set out in the original ICS2 contract
- 7. Under the terms of this flexible extension, DFID reserves the right to wind down the extension should ICS3 be ready to launch prior to February 2021. The table below gives an indication of the key break points in the extension. Following notification of a break in the extension contract, the supplier will have 3 months to wind down activities for a transition to ICS3 including a possible handover to any new supplier(s).

## Proposed break points:

September 2020	ICS3 ready to launch	Notice of a break will only be served when all volunteers from Summer cycle have returned  3-month wind down until November 2019

8. The price point for this flexible extension will remain the same as the current extension, unless VSO can fully substantiate either i) any increase through added value or ii) any decrease through efficiencies. Any such exception for a specific area (or areas) will be agreed between VSO, the Children Youth and Education Department and PCD.

# **Constraints and dependencies**

- The successful delivery of this extension is contingent on suitable numbers of high-quality volunteers applying for placements, and suitable numbers of sustainable and safe projects in communities overseas being identified, riskassessed and delivered.
- 10. Providing an appropriate number of sustainable, safe projects is partially dependent on political stability and attitudes towards civil society in-country, which can change significantly in a short space of time. Given the number of volunteer placements being supported under this extension, the Provider should be able to flex volunteer placement locations to ensure volunteer numbers can still be met even if projects in certain countries become non-viable for a period of time.

## **Exit Management**

- 11. In accordance with DFID Standard Condition 16, both DFID and VSO will work collaboratively to facilitate the wind down/closure of ICS2 activities and ensure a smooth transition to any new ICS3 requirement, whether this is with the incumbent (VSO) or any other new supplier.
- 12. VSO are therefore required to revise and resubmit their "Exit Management Plan" for further consideration/agreement with DFID, within six weeks of formal issue of Amendment #2. This should take cognisance of the following scenarios:

Scenario 1: ICS3 awarded to Incumbent supplier (VSO) Scenario 2: ICS3 awarded to new supplier July/Aug
