8	<p>Experience - Specialist Lot 5 (if applicable)</p> <p>Three or more years of working as a heritage specialist.</p> <p>The following criteria is desirable and will be used to rank tenders:</p> <ul style="list-style-type: none"> · A recognised qualification in historic environment conservation; · Evidence of continuous professional development in historic environment conservation; · Full/associate membership of the Institute of Historic Building Conservation; 		
9	<p>Experience - Specialist Lot 6 (if applicable)</p> <p>Five or more years' experience of undertaking visual tree assessments and making and writing management recommendations.</p> <p>The following criteria is desirable and will be used to rank tenders:</p> <ul style="list-style-type: none"> · Membership of the Arboricultural Association, Technician or above. · Evidence of continuous professional development in arboriculture.
