Glossary

Unless the context otherwise requires, the following words and expressions used within this Request for Quotation shall have the following meanings (to be interpreted in the singular or plural as the context requires):

"Authority"	Means the Department for Environment, Food and Rural Affairs acting as part of Natural England
"RFQ"	Means this Request for Quotation and all related documents published by the Authority and made available to suppliers
"Contract"	Means the contract to be entered into by the Authority and the successful supplier.

Conditions applying to the RFQ

You should examine your response to the RFQ and related documents ensuring it is complete prior to submitting your completed quotation.

Your quotation must contain sufficient information to enable the Authority to evaluate it fairly and effectively. You should ensure that you have prepared your quotation fully and accurately and that prices quoted are arithmetically correct for the units stated.

The supplier by submitting a quotation is deemed to accept the terms and conditions in the RFQ. Failure to comply with the instructions set out in the RTQ may result in the supplier's exclusion from this procurement.

Specification

The Authority is Natural England. The Authority's priorities are to secure a healthy natural environment; a sustainable, low-carbon economy; a thriving farming sector and a sustainable, healthy and secure food supply. Further information about the Authority can be found at: Natural England

Lathkill Dale forms part of the Derbyshire Dales National Nature Reserve (NNR) and is managed by Natural England, the UK Governments adviser for the natural environment in England. NNRs are designated to offer the best examples of England's wildlife, habitats and geology. They are the 'jewels in the crown' of England's biodiversity and as such they are managed to an exemplar standard.

In addition to the sites NNR status it is further designated as a, Special Area of Conservation (SAC), Site of Special Scientific Interest (SSSI) and also has areas and features covered by Scheduled Ancient Monument (SAM) status.

To achieve the objectives of optimising conditions for a healthy woodland canopy, the project requires the assistance of suitably skilled operatives to undertake tree felling operations between **16 January 2023 and 3 March 2023** across a number of woodland areas, within the Derbyshire Dales NNR. Operatives will be working in circular coupes of .25 ha (approx. 56m diameter.) Operatives will have experience of felling infected Ash trees and will be able to produce appropriate risk assessments which all operatives will adhere to.

All construction contractors engaged by NE should hold a valid Safety Schemes In Procurement (SSIP) certificate in the correct trade and scope. All other contractors should be able to demonstrate a H&S system to the equivalent of SSIP certification

If an SSIP is not held by the contractor then the contractor must complete a Natural England Contractor Competence Questionnaire which is then assessed by the representative of Natural England who is engaging the contractor. see Annex 2

A site visit before quoting is essential for those that don't have experience of the site conditions

Prior to the contract starting, a site induction will be held between the contractor and Natural England to agree all control measures are in place as detailed on the contractor site induction checklist- Annex 3

Guiding principles for the tree felling operations can be found in Annex 1.

All operations are to be compliant with the following LIFE in the Ravines biosecurity requirements. The operations on this site will be classed as a **low-risk activity** so require the following measures:

- Wear footwear and outerwear that can easily be kept clean.
- Clean footwear and outerwear regularly; ensure they are visually free from soil and organic debris.
- Clean vehicles regularly; do not let mud and organic debris accumulate on tyres, wheels or under wheel arches.
- Restrict the equipment taken onto a site take only what you need for the task.
- Ensure all tools and equipment are clean, serviceable and free from organic debris.
- Do not bring foreign plant material (eg wood chip, brash) onto site as a vehicle load or unclean vehicle.

• Use of an appropriate cleaning agent is recommended i.e Cleankill.

It is anticipated that this contract will be awarded for a period to end no later than 3 March 2023. Prices will remain fixed for the duration of the contract award period. We may at our sole discretion extend this contract to include related or further work. Any extension shall be agreed in advance of any work commencing and may be subject to further competition.

Prices

Quotations must include the **day rate per person** for undertaking the above works over a duration of up to 48 days of work between 16nd January and 3 March 2023. The day rate is to include all expenses, equipment, and insurances and please indicate whether prices include VAT.

Prices must be submitted in £ sterling and please indicate whether they include VAT.

Quotation Submission

When submitting a quotation, suppliers must:

- A completed Supplier Form (Annex 4), to avoid delays issuing a Purchase Order on award of the contract.
- Provide evidence to demonstrate current and adequate *Public liability Insurance* to cover the scope of the operations (see link within 'Conditions of Contract' for more information).
- Where applicable provide evidence to demonstrate current and adequate *Employers* Liability Insurance to cover the scope of the operations.
- Provide assurance, and evidence should the contract be awarded, of operators holding a valid Emergency First Aid +F qualification.
- Provide assurance, and evidence should the contract be awarded, that chainsaw operators who will undertake operations are trained (and either attended a refresher chainsaw course or upskilled within the last 5 years) to a minimum of:

City & Guilds NPTC certification / qualification in - *Chainsaw maintenance* requires <u>CS30</u> or NPTC Level 2 'Award in Chainsaw Maintenance' (002001).

City & Guilds NPTC certification / qualification in - *Felling and processing trees under Ø* **380mm** requires <u>CS31</u> or '*Felling and Processing Trees up to 380mm*' (002004).

 Should the contract be awarded, suppliers must supply a risk assessment to cover the operation and site-specific hazards prior to commencing work.

We will award the contract in line with the most economically advantageous tender (MEAT) for each area as set out in the following award criteria:

By issuing this RFQ the Authority does not bind itself to accept any quotation and reserves the right not to award a contract to any supplier who submits a quotation.

Costs

The Authority will not reimburse you for any costs and expenses which you incur preparing and submitting your quotation, even if the Authority amends or terminates the procurement process.

Mandatory Requirements

The RFQ includes mandatory requirements and, if you do not comply with them, your quotation will not be evaluated.

Clarifications

The Authority reserves the right to discuss, confidentially, any aspect of your quotation with you prior to any award of Contract to clarify matters.

Amendments

The Authority may amend the RFQ at any time prior to the deadline for receipt. If it amends the RFQ the Authority will notify you in writing and may extend the deadline for receipt in order to give you a reasonable time in which to take the amendment into account.

We will raise purchase orders to cover the cost of the services and will issue to the awarded supplier following contract award.

Annex 1 – Guiding principles for tree felling

Thinning and Clearance

This work is targeted at stands of ash which have been categorised as being at the highest risk from ADB and it is expected that these areas will suffer the heaviest levels of mortality, losing their ash canopy at the quickest rate.

Through targeted species and stem selection (see table below) the objective for felling is twofold; firstly to clear adequate space on the ground to allow underplanting (at a minimum of 1,100 stems per hectare (SPH), and secondly to thin the over-storey and canopy to allow sufficient light for regeneration whilst maintaining adequate canopy cover to control 'woodland conditions'. However, on this second consideration it is worth noting that following a conventional thinning intervention the canopy would eventually reclose. However, with ash dominated stands affected by ADB the canopy will likely continue to self-thin and open due to ongoing tree mortality and decline; therefore a more cautious approach to conventional thinning is required and trees 'normally' considered sub-optimal specimens may need to be retained in order to preserve some assemblage of an overstorey and canopy cover in the short term.

Coupes identified for thinning and clearance are 0.25 hectare in size and marked out (plan view) in a circular shape (approx. 56m diameter)

D – Cut material should be stacked horizontal to the slope, in as small piles as practicable (between 1m and 3m depending on where they are stacked) and within areas which are least suitable for planting e.g. directly beneath larger crowned trees. Stacks should aim to maximise the amount of planting ground available, maintain access for the planting operations and be left in a safe and stable condition. A perimeter 'dead hedge' may be created just outside the coupe using brash arisings.

Where it is safe to so and does not excessively occupy suitable planting ground, felled timber >20cm diameter may be left in whole length as a snedded pole, however it must also be left in a safe and stable condition eg pinned behind stumps to prevent sliding or rolling downhill, or the hinge still attached.

Do not stack cut material on Spurge Laurel

E – Stumps should cut flat and as low as is practicable to ground level. Small diameter stumps cut at an angle with 'spear cuts' pose a puncture wound hazard for anyone falling on them so must be avoided!

F-Chainsaws must be run on biodegradable chain oil.

G-Generally no stump treatment with pesticide is required unless specifically specified (e.g 13).
