CONTRACT FOR: Zimbabwe – Livelihoods and Food Security Programme Markets Development Component

CONTRACT NUMBER: PO6527

With reference to the contractual letter dated 30th July 2014 (as most recently amended by the letter dated 02nd August 2017) whereby your firm was engaged to carry out the Terms of Reference as set out at Annex A of the contract, I confirm that the UK Government wishes to make the following further amendments to the letter of 30th July 2014:

Section 1, Para 3 – Commencement and Duration of the Services

Delete: The supplier shall start the services no later than 01st October 2014 (“the Start Date”) and shall complete them by 28th August 2017 (“the End Date”) unless the Call-Down contract is terminated earlier in accordance with the Terms and Conditions of the Framework Agreement.

Insert: The supplier shall start the services no later than 01st October 2014 (“the Start Date”) and shall complete them by 30th September 2017 (“the End Date”) unless the Call-Down contract is terminated earlier in accordance with the Terms and Conditions of the Framework Agreement.

2. This amendment relates to a further short term “Nil Cost” one month extension of time only, to provide contractual cover while the proposed twelve month extension is reviewed by Ministers, in accordance with the PO6527 Terms and Conditions. Any subsequent progression to the twelve month extension period is dependent upon supplier performance, continued demonstration of VfM and the requisite DFID approval processes. If the submission is not approved by SoS, associated staffing costs incurred for the interim period may be reconciled with identified programme underspend, any such costs will be fully substantiated and approved by the Programme Team accordingly. All other Terms and Conditions of this contract remain unchanged.

3. Please confirm in writing by signing and returning one copy of this letter, within 15 working days of the date of signature on behalf of DFID, that you accept the amendment set out herein.

4. Please note the provision in the contractual letter, that the financial limit of the UK Government's liability to the Supplier under this engagement shall not exceed the sum specified, unless the amount of any such excess has been agreed by the Department for International Development in writing before the Supplier takes any action which might result in the financial limit being exceeded.
