Reason for Change	<p>In February 2023 a combination of DIT and some parts of the former BEIS merged to become Department for Business and Trade (MOG). This meant that there was a greater departmental spend and headcount than originally been envisioned when CR _2081 was signed in September 2022.</p>



	<p>Most of the overspending has occurred over the past 9 months delivering MOG such as:</p> <ul style="list-style-type: none">• Changes to our current systems.• moving Microsoft dynamics ex base into DIT environment.• Rebranding to DBT,• supporting onboarding (training and UR for 1800 new users).• providing backfill resources for other teams to complete similar work.• Data Commitments to the MOG changes. <p>The above changes contributed to 50% of the initial contract cost.</p>
