## Accession Agreement

THIS ACCESSION AGREEMENT is made on

19<sup>th</sup> June 2018

### BETWEEN:

- (1) **The Secretary of State for the Environment, Food and Rural Affairs** whose principal place of business is at [REDACTED] acting as part of the Crown (the "Authority"); and
- (2) **ATOS IT Services UK Limited** a company registered in England and Wales under company no 01245534 whose registered company is at [REDACTED] (the **Hosting and Application Support Supplier**);

## 1 Background

- 1.1 On 17<sup>th</sup> October 2017, the Authority entered into a Collaboration Agreement with a supplier (the "Collaboration Agreement", as such may be amended from time to time).
- 1.2 The Authority and the Hosting and Application Support Supplier have agreed that the Hosting and Application Support Supplier shall become a party to the Collaboration Agreement as a Supplier.

## 2 Accession

- 2.1 The Authority agrees that, in entering into this Accession Agreement, the Hosting and Application Support Supplier shall become a Supplier under the Collaboration Agreement in accordance with Clause 2.1 of that agreement.
- 2.2 The Hosting and Application Support Supplier agrees that, in entering into this Accession Agreement, it will have all of the rights and obligations of a Supplier under the Collaboration Agreement in accordance with Clause 2.2 of that agreement.

## 3 Notices
