Award of contract for the Provision of Procurement for LinkedIn Licences

 - 1.2. The charges for the Goods and Services shall be as set out in Annex 2. The total contract value shall be £18,850.00 excluding VAT and any extension option. In the event the Contracting Authority wishes to take up a 12 month contract extension, it will approach the Supplier for updated pricing at that time. The Contracting Authority expects the year two pricing to be not significantly less advantageous than the year one pricing.
 - 1.3. The specification of the Goods and Services to be supplied is as set out in Annex 3 and within the Supplier's response at Annex 4]. Where there is conflict Annex 3 shall take precedence.
 - 1.4. The Date of Delivery shall be Friday 5/3/2021
 - 1.5. The Term shall commence on Friday 5/3/2021 (the "Start Date") and the Expiry Date shall be Friday 4/3/2022 on which the contract will end unless extended or subject to early termination. The Customer reserves the option to extend the contract by 1 period of 1 year.
