Re: Award of Contract Variation for Evaluation of Social Action and Carers Fund

Crown Commercial Service are writing to inform you of Cabinet Office's intention to vary the existing contract for evaluation of social action and carers fund with your organisation, contract reference RM4129 L0495. This contract was originally varied 09 March 2015, and this letter further varies the contract. The conditions of this variation are:

- The contract end date is now 01/06/2016
- The contract will be extended to include the survey extensions and project management fees
 plus a combination of other options to be agreed between TSIP and Cabinet Office following
 discussion with providers, up to a maximum value of £104,415 excl. VAT
- The payment tranches will now be structured as follows (prices excl. VAT):
 - Tranche 1, October to December 2014: **REDACTED**Participation in interview panel; set up of processes for evaluation
 - Tranche 2, January to March 2015: REDACTED
 Received first set of baseline data from grantees (excl. Westbank)
 - Tranche 3, April to June 2015: REDACTED
 Received all baseline data from grantees (incl. Westbank)
 - Tranche 4, July to October: **REDACTED**
 - Delivery of interim report
 - Tranche 5, November to December 2015: REDACTED
 Receive first set of transition data and plans for qualitative work
 - Tranche 6, January to March 2016: REDACTED Receive all transition data and qualitative work.
 - Tranche 7: April to June 2016: REDACTED Delivery of full report
- British Red Cross, Parkinson's UK and Age UK Buckinghamshire will be evaluated between January 2015 and the end of November 2015.
- Carers Trust Cambridgeshire, Westbank, Thirsk and Shared Lives will now be evaluated between January 2015 and March 2016.







- British Red Cross, Parkinson's UK and Age UK Buckinghamshire will use a pre and post design
 without a control group. Carers Trust Cambridgeshire, Thirsk, and Shared Lives will also use a
 pre and post design without a control group. In addition TSIP will undertake qualitative process
 evaluation with these grantees. The provider will implement a wait-list randomised control trial
 until November 2015 after which point they will undertake qualitative process evaluation with this
 grantee.
- The provider is now required to produce a final report by 1st June 2016.

All other terms and conditions of the contract remain unchanged.
