PROJECT INFORMATION

PROJECT DESCRIPTION

NHS Kirklees Clinical Commissioning Group (CCG) wishes to appoint a consultant to produce a Primary Care Network (PCN) estate strategy for the 5 PCNs across the Greater Huddersfield area.

The final deliverable arising from the programme of work will support understanding of the current GP practice estate provision within its boundary, the capacity and utilisation rates and the overall condition of the buildings.

The PCNs have a need to understand the suitability of the estate to accommodate an expanding primary care workforce and the delivery of enhanced community services. The PCNs must plan for the sustainability of the current estate in the future and therefore the reviews should consider the durability of the estate across the short, medium and long term.

The PCN estates strategy will need to be evidenced based, referenced and specific wherever possible. It will highlight where the gaps are in the clinical offering – what does the clinical need / demand look like now and future trends versus the clinical resource availability (skills, capacity, profile, numbers, location etc).

The appointed consultants will have to effectively engage with local primary care to co-produce an effective and robust estates strategy, which documents patient needs and clinical resource understanding and profiling to avoid the risk of developing under-utilised / redundant spaces.

PURPOSE

The purpose of this work is to support the PCNs optimise use of the existing GP estate in the delivery of high-quality primary care and collaborative service model (community-hub type) arrangements.

The strategy will support investment decisions and ensure the primary care estate is in a alignment with emerging wider health and care service models that meet the needs of the local population.

SPECIFICATION AND REQUIREMENTS

The CCG requires the production of a single coherent strategy document covering all 5 PCNs but containing 3 sub-sections which outline the specific considerations associated with the following:

- 1. Greenwood Network, Tolson Care Partnership and The Viaduct Care Network
- 2. The Valleys Health and Social Care Network
- 3. The Mast Primary Care Network

The approach used will reflect learning from PCN estates strategy development currently underway in the North Kirklees area of the CCG and the work will also utilise information gleaned from the National Primary Care Data Gathering Exercise, and data obtainable via the SHAPE (Strategic Health Asset Planning and Evaluation) tool, to minimise the requirement for additional data collection from individual GP practices.

The appointed team is expected to undertake the following activities:

- Preparing, arranging and chairing of stakeholder engagement meetings and ongoing project meetings as required
- A comprehensive review of the current estate, its condition and utilisation rates
- Liaison with the West Yorkshire & Harrogate Integrated Care System (ICS) Population Health Analytics to confirm population needs analysis
- Collection of additional GP Premises data (elements of 6 facet survey) to be confirmed by CCG
- Identification of any existing issues and physical condition of the buildings
- Identification of the potential impact of the PCN Additional Roles and an expanding primary care workforce on the current estate provision
- Solution-finding in respect of improving utilisation of existing estate, delivering better services and identifying aspects of the GP estate that require improvement or disposal
- Assess the local and national priorities including working at scale, Local Authority priorities and PCN population health priorities and align these with the suitability of the current estate
- Identify future development needs to support the sustainability of the PCN's primary care estate
- Incorporate findings, recommendations and key considerations from the previously commissioned Huddersfield Town Centre Feasibility Study report
- Identification of opportunities to improve the current estate
- Identification of opportunities to co-locate services
- Impact of any potential disposals
- A site search for local development land and/or buildings, including indicative costs where possible, for the provision of existing and new services
- Assemble appropriate data for any land or buildings identified including ownership, mortgage debt, property condition and access
- Ensure that all presented opportunities maximise the use of existing estate and where future development is proposed, to assess value for money
- Presentation of short, medium and longer-term challenges and solutions to the primary care estate

TARGET AUDIENCE

The reports are to be prepared for the PCN clinical directors, member GP practices within the PCNs and NHS Kirklees CCG.

The reports will be shared with partners including NHS England and NHS Improvement, Kirklees Council, local NHS Trusts, Kirklees Strategic Estates Group, West Yorkshire and Harrogate ICS and other bodies as appropriate.
