# CH Framework Agreement Schedule 4.2 (Commercially Sensitive Information)

#### 1. Introduction

- 1.1 Without prejudice to the Framework Authority's general obligation of confidentiality, the Parties acknowledge that the Framework Authority may have to disclose Information in or relating to this Framework Agreement or any Call-Off Agreement following a Request for Information pursuant to Clause 22 (Freedom of Information) of the Framework Agreement.
- 1.2 In this Schedule the Supplier has sought to identify Confidential Information of the Supplier that it considers falls within one of the exemptions available to the Framework Authority under FOIA, e.g. Confidential Information that the Supplier considers to be genuinely commercially sensitive and the disclosure of which it considers would be contrary to the public interest.
- 1.3 Where possible, the Supplier has sought to identify under the heading "Review Date" when it considers that any relevant Information will cease to fall into the category of Information to which this Schedule applies.
- 1.4 Without prejudice to the Framework Authority's obligation to disclose Information in accordance with FOIA, the Framework Authority may, in its sole discretion, seek to apply the relevant exemption under FOIA which the Supplier requests should apply to the relevant Designated Information.
