- Inserting key descriptive text in the main body of the report. Specifically, this text should highlight and integrate the analysis related to the views and experiences of:
  - a) medical practitioner respondents and
  - b) organisations representing medical practitioners

- conducting additional analysis for all consultation questions specifically for respondents who self-identified as medical practitioners). This includes qualitative and quantitative analysis.

### *Organisations representing medical practitioners*

- analysing the qualitative responses submitted by organisations representing medical practitioners

## **Component 3: Providing materials**


- Providing the Cabinet Office with the final dataset and code for analysis.
- The final dataset will be presented to GEO as a .csv file, or a format equally easy to interrogate. We would like the Supplier to provide any code they have used for the qualitative and quantitative analysis from the software *R studio*. As previously, this

can either be sent to the Equality Hub directly or placed on the software development site Github. Com (to be agreed).


### **Duration and Value**
