# 1.1 Site boundary, extents and access arrangements

#### 1.3 Drainage

A small watercourse feeds into a reservoir at the bottom of a steep embankment of the A40 eastbound. The reservoir discharges water via a spillway and a pipe, which then leads into the old stone culvert. The culvert runs under the A40.

# 1.4 Geotechnical

The A40 is on an embankment, the road embankment toe and general area has suffered scour damaged. The slopes are 7m high and has a formation of made ground, Greyish brown gravelly fine to coarse sand.

# 1.5 Soft Estate and Environment

The full site extent consists of soft estate. The environment constraints are to be confirmed by the SWDSC Environmental Team.

# 1.6 Traffic Signs, Road Markings

The A40 road has traffic signs and road markings.

# 1.7 Lighting

There is no street lighting on the A40 along the scheme extents.

# 1.8 Structures and Buildings

There is an old drinking water reservoir, spillway and a culvert within the scheme extent. There are a couple of houses on the westbound of the A40. Huntley village is to the east

Typical technology assets associated with traffic counting and CCTV cameras are anticipated be within the scheme extents.

# 1.11 Statutory Undertakers

The C2 STATS have been obtained and enclosed with the PCI to assist the Contractor to identify existing services using a QL-B1 utility detection survey and other techniques before digging.
