Preamble

WHEREAS, Seller is prepared to sell and deliver such units of Disposable PE Apron (Non-Medical Use) to the Buyer according to the terms and conditions set forth in this Supply Contract.

NOW THEREFORE, in consideration of the promises and the mutual covenants contained herein, Seller and Buyer agree as follows:

Article 1 - Definition

1.1 "Products" shall mean Disposable Polythene Apron (White,1170x686mm,16µ) produced by

Article 2 - Scope of the Contract

2.1 Seller hereby sells to Buyer and Buyer hereby purchases from Seller Products according to the terms and conditions of this Supply Contract.

Article 5 - Deliveries

- 5.1 Seller shall handover the Products EXW (Incoterms 2020) (see Article 3.3) at factory addresses listed in Appendix 3. .
- 5.2 All Products supplied shall be properly packed and secured in Export Standard Carton Case in good condition and shall be handed over to the logistic company designated by the Buyer within 2 calendar days upon receipt of Telegraphic Transfer from the Buyer.
- 5.3 Partial-deliveries are as agreed by both Parties (see Appendix 3 Shipping details).
- 5.4 Shipping Mode: to be agreed and arranged by the buyer
- 5.5 Port of Shipment: China Main Port, (Qingdao Port, Xiamen Port)
- 5.6 Port of Destination: London, United Kingdom
- 5.7 Shipping Marks: As agreed by both Parties
- 5.8 Delivery Schedule: Refer to the Shipping Details (Appendix 3) of This Contract.
- 5.9 Delayed Delivery: Should the Seller fail to deliver the products as scheduled (see Article 5.8), the Buyer shall be entitled to a 0.05% of the delayed delivery value for each calendar day of delay as liquidated damages, but these damages shall not exceed 5% of the delayed delivery value.
- 5.10 Failure to Deliver: Unless an extension of time has been agreed by the Buyer, the Seller's failure to effect delivery Products 7 calendar days after the dates specified in Article 5.8 shall entitle the Buyer to terminate the Contract. Upon termination of the Contract due to delay of delivery, the Seller shall pay 5% (see Article 5.9) of the delayed delivery value to the Buyer as compensation and return the value of undelivered products to the Buyer within 2 calendar days unconditionally (Article 9.1).

5.11 The Seller shall take full responsibility on documentations required for customs clearance in China,. The Seller shall assist on customs clearance. The Buyer reserves the right to terminate the Contract if the Products fail to clear customs in China and will receive a refund of undelivered value from the Seller unconditionally. (See Article 9.1),

6.2 The Seller shall not without the prior written consent of the Buyer change the Sub-supplier listed in Article 6.1. If, due to unforeseen reasons, the replacement is requested by the Seller, the Seller shall inform the Buyer via email as soon as possible. The Seller shall be liable to provide the Buyer with updated sub-order and product specification and shall ensure that the products provided by the replaced Sub-supplier are of the same quality standard and the agreed delivery schedule remains unchanged. Should the updated product specification fails to meet the Buyer's requirements, the Buyer shall reserve the right to terminate the Contract.

Article 7 – Quality and Warranty

7.1 All Products supplied by the Seller shall be fit for purpose for the Warranty Period and shall be supplied strictly in accordance with the quantities, specifications and stipulations contained in the Contract and its appendixes. The Seller warrants that the products are consistent with existing laws, regulations, policies, and national quality standards in P.R.China. Where any other detailed technical requirements are concerned, the Buyer shall explicitly stipulate such requirements in this Contract and its appendixes.

7.2 Warranty Period: 24 months

7.3 Inspection and Acceptance

Upon the products' arrival at the port of destination, the Buyer shall inspect and accept such products. If the quality of products is found not to be in conformity with the stipulations of the Contract, the Buyer shall notify the Seller of such discrepancies within 30 calendar days as of the arrival date of the products. Where the craftsmanship of the products is sufficiently evidenced defective, the Buyer shall be entitled to claim a replacement. All the costs, expenses and losses resulting from providing the replacement shall be borne by the Seller. Other damages or deficiencies caused not by the production process, but by the transportation process is not taken by the Seller.

Article 8 - Force Majeure

- 8.1 Should any cases happen and prevent either Party from performing the Contract, such as war, serious fire, typhoon, earthquake, floods, plagues, riots, strikes and other cases which could not be foreseen, controlled, avoided and overcome, the Party concerned shall inform the other Party by E-mail/fax and send by express a certificate issued by competent authority concerning confirmation of the Force Majeure within fourteen (14) calendar days following the occurrence of the case of Force Majeure.
- 8.2 The Party concerned shall not be responsible for any delay or failure in performing any or all of the obligation due to the event of Force Majeure. However, the Party concerned shall inform the other Party by /E-mail/fax the termination or elimination of the case of Force Majeure as soon as possible.
- 8.3 The Parties shall proceed with their obligations immediately after the date when the case of Force Majeure has ceased or the effects have been removed. The performance of those obligations shall be extended by a period equal to the effect of such cases. Should the effect of the Force Majeure mentioned above last for more than one hundred and eighty (180) calendar days, either Party shall have the right to terminate the Contract.

Article 9 - Breach of Contract

9.1 Both Parties shall perform according to the Contract. If either Party breaches the contract other than reasons covered by Article 5.9, it shall compensate the other Party for 100% of the undelivered contract amount. If any dispute or negotiation fails to be settled, it shall bring a lawsuit to in accordance with Article 11.1

Article 10 - Termination of Contract

10.1 In mutually agreed 27 week period from contract signature, the Seller has no right to terminate the Contract if the Buyer makes the payment on time. Seller to retain the right to cancel the contract should the buyer request any variation(s) not mutually agreed with the Seller.

Article 11 - Arbitration

11.1 All disputes arising out of or in connection with this Contract including any question regarding its existence, validity or termination, which cannot be settled in due time by the Parties, shall be finally settled by The London Court of International Arbitration ("LCIA") under its rules ("Rules") by three arbitrators appointed in accordance with the said Rules. The arbitration award shall be final and respected by the Parties.

Article 12 - Governing Law

12.1 The Contract shall be governed by and constructed in accordance with English Law. If the Contract terms are inconsistent with the Incoterms selected by both Parties, the Contract terms shall prevail.

Article 13 - Miscellaneous

- 13.1 In the event of a conflict, this English Contract shall prevail.
- 13.2 The Seller has capability to receive dollars into their providing bank account (see Article 4.2). The Buyer do not need to provide anything for the Seller's foreign currency collection into their bank account. The Seller will handle by themselves.
- 13.3 The calendar days or working days in this Contract refers to the UK time (GMT+0).

13.4 This Contract shall come into force from the date of signature of this Contract by the Parties. The scanned Contract and the original Contract are equally authentic. This Contract has two originals. The Buyer and the Seller shall each holds one.
