Section 4 – Specification and about this procurement

1. Introduction

UKRI is the UK's largest public funder of research and innovation and brings together Research England, Innovate UK and the seven disciplinary research councils, of which NERC is one.

NERC - the Natural Environment Research Council - is the driving force of investment in environmental science in the UK. NERC advances the frontier of environmental science by commissioning new research, infrastructure and training that delivers valuable scientific breakthroughs. We do this because understanding our changing planet is vital for our wellbeing and economic prosperity.

We invest public money in world-leading science, designed to help us sustain and benefit from our natural resources, predict and respond to natural hazards and understand environmental change. We work closely with policymakers and industry to make sure our knowledge can support sustainable economic growth and wellbeing in the UK and around the world.

ECOWind is co-funded by The Crown Estate who manage a portfolio of property, rural and marine holdings with the sole purpose of creating lasting and shared prosperity for the nation. In addition to its role in the offshore renewables sector, as manager of the seabed and half the foreshore around England, Wales and Northern Ireland, it also plays a role marine aggregates, cables and pipelines; working to create holistic value that balances economic, environmental and social considerations.

2. Aims

The UK is committed to delivering net zero through significant expansion of offshore wind and to achieving Good Environmental Status (GES) for UK seas across the 60 GES indicators¹. Understanding ecosystem responses to the cumulative pressures of large-scale deployment of offshore wind, in combination with other anthropogenic and climate stressors, and how this will influence progress towards GES, requires new scientific approaches, which advance our understanding of the dynamics of marine ecosystems.

NERC and The Crown Estate are co-funding the Ecological Consequences of Offshore Wind research programme (ECOWind), which has a £7m budget to fund projects that will enhance understanding of the ecological consequences of the planned expansion of offshore wind in the context of increasing pressures on UK marine ecosystems and provide evidence to inform marine policy and management.

The ECOWind Champion role will be delivered by an individual or organisation who may, or may not, propose delegating some of the more technical aspects of the role to other members of a Champion team. The appointed Champion will be critical for the successful day to day management and leadership of the ECOWind programme, working closely with the programme funders to ensure it achieves its full potential, all commissioning and delivery risks are managed appropriately, and all stakeholders are engaged effectively. In so doing

the Champion will also ensure there is effective integration with ongoing research and evidence-building initiatives inside and outside government across the UK (e.g. the wider Offshore Wind Evidence and Change² (OWEC) Programme and other initiatives such as Offshore Wind Enabling Actions Programme (OWEAP)) to avoid duplication and maximise added value to the UK through strong alignment and partnership.

3. Objectives

Objectives for the Champion are, in no particular order, to:

1. Support programme management (including project monitoring, programme reporting, organisation of meetings and workshops and risk management).
2. Manage integration between projects within the research programme
3. Lead on ensuring all risks are identified and are well managed during the commissioning and delivery of the programme.
4. Manage integration and interface between the ECOWind programme and the wider OWEC Programme.
5. Co-ordinate with other government initiatives focusing on policy development and delivery, such as Defra's Offshore Wind Enabling Actions Programme (including Marine Management Organisation (MMO), Natural England, Joint Nature Conservation Committee (JNCC)).
6. Co-ordinate with industry initiatives and activities to address government's policy objectives and regulatory regimes.

4. Background to the Requirement

The UK commitment to reach net zero greenhouse gas emissions by 2050 was strengthened in 2020 with ambitious new targets for at least 68% reduction in greenhouse gas emissions by 2030 (from 1990 levels). To help meet this target, the Government has committed to 40 GW of new offshore wind electricity generation by 2030, representing a fourfold expansion (from 2020 levels) of infrastructure deployment in UK waters. Commitments to net zero are made in the Industrial Strategy, the Clean Growth Strategy and the Offshore Wind Sector Deal, and are being advanced through The Crown Estate's recently awarded Round 4 leasing process for offshore wind, with future leasing rounds anticipated.

Alongside the large-scale expansion of offshore wind to meet Net Zero targets, other significant government commitments relevant to marine systems must be addressed, including biodiversity protection, achieving net environmental gain and restoration, and sustainable fisheries, as set out in the UK Government's 25 Year Environment Plan. However, despite advances in the strategic coordination and management of marine activities, the extent to which large-scale offshore wind deployment in UK seas influences success with other policy objectives is poorly understood. Consequently, there is an urgent need for cutting edge research that takes advantage of innovative technologies to better understand the functioning of the UK marine ecosystems within which large-scale offshore wind deployment is situated, in order to develop policy and management solutions to address commitments to net zero, other anthropogenic activities (e.g. oil and gas,

aquaculture, and fishing), and emerging policy areas (net gain and environmental restoration).

The ECOWind research programme will address a critical gap in understanding how marine ecosystems will respond to the planned large-scale expansion of UK offshore wind infrastructure, and will provide evidence to inform marine policy and management of increasing pressures on UK marine ecosystems from a combination of offshore wind, other anthropogenic stressors and climate change. Outcomes will inform how we manage UK waters and achieve net zero, whilst ensuring net environmental gain and how to address the lack of progress toward achieving Good Environmental Status in several biodiversity indicator areas, including pelagic habitats and food webs, and marine birds.

The objectives of this research programme are to:

- Enhance understanding of ecosystem responses to the cumulative pressures of large-scale deployment of offshore wind, in combination with other stressors.
- Provide a sound evidence base to inform decision-making for managing human activity and policy prioritisation associated with the delivery of an expansion of offshore wind.
- Demonstrate research advances in using the latest innovative technologies for integrated marine observing approaches to inform and support better understanding of delivering net environmental gain.
- Provide a sound evidence base to inform policy and marine management responses for delivering net environmental gain whilst deploying fixed/floating offshore wind.
- Develop long term relationships between UKRI researchers, government, and industry, built around rigorous applied research and long-term data management and archiving.

To realise these objectives, the programme will be implemented through an open call for proposals and synthesis activities, both of which will be supported by a data initiative. The open call for proposals will follow a two-stage commissioning process, with an outline and full proposal stage. The outline stage will be used to identify proposals to be invited to submit a full proposal. At the full proposal stage applicants will be expected to engage with stakeholders in the development of their proposals and these interactions will be proactively facilitated by the Champion. It is anticipated this facilitation will start in early February 2022 and will go on for up to 9-weeks. The call for proposals will fund three projects, with anticipated start dates in August 2020. After approximately 18 months, these funded projects will be given the opportunity to bid for additional funding for synthesis activities, which will work across the ECOWind programme and take advantage of opportunities arising from other relevant activities (e.g. OWEC and OWEAP) to deliver synthesis outcomes.

The ECOWind programme will be supported by a data initiative that will provide researchers with free access to data that will significantly enhance the outcomes of the funded research projects. This initiative will leverage ongoing activities, such as the OWEAP big data project, The Crown Estate's Marine Data Exchange and the NERC INSITE data initiative to meet its two objectives for this research programme:

- i. Secure access to relevant OWEC and other government funded data, and industry-owned data, which will add significant value to research projects.
- ii. Provide additional fieldwork opportunities for research projects to collect new data through access to industry sampling/survey equipment (e.g. remotely operated vehicles), vessels, and offshore installations.

5. Scope

The ECOWind Champion and/or their team will be involved in all aspects of the ECOWind programme. The Champion will directly interface with industry and other stakeholders (e.g. policy users), and with other relevant activities (such as those below) in order to ensure the successful delivery of all of the programme's objectives (as outlined in Section 4).

- The OWEC programme management function, that will oversee and facilitate integration and coordination between the four OWEC themes, interface with other evidence initiatives, government and industry
- Defra's Offshore Wind Enabling Actions team which provides a focal point for integration and coordination within UK government
- The Offshore Wind Industry Council which provides a focal coordinating point for the Offshore Wind Industry
- Other multiple initiatives currently operating coordination and integration functions (e.g. Offshore Renewables Joint Industry Programme (ORJIP), Offshore Wind Strategic Monitoring Research Forum (OWSMRF), Scottish Marine Energy Research programme (ScotMERC)), mostly around evidence needs to de-risk consenting.
- UKRI funded research e.g. INSITE, Sustainable Management of UK Marine Resources.
- Similar international activities as appropriate.

The funded Champion, and, if relevant, their team members, will not be eligible to bid for funding as part of the ECOWind call for proposals.

6. Requirement

The Champion will be required to undertake the following key tasks:

- Supporting programme management (including project monitoring and evaluation, programme reporting, and risk management) as defined by the Programme Executive Board, working closely with the ECOWind Advisory Group.
- Working with the Programme Executive Board to ensure, where appropriate, there is alignment of the ECOWind programme with the wider OWEC programme, both in terms of objectives and research focus;
- Facilitate co-design of up to 7 full project proposals following the outline stage, bringing together the applicants with both policy representatives and industry. This process needs careful facilitation and management to understand the aims and objectives across all parties and then to prioritise these in line with ECOWind's research areas;
- Establish co-ordination and communication with relevant activities on-going within public bodies and agencies, and other initiatives nationally and internationally (e.g. NERC's Sustainable Management of UK Marine Resources and INSITE; Marine Scotland ScotMER and Defra OWEA programmes) and, in so doing, support efforts to secure in-kind contribution (e.g. help in securing data for the ECOWind data initiative) and deliver a strong portfolio of ECOWind synthesis activities.

- Leading, and organising, around 5 programme meetings and stakeholder-orientated workshops (particularly with government and industry stakeholders) to share the knowledge that has been generated and help realise programme objectives. [To note: the cost of arranging programme meetings and workshops (e.g. venue hire, catering) should not be included in bids as will be covered by a separate budget]
- Support co-delivery of funded projects with policy representatives and industry, and the interpretation of the knowledge acquired to provide useful evidence for marine policy and management.
- Facilitate effective integration between the funded ECOWind projects and those funded via OWEC and other relevant initiatives, such as those funded by Government, industry, and UKRI.
- Oversee the ECOWind integration and synthesis projects to ensure their appropriate interface with the outputs of other national and international initiatives and effective engagement with users to deliver impactful outcomes for government and industry.
- Coordinate the review of the 3 projects funded through the research programme, with light touch reviews biannually and a substantive review at the 24 month point, to assess progress on the science aims.

A contract review will take place after 28 months from the start of the contract to review outputs and decide on continuation of the contract.

UKRI will have unrestricted access to the outputs of the contracted work in terms of their use and distribution.

By preference meetings should be held virtually. This does not preclude in person meetings if required; however travel costs are expected to be minimal.

Additional elements within scope of the requirement

The potential additional activities covered in the additional £76,000.00 may include but is not limited to:-

- additional programme meetings/workshops
- further stakeholder engagement
- further dissemination work
- increased evaluation and monitoring requirements.

Volumes of the additional work listed above is not guaranteed.

7. Timetable

The Champion will be required to start in February 2022.

Following the outline proposal stage the Champions key tasks will commence with the facilitation of interactions between funding applicants and potential project partners during the development of full proposals – February to April 2022

Following the submission of full proposals until funded projects start, we anticipate there will be a relatively quiet period before the main work of the Champion will begin to meet the other key tasks outlined in this specification – August/September 2022 – to end of contract, expected to be August 2026.

During this period Champion activities to include:

Facilitate review of the 3 funded research projects biannually and 24 months post start date.

Organise three annual science meetings to include interaction with the rest of the OWEC programme and relevant policy stakeholders.

Identification of additional opportunities to disseminate programme results, and to facilitate result dissemination at, or towards the end of, the ECOWind programme.

Terms and Conditions

Bidders are to note that any requested modifications to the Contracting Authority Terms and Conditions on the grounds of statutory and legal matters only, shall be raised as a formal clarification during the permitted clarification period.

Section 5 – Evaluation model

5.1. Introduction

- 5.1.1. The evaluation process will be conducted to ensure that Bids are evaluated fairly to ascertain the bidders who can demonstrate the required skills qualities, technical ability and capacity, commercial stability and experience to ensure successful performance of the Contract.
- 5.1.2. The evaluation team may comprise staff from UK SBS and the Contracting Authority, and any specific external stakeholders the Contracting Authority deem required

5.2. Evaluation of Bids

- 5.2.1. Evaluation of Bids shall be based on a Selection questionnaire and Award criteria as clearly defined in the e-sourcing tool.

5.3. SELECTION questionnaire

Award Evaluation of criteria

Non-Price elements

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

$$\text{Score} = \{\text{weighting percentage}\} \times \{\text{bidder's score}\} = 20\% \times 60 = 12$$

The same logic will be applied to groups of questions which equate to a single evaluation criterion.

The 0-100 score shall be based on (unless otherwise stated within the question):

0	The Question is not answered, or the response is completely unacceptable.
10	Extremely poor response – they have completely missed the point of the question.
20	Very poor response and not wholly acceptable. Requires major revision to the response to make it acceptable. Only partially answers the requirement, with major deficiencies and little relevant detail proposed.
40	Poor response only partially satisfying the question requirements with

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Example

Evaluator 1 scored your bid as 60
 Evaluator 2 scored your bid as 40
 Evaluator 3 scored your bid as 80
 Evaluator 4 scored your bid as 60
 Your final score will $(60+40+80+60) \div 4 = 60$

Once the above evaluation process has been undertaken and the scores are apportioned by evaluator(s) this will then be subject to an independent commercial review and moderation meeting, if required by the commercial lead, any and all changes will be formally recorded relative to the regulatory obligations associated with this procurement, so as to ensure that the procurement has been undertaken in a robust and transparent way.

Price elements will be evaluated on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the price criterion.

For example - Bid 1 £100,000 scores 100.

Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80

Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.

Bid 4 £175,000 differential £75,000 remove 75% from price scores 25.

Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.

Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: $\text{Score/Total Points} \times 50$ ($80/100 \times 50 = 40$)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

This evaluation criteria will therefore not be subject to any averaging, as this is a mathematical scoring criteria, but will still be subject to a commercial review.

- 7.1.5. - 7.1.13. Bidders should read this document, Stage One: Overview Section. messages and the evaluation questionnaires carefully before completing the Response submission. Failure to comply with any of these instructions for completion and submission of the Submitted Response may result in the rejection of the Response. 7.4. Freedom of information

7.8. Preparation of a Response

- 7.8.1. Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. - 7.11.2. Neither UK SBS, the Contracting Authority, nor any relevant OPB's nor their advisors, nor their respective directors, officers, members, partners, employees, other staff or agents:
- 7.11.2.1. makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or
 - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3.  - 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or
 - 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
 - 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,

- 7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within two days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Delta eSourcing system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in [Section 3](#).
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the e-sourcing portal they should use the contact details defined in [Section 3](#).
- 7.15.4. No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.
- 7.15.5. In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6. Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:
- 7.15.6.1. invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
 - 7.15.6.2. request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.

- 7.15.7. The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

- 7.16.1. At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
- 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
- 7.19.1.1. cancel the evaluation process at any stage; and/or
 - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in Find a Tender in accordance with the Regulations within 30 days of the award of the contract.

7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.

Section 7 – General Information

What makes a good bid – some simple do's 😊

DO:

Do comply with Procurement document instructions. Failure to do so may lead to disqualification.

Do provide the Bid on time, and in the required format. Remember that the date/time given for a response is the last date that it can be accepted; we are legally bound to disqualify late submissions. Responses received after the date indicated in the RFP shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay, is solely attributable to the Contracting Authority

Do ensure you have read all the training materials to utilise e-sourcing tool prior to responding to this Bid. If you send your Bid by email or post it will be rejected.

Do use Microsoft Word, PowerPoint Excel 97-03 or compatible formats, or PDF unless agreed in writing by the Buyer. If you use another file format without our written permission, we may reject your Bid.

Do ensure you utilise the Delta eSourcing messaging system to raise any clarifications to our RFP. You should note that we will release the answer to the question to all Bidders and where we suspect the question contains confidential information, we may modify the content of the question to protect the anonymity of the Bidder or their proposed solution

Do answer the question, it is not enough simply to cross-reference to a 'policy', web page or another part of your Bid, the evaluation team have limited time to assess bids and if they can't find the answer, they can't score it.

Do consider who the Contracting Authority is and what they want – a generic answer does not necessarily meet every Contracting Authority's needs.

Do reference your documents correctly, specifically where supporting documentation is requested e.g. referencing the question/s they apply to.

Do provide clear, concise and ideally generic contact details; telephone numbers, e-mails and fax details.

Do complete all questions in the questionnaire or we may reject your Bid.

Do ensure that the Response and any documents accompanying it are in the English Language, the Contracting Authority reserve the right to disqualify any full or part responses that are not in English.

Do check and recheck your Bid before dispatch.

What makes a good bid – some simple do not's ☹

DO NOT

Do not cut and paste from a previous document and forget to change the previous details such as the previous buyer's name.

Do not attach 'glossy' brochures that have not been requested, they will not be read unless we have asked for them. Only send what has been requested and only send supplementary information if we have offered the opportunity so to do.

Do not share the Procurement documents, they may be confidential and should not be shared with anyone without the Buyers written permission.

Do not seek to influence the procurement process by requesting meetings or contacting UK SBS or the Contracting Authority to discuss your Bid. If your Bid requires clarification the Buyer will contact you. All information secured outside of formal Buyer communications shall have no Legal standing or worth and should not be relied upon.

Do not contact any UK SBS staff or the Contracting Authority staff without the Buyers written permission or we may reject your Bid.

Do not collude to fix or adjust the price or withdraw your Bid with another Party as we will reject your Bid.

Do not offer UK SBS or the Contracting Authority staff any inducement or we will reject your Bid.

Do not seek changes to the Bid after responses have been submitted and the deadline for Bids to be submitted has passed.

Do not cross reference answers to external websites or other parts of your Bid, the cross references and website links will not be considered.

Do not exceed word counts, the additional words will not be considered.

Do not make your Bid conditional on acceptance of your own Terms of Contract, as your Bid will be rejected.

Do not unless explicitly requested by the Contracting Authority either in the procurement documents or via a formal clarification from the Contracting Authority send your response by any way other than via e-sourcing tool. Responses received by any other method than requested will not be considered for the opportunity.
