## Introduction

# Purpose

Chief of the General Staff (CGS) stated at the RUSI Land Warfare Conference that the British Army needs to develop an 'Any/Any' Network', capable of connecting any sensor, from any domain, from any partner to any effector in order that any British unit can destroy an enemy three times its size by 2030.

To achieve this, we must think and fight differently to refine the 'kill-web' thus increasing the lethality of the Field Army. Dir RAPSTONE has identified the establishment of a basic First-Person View drone (FPV) capability as one of his 'First 6' initiatives that delivers CGS' ambition.

# Background

Learning lessons from the War in Ukraine, academic research by RUSI and CAPDEV efforts [REDACTED], the Authority has identified the class of drone that will enable the rapid training of a large cadre of pilots that Commander Field Army (CFA) has directed to start in the first financial quarter of 2025.

### Objectives

This procurement enables purchase of equipment necessary to train pilots for delivering a FPV STRIKE capability in Field Army. The equipment proposed is appropriate for fitment of Anti-Tank, Anti-Personnel and Anti-Structure munitions.

## Requirements

**Single Statement of User Need (SSUN).** The User requires a modular aerial system that is portable, rapidly deployable, organic & simple to use, with the option of multiple payloads to provide enduring day and night tactical advantage.
