





Invitation to Tender: Who Dares Works Who Dares Grows Work-Related Activity.

1. Background: Who Dares Works is a project funded by the European Social Fund and the National Lottery Community Fund. It is led and managed by Active Plus Community Interest Company and delivered by a partnership of 17 social enterprises.

The aim of Who Dares Works is to help and inspire people aged 18 and over who are not working, who live in West Cornwall and the Isles of Scilly and who have a range of needs or barriers to overcome, to reconnect with education, training and work. The project runs to June 2023, with delivery coming to a close from December 2022.

Who Dares Works has a strong and effective partnership ethos, with each partner helping to develop and then committing to the principles within the Who Dares Works Charter (included in tender pack). New partners must be also be able to demonstrably commit to those principles of:

- Putting People in the Lead
- Committed to Sustainable Development
- Building Capacity for the Future
- Continuous Improvement and Excellence in Delivery
- **2.** The services we are seeking: Active Plus is seeking delivery of **Who Dares Grows** courses that provide work-related activity, including volunteering, skills development and work experience in environment friendly activities.
 - Horticulture
 - recycling, upcycling and re-use activity;
 - the use of the natural environment to improve health and wellbeing;
 - building skills and work readiness through creating campaigns and activities to highlight and tackle environmental concerns
 - Garden/growing projects

Responses can cover one or more of these strands.

- Courses to run for 10 consecutive days for a minimum of 5 hours per day
- Courses to accommodate between 6 and 15 participants
- Delivery to take place in the West Cornwall Local Action Group in communitybased settings that are accessible
- Delivery to be undertaken by professionals already working in horticulture, volunteering or the environmental industry









 Participants to receive a certificate of completion and support to reflect their new skills/experience on their CVs

In addition, the successful applicant will be required to:

- Promote Who Dares Grows to project partners and existing participants, attending meetings and events where requested. Referrals to the courses will be made by/through Who Dares Works mentors.
- Take an active seat on the Who Dares Works Partnership Delivery Board (meets 10 time a year)
- Complete project paperwork in a compliant and timely manner this includes a participant start/end/attendance form, feedback forms and quarterly project narratives
- Invoice for courses completed in a timely and compliant manner
- Comply with all project guidance from Active Plus this includes guidance issued by the National Lottery Community Fund and ESF Managing Authority

Contract value: The minimum value will be £25,000. The contract will be let on a fixed price-per-course basis. Courses that are scheduled but do not have sufficient participants scheduled to attend will be cancelled without payment. A full breakdown of costs is asked for in the application form so that Active Plus can ensure that all costs are eligible and that delivery provides value for money.

Contracts will have an end date no later than December 2022.

Active Plus reserves the right to make offers to successful partners that may be less than the volume of delivery they are seeking funding for.
