 - b. Appendix 2 to Schedule 2, Annex C Pricing Original Equipment Manufacture Spare Parts Percentage Discount
- **2.** The Definitions and descriptions of terms used within the Pricing Schedule can be found at Schedule 1.
- **3.** The 'Firm Rate Per Hour' shall be billed in 6 minute intervals (hourly rate divided by 10 = 6 minute rate).
- 4. The prices detailed within Schedule 2, Annex C, Pricing shall be inclusive of all labour, material, overheads and equipment but exclusive of VAT/Mwst.
