Statement of Work



#### STATEMENT OF WORK

This Statement of Work (SOW) is subject to the Terms and Conditions of the Master Services Agreement (the "Agreement") dated as of 26 November 2020 between Mango Business Solutions and the Department for Environment, Food, and Rural Affairs (DEFRA).

Subject at all times to the terms and conditions of the Agreement, Supplier Mango Business Solutions shall provide to the Department for Environment, Food, and Rural Affairs the following:

### Scope of Work, Location and Timeframes

## Scope:

To provide an experienced team to work closely with stakeholders in deploying a proof of concept project. This SOW extends the work agreed with the Environment Agency (EA) for project number 3987.

The EA project consists of 3 steps:

- 1. Optimise EA Shiny applications via a rapid audit and tactical enhancement exercise Mango to work collaboratively with EA to review quality of the demo Shiny apps in scope and build a backlog of tactical quick wins and recommendations:
- Conduct code review on 3 demo Shiny apps
- Review existing versioning and make recommendations for how it can be improved
- Evaluate current testing process to improve the efficiency and robustness of apps
- Investigate the current workflow to identify opportunities to improve outputs and make recommendations for further enhancements

Statement of Work

Starting in parallel with the activities above, Mango to install and configure GitLab CE on an EA provided server built with Oracle Linux 7 (minimal install). The server will require outbound access to the Internet.

2. Showcase RStudio Connect with the optimised Shiny applications

Mango Data Engineers to support with the installation and configuration of a trial RStudio Connect platform, before helping to 'lift and shift' the optimised Shiny apps. Thereafter, Mango Project Team will advise on a roadmap for EA user group to support with generating maximum value over the trial period. Recommended activities include:

- 3-way educational best practice workshop sessions with RStudio, EA and Mango
- Set tasks for users to accelerate learning
- 3. Deliver a playback session to senior EA leaders

Mango to present a playback of the findings from the previous evaluation steps to senior EA leaders. This collaborative workshop-based session will also include a presentation on the Art of the Possible.

- Surface results to establish feasibility, and value potential, for recommended next steps
- Document ideas and projected timescales for future enhancements

Expanding the scope of this engagement to include infrastructure and user communities within DEFRA would require the additional extensions to the above:

- A more complex infrastructure deployment to enable more users and test the forward-looking approach
- Additional days to handover infrastructure to in-house support and maintenance teams
- Expanding the workflow support to include a number of users from within DEFRA alongside those at EA
- Working together to define, at a high level, appropriate governance and working practice elements for the wider data science community within DEFRA

In order to deliver this expanded scope and work together with EA and DEFRA the additional workload costed below will be necessary.
