Dear Sirs.

I am writing on behalf of Highways England to advise you of the award of the above mentioned contract to Geoffrey Osborne Ltd through the Collaborative Delivery Framework.

The Package Contract is split into two Phases;

- Phase 1, design development of the *works* and agreement of the total of the Prices for Phase 2. Phase 1, will end at issue of the Notice to Proceed to Construction.
- Phase 2, will start from receipt by the *Contractor* of the Notice to Proceed to Construction and includes the completion of the *works*, the operations and maintenance of the bridge, as detailed in the Works Information.

The value of Phase 1 of this Package Contract is estimated to be £276,085.05. This will form CDF PC2 0024 to the Agreement. You should note that we will not pay for any work unless it has been specifically authorised in writing within the terms of the Agreement.
