### **Invitation to Tender Letter**

# Street Parish Council - Tender for 3-year Grounds Maintenance contract 1<sup>st</sup> November 2024 to 31<sup>st</sup> October 2027

**Dear Sirs** 

Street Parish Council is responsible for the upkeep of assets and facilities it owns, and services it administers and delivers, for the residents and visitors of Street.

## Scope of works

Street Parish Council is inviting tenders for the ground and horticultural maintenance requirements throughout the village, which includes:

- Merriman Park
  - Note: Merriman Park is owned by Street Parish Council and managed by the Merriman Park Community Group (MPCG).
- Street Skatepark
  - Note: Street Skatepark is owned by Street Parish Council.
- Strode Road Allotments
  - Note: Strode Road Allotments are owned by Street Parish Council and administered by Street and District Allotments Association.
- The centre of the roundabout on the Westway near McDonalds

  Note: The roundabout is owned by Somerset Council and maintained by Street Parish Council.
- Hanging baskets (High Street, Farm Road and Leigh Road), Flower Beds (High Street and Leigh Road), and Horse Trough (The Cross).

Note: Owned by Street Parish Council

### **Additional works**

- Cleaning and maintenance of four bus shelters.
- Moving Speed Indicator Devices (SIDs) to locations around Street.
- Other works as required, on an ad hoc basis.

## Ad hoc works

The successful contractor must be flexible when ad hoc work is required. This is to be quoted for on an agreed hourly rate. Once the quote is approved, works can be carried out.

Prospective contractors should ensure that they are familiar with Street and comfortable with the obligations set out in the Specification for Grounds Maintenance & Horticultural contract 2024-27.

## **Quotation requirements**

You are invited to quote for all works or any part thereof.

The Prices submitted must indicate the rate for each element of the Contract.

All prices are to be exclusive of VAT.

#### **Payment**

All works are to be invoiced monthly over equal payments for the duration of the contract.

A separate quote and invoice will be required for additional ad hoc works agreed with Officers on behalf of the Parish Council.
