CONTRACT FOR: Global Mine Action Programme 2 (GMAP2) in Burma, Laos, Lebanon, South Sudan, Vietnam and Sri Lanka

CONTRACT NUMBER: PO 8340

With reference to the contract dated 27th July 2019, as most recently amended by the letter dated 31st March 2021, both Parties have in principle agreed to the following variations to the Contract:

Section 1, Form of Contract, Paragraph 2, Commencement Date and End Date of Initial Period

Delete: "The Services shall commence on 01st July 2018 and the end date of the Initial Period shall be 30th June 2021."

Insert: "The Services shall commence on 01st July 2018 and the end date of the Initial Period shall be 31st March 2022."

Section 1, Form of Contract, Paragraph 4, Financial Limit

Delete: "Payments under this Contract shall not, in any circumstances, exceed £32,661,063 exclusive of any government tax, if applicable. This financial limit may be increased if the option to extend beyond the contracted end date of 30th June 2021 is implemented, pursuant to Section 4 Clause 15."

Insert: "Payments under this Contract shall not, in any circumstances, exceed £35,761,928 exclusive of any government tax, if applicable."

Section 3, Terms of Reference

Timeframe, Paragraph 17:

Delete "run from 1 July 2018 until 31 March 2020" and **replace** with "run from 1 July 2018 until 31 March 2022".

Timeframe, Paragraph 21, Table 1:

Delete:

Requirement	Timing
Project closure report and asset disposal plan	Preparations begin 90 days before March 2020

Insert:

Requirement	Timing
Project closure report and asset disposal plan	Preparations begin 90 days before 31 March 2022



Budget, Paragraph 22:

Delete: “The maximum budget for Lot 2 is £32.1million. This figure represents up to £21.4M for the 18.5 month period of the contract and up to £10.7M for up to a 12 month extension.”

Insert: “The maximum budget for Lot 2 is £35,761,928. This figure represents up to £21.4M for the 18.5 month period of the contract and up to £14,361,928 for up to a 24 month extension.”

Calculation of Targets from 31 March 2021, Paragraph 68:

Insert: “68. FCDO has agreed that cumulative targets will be calculated against actual outputs as at 31st March 2021 and agreed proposed targets for the interim extension April to June 2021 and further extension dated 1st July 2021 to 31st March 2022.”

Section 4, Special Conditions, Paragraph 21, Review Points for Myanmar

Insert: “21. Review Points for Myanmar

FCDO and the Supplier will review the workplan and funding proposal for Myanmar in full by the 31st August 2021 and may require amendments dependant on operations and country situation to that point. The security and operating situation in Myanmar will be regularly monitored with the potential for further reviews until 31st March 2022.”

Section 5, Schedule of Prices

Delete the Section 5 Proformas revised March 2021 in toto and **replace** with the Section 5 Schedule of Prices revised June 2021 attached.

2. These amendments relate to a 9 month extension of the contract to 31st March 2022 with an increased Financial Limit of £35,761,928, updates to the timeframe and budget paragraphs in the ToR and clarification of the methodology for calculating targets for the final year from 31st March 2021 to 31st March 2022, inclusion of a review point for Myanmar in Section 4, and a revised Schedule of Prices to reflect the actual costs to date and the proposed costs for the extension period.

3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of signature on behalf of FCDO that you accept the variations set out herein.

4. The Contract, including any previous variation, shall remain effective and unaltered except as amended by this letter.

5. Words and expressions in this letter shall have the meanings given to them in the Contract.
