

PRIOR INFORMATION NOTICE - PREHABILITATION FOR SURGERY SERVICE (PILOT)

This is a prior information notice with future call for competition and its purpose is to make the market aware of the CCGs' commissioning intentions.

NHS Leicester City Clinical Commissioning Group (CCG) will be commissioning a multimodal prehabilitation for surgery service on behalf of the three CCG's: Leicester City CCG, West Leicestershire CCG and East Leicestershire & Rutland CCG.

The service will be commissioned as a pilot for 1 year with the possibility of a 1-year extension.

The Commissioners will be considering inviting offers to deliver a supervised exercise programme as part of a multimodal prehabilitation for surgery pilot project. The project aims to deliver 300 patient episodes potentially over 2 years for patients in Leicester, Leicestershire and Rutland (LLR) undergoing major surgery, at locations convenient for patients across LLR.

It is proposed that the terms and conditions of all the services, including tariff arrangements, will reflect those contained in the NHS England Standard Short form contract.

The service will be commissioned via an open procurement process, advertised to all providers which is proportionate to the value and complexity of the service and contract.

To register on the Bravo portal

1. If your organisation has registered previously, you do not need to re-register. Register on the portal webpage at <https://mlcsu.bravosolution.co.uk> (registration and use of the website is free of charge).
2. Once registered, candidates must Express their Interest by:
 - a. logging into the ML CSU eTendering Bravo portal
 - b. selecting response to the relevant ITT,
 - c. select Open Access relevant ITT,
 - d. search for and access listing related to this contract and view details,
 - e. click on Express Interest link.
3. Once you have expressed your interest, please access the My ITTs page, where you can view all the documentation (and download if required) and construct your reply in the bravo online questionnaire, as instructed. The deadline will be detailed in the tender documentation.

“Light Touch Regime” services

This procurement is for clinical services which are Light Touch Regime services for the purpose of the Public Contracts Regulations 2015 as specified in Schedule 3 of the Regulations (“Regulations”). Accordingly, the contracting authorities are only bound by those parts of the Regulations detailed in Chapter 3 Particular Procurement Regimes Section 7. The contracting authorities are not voluntarily following any other part of the Regulations.

The procedure which the contracting authorities are following is set out in the tender. As the CCG is a relevant body for the purpose of the National Health Service (Procurement, Patient Choice and Competition) (No 2) Regulations 2013 these Regulations also apply to this procurement.

Right to Cancel

The contracting authority reserves the right to discontinue the procurement process at any time, which shall include the right not to award a contract or contracts, and does not bind itself to accept the lowest tender, or any tender received, and reserves the right to award a contract in part, or to call for new tenders should it consider this necessary. The contracting authority shall not be liable for any costs or expenses incurred by any candidate or tenderer in connection with the completion and return of the information requested in this Contract Notice, or in the completion or submission of any tender, irrespective of the outcome of the competition or if the competition is cancelled or postponed. All dates, time periods and values specified in this notice are provisional and the contracting authority reserves the right to change these
