

- 9. Please note that the Authority has made the following changes to the Contract:
 - a. Inclusion of Clause 5.6 (Intellectual Property Rights Subcontracts); following input from the Authority's Defence IPR specialist we have included a Clause which calls into use Annex P DEFFORM 177 Design Rights and Patents (Subcontractors Agreement) if the Contractor seeks to place a subcontract for design or development work. As the RTES solution offered is an 'off the shelf' product the Authority does not envisage that this additional Clause, nor Annex P, will be required; but has been included to remain compliant with Ministry of Defence IPR policy.
 - b. Annex C Key Performance Indicators has been updated; including the amendment of definitions and the inclusion of a Social Value KPI.
 - c. Annex D Management Information has been updated to reflect the inclusion of the Social Value KPI in Annex C.
 - d. As they are no longer required as part of the contractual documents the Authority has removed: Annex E SR Road Map; Annex H Security Aspects Letter to UK Contractor; Annex I Security Aspects Letter to Foreign Supplier; and Annex M DEFFORM 24 Parent Company Guarantee.
