With reference to the contractual letter dated 12 March 2014 as most recently amended by the communication dated 25 February 2015 whereby your firm was engaged to deliver the terms of reference detailed in Section 3 of the contract, and subsequent discussion, I confirm that the UK Government wishes to make the following further amendment 4 to the letter of 12 March 2014:

Section 1 Form of Contract, Paragraph 3, Commencement and Duration of the Services

Delete: 'and shall complete them by 28th February 2015 the (End Date)'. **Insert:** 'and shall complete them by 30th April 2015 the (End Date)'.

Section 1 Form of Contract, Paragraph 4, Financial Limit

Delete: 'Payments under this Contract shall not, in any circumstances, exceed £4,138,367.40 exclusive of any

government tax, if applicable (the "Financial Limit")'.

Insert: 'Payments under this Contract shall not, in any circumstances, exceed £ 4.465.235.70

exclusive of any government tax, if applicable (the "Financial Limit")'.

Section 5 Schedule of Prices

Delete Section 5 Schedule of Milestone payments and **Replace** with Section 5, Schedule of Prices (Revised 25 February 2015) as attached.

- 2. These amendments relate to a two month extension to initiate some implementation requirements while Board of Investment approval is given, an update on the Milestone Payment Schedule with three additional milestones for the amended period, and an increase to the Financial Limit of the Contract.
- 3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of signature on behalf of DFID that you accept the amendment[s set out herein.
- 4. Please note the provision in the contractual letter that the financial limit of the UK Government's liability to the Supplier under this engagement shall not exceed the sum specified unless the amount of any such excess has been agreed by the Department for International Development in writing before the Supplier takes any action which might result in the financial limit being exceeded.
