Information to be submitted with Form of Tender:

a) 1 copy of completed Contract Sum Analysis - all items within the Contract Sum Analysis must be individually priced including:

a. Percentage mark-up's in the Dayworks Section. The tenderer must provide his mark-up on materials and subcontract works

b) List of main subcontractors namely; Mechanical and Electrical subcontractors etc

c) Site plan indicating location of site hut/welfare, materials and refuse storage

d) Access statement and logistical plan

e) A description detailing the proposed organisation, quality management systems and resources to be provided by the Contractor to control the works

f) CV's of site based personnel

g) Summary programme

h) Lead in period from date of appointment to start on site

All queries concerning documentation and drawings should be directed to the portal and any clarifications or amendments shall be distributed to all tenderers.
