


Cranleigh Facts

- Cranleigh Parish is located in Surrey in the borough of Waverley.
- Population is approximately 12,500 people.
- Cranleigh Parish Council has 12 Parish Councillors, six full time staff and one apprentice.
- Precept 2022 2023 is £445,582



Background

Cranleigh Parish Council (CPC) owns a variety of properties, land and assets across different locations in the village. Many of these are in a state of disrepair and now require significant investment to ensure they continue to be functional and usable for all. The Council already has a number of new projects under consideration for investment within the Business Plan.



The CPC are seeking an independent advisory service to review the current properties and assets and align them to the finalised Business Plan to find a suitable way forward for the level of investment available. CPC need to be certain that the best course of action is taken with our assets to ensure that any benefits of aligning services can be achieved. Value for money and long term vision will be required to allow the funds available can be spent effectively.

Solutions should include:

- How various assets can be used to generate income to ensure the assets can become self sufficient is required.
- How all funding used in their building/repair, is to the benefit of the community.
- A good understanding of the needs of the village and community and how the CPC properties and assets can be improved to support as large a proportion of this population as possible.
- Consultation on initial findings with the Council.
- As many solutions to encourage visitors to the village to use the facilities and support local businesses.
