1. Terminal Points

2. Stopping Arrangements

All buses operating on the Services must serve all stops on the line of route designated for the route.

Drivers must pick up/set down at all bus stops where passengers wish to board and/or alight. If a driver is certain no passengers wish to board or alight, they may continue. If the driver is in any doubt, they must stop.

Canning Town Bus Station. Stand W1

Private stand for 6 buses in marked bays at Stand W1/2 on west side of Canning Town Bus Station at south-west corner of junction of Barking Road and Silvertown Way.

Buses proceed from Canning Town Bus Station direct to stand, departing to Canning Town Bus Station.

Set down in Canning Town Bus Station, at Stop A (BP2284 - Canning Town Station) and pick up in Canning Town Bus Station, at Stop C (BP2279 - Canning Town Bus Station).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	No more than 2 buses on Route 309 should be scheduled to stand at any one time.
MEAL RELIEFS:	No meal relief vehicles to stand at any time.
FERRY VEHICLES:	No ferry vehicles to park on stand at any time.
BLIND DISPLAY:	Canning Town, Bus Station.
OTHER INFORMATION:	LBSL toilet facilities available 24 hours via the code.

Poplar. Leven Road (from Bethnal Green. Bonner Road)

Public stand for two buses on north side of Leven Road commencing 65 metres west of no. 202 and extending 30 metres west.

Buses proceed from Abbott Road, Leven Road to stand, departing via Leven Road, Oban Street to Blair Street.

Set down in Abbott Road, at Stop W (BP2004 - Leven Road) and pick up in Blair Street, at boarding point (BP518 - Abbott Road).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	Unscheduled curtailments only.
MEAL RELIEFS:	No meal relief vehicles to stand at any time.

Poplar. All Saints Station (from Bethnal Green. Bonner Road)

Public stand for 2 buses on west side of Bazely Street commencing approximately 40 metres south of East India Dock Road and extending 20 metres south.

Buses proceed from Cordelia Street, Chrisp Street, East India Dock Road, Newby Place, Poplar High Street, Bazely Street to stand, departing via Bazely Street, East India Dock Road, Chrisp Street to Cordelia Street.

Set down in Cordelia Street, at alighting point (BP1902 - Chrisp Street Market) and pick up in Cordelia Street, at boarding point (BP550 - Chrisp Street Market).

AVAILABILITY: At any time.
OPERATING RESTRICTIONS: Unscheduled curtailments only.
MEAL RELIEFS: No meal relief vehicles to stand at any
time. FERRY VEHICLES: No ferry vehicles to park on stand at any
time. BLIND DISPLAY: Poplar, Chrisp Street.

Poplar. Augusta Street (from Canning Town Station)

Public stand for one bus on west side of Augusta Street, opposite No 2-52, commencing 44 metres south of Giraud Street and extending 18 metres south.

Buses proceed from Cordelia Street, Augusta Street to stand, departing via Augusta Street, Giraud Street to Cordelia Street.

Set down in Cordelia Street, at stop G (BP544 - Augusta Street).

AVAILABILITY: At any time.
OPERATING RESTRICTIONS: Unscheduled curtailments only.
MEAL RELIEFS: No meal relief vehicles to stand at any
time. FERRY VEHICLES: No ferry vehicles to park on stand at any
time. BLIND DISPLAY: Poplar, Cordelia Street.

Stepney Green. Stepney High Street (from Canning Town Station)

Buses proceed from Rhodeswell Road, Ben Jonson Road, Harford Street, Mile End Road departing to White Horse Lane.

Set down in Rhodeswell Road, at Stop MZ (BP537 - Copperfield Road) and pick up in White Horse Lane, at Stop L (BP532 - Mile End Road).

AVAILABILITY: At any time.
OPERATING RESTRICTIONS: **Turning Point Only - Buses must not stand**
BLIND DISPLAY: Stepney High Street.

Bethnal Green. Bonner Road Stand

Public stand in Bonner Road commencing 12 metres east of Approach Road and extending 30 metres east.

Buses proceed from Bonner Road to stand, departing to Bonner Road.

Set down in Bonner Road, at Stop HA (BP525 - Bonner Road) and pick up in Bonner Road, at Stop HA (BP525 - Bonner Road).

AVAILABILITY: At any time.
OPERATING RESTRICTIONS: No more than 2 buses on Route 309 should be
scheduled to stand at any one time.
MEAL RELIEFS: No meal relief vehicles to stand at any
time. FERRY VEHICLES: No ferry vehicles to park on stand at any
time. BLIND DISPLAY: Bethnal Green, Bonner Road.
OTHER INFORMATION: No toilet facilities available.

* For this Route Agreement, clause 46 of Annex B of the Framework Agreement shall be deleted in its entirety and replaced by the following clause:

“46. INCENTIVE PROVISIONS

46.1 The provisions contained in this Route Agreement in relation to Performance Payments only and not the Contract Extension Criteria shall for the purposes of this clause 46 be referred to as the “Incentive Provisions”.

46.2 The following Contract Extension Criteria provisions shall not apply to this Route Agreement:

46.3.1 clause 2 and clause 44.2; and
46.3.2 Schedule IX in its entirety.

All other provisions of the Route Agreement shall continue to apply provided that where any other part of the Route Agreement relates to or can reasonably be inferred as relating to clauses 46.3.1 or 46.3.2 or any part thereof, such parts shall apply mutatis mutandis.”

6. Spare Vehicle – The Operator shall ensure that the following number of spare vehicles, which are specified in Schedule IIA Part 1, are available for the provision of the Services. 1
7. Existing Vehicles – The Operator shall ensure that all vehicles entering service on this route undergo refurbishment to the April 2021 Refurbishment Specification prior to entering service.
8. Route Risk Assessment - The Corporation acknowledges receipt of the Route Risk Assessment pertaining to route 309.
9. Contract Price Adjustment – applied from Tranche 730 onwards:

Paragraph 9.2.2 is deleted and replaced by the following:

The percentage price adjustment (R) is a 12-month rolling average given by: -

$$R = W \times \frac{1}{12} \times \sum_{i=1 \dots n}^{n=12} \frac{P_{i+1} - P_{i+13}}{P_{i+13}}$$

Where:

- W = 0.85 representing the proportion of the Contract Price that is to be adjusted by movement in the Consumer Price Index.
- P_{i+1} = The Consumer Prices Index published for the month that is i+1 month prior to the anniversary of the Date of Tender as set out in Table 309BT published by the Office for National Statistics (ONS).
- P_{i+13} = The Consumer Prices Index published for the month that is i+13 months prior to the anniversary of the Date of Tender as set out in Table 309BT published by the Office for National Statistics (ONS).

For the avoidance of doubt 15% of the prevailing Contract Price is non- adjustable.

10. In accordance with the award letter dated 11 July 2023, this contract may be extended by one further year, subject to mutual agreement. The Corporation will serve a minimum of one year's notice prior to the end of the six-year term.
