

SCHEDULE 7

SERVICES OUTPUT SPECIFICATION

1. INTRODUCTION

The Contractor shall provide the Services set out in this Schedule 7 in accordance with Clause 3 of this Agreement. The Contractor shall, at all times, ensure that the Services comply with, and meet all the requirements of, and perform all its other obligations arising under or in connection with this Agreement, in accordance with each of this Agreement, the Services Output Specification, the Services Delivery Proposals, Good Industry Practice, Directions, Mandatory Probation Instructions, Mandatory Prison Service Instructions and Applicable Law with effect from the Amendment Date.

The NOMS Service Specifications, the non-mandatory elements of Probation Instructions and the non-mandatory elements of Prison Service Instructions may be made available on the Authority Website to provide guidance. They shall not impose any obligations on, nor create any rights for, either of the parties under this Agreement.

The Contractor shall provide the Services with respect to each relevant Applicable Person set out in the column “Offender Type” and for each relevant sentence of the court set out in the column “Sentence Type” that the Applicable Person has been sentenced to. Where the “Service” column refers to Applicable Persons this shall mean the offender type set out in the “Offender Type” column, as applicable.
